BANKRUPTCY RULES, 1915.

Notice is hereby given in accordance with section 1 (1) of the Rules Publication Act, 1893, that after the expiration of at least 40 days from the date hereof the Lord Chancellor, with the concurrence of the President of the Board of Trade, proposes to make Rules relating to solicitors' remuneration, under Section 132 of the Bankruptcy Act, 1914, amending the Bankruptcy Rules, 1915.

TENDERS FOR TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England on Friday, the 4th February, 1944, at 1 p.m., for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Acts, 1939 to 1943, to the amount of £90,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday, the 7th February, 1944, to Saturday, the 12th February, 1944, inclusive, and will be payable at three months after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 1.30 p.m.

(Saturday 12 noon) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.

DANGEROUS DRUGS ACTS, 1920 TO 1932.

SUSPENSION OF WITHDRAWAL OF AUTHORITIES.

(OSWALD WHITE.)

Whereas in pursuance of the powers conferred on the Secretary of State by Regulation 7 of the Dangerous Drugs Regulations, 1937, the Authorities granted by the Dangerous Drugs Regulations, 1937, to registered dentists to be in possession of and to supply by personal administration the drugs and preparations to which Part III of the Dangerous Drugs Act, 1920, applies, were by Notice published in the London Gazette and Edinburgh Gazette on the 12th March, 1943, withdrawn from Oswald White, Dentist, of 102, Midland Road, Bedford, who had been convicted of an offence against the Dangerous Drugs Acts:

And whereas at the same time a direction was given by the Secretary of State that it should not be lawful for the said Oswald White to give prescriptions for the purposes of the Dangerous Drugs Regulations, 1937.
