The KING's Most Excellent Majesty in Council.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 4th day of April, 1944 (N.7578/44), in the words following, viz. :—

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted *inter alia* that all pay, pensions or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman or Marine therein shall be paid in such manner and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council:

"And whereas we have had under consideration the necessity of employing qualified men to carry out the responsible duties of Coxswains in Surveying Ships:

"And whereas we consider that men selected and employed as Surveying Coxswains should be paid an allowance of 6d. a day while allocated for and performing the duties satisfactorily:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to give Your sanction accordingly:

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

WHEREAS the Ecclesiastical Commissioners for England have duly prepared and laid before His Majesty in Council a Scheme bearing date the 23rd day of March, 1944, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, have prepared and now lay before Your Majesty in Council the following Scheme pursuant to the Episcopal Endowments and Stipends Measure, 1943, for vesting in us, the said Ecclesiastical Commissioners, all endowments and other property belonging to, or held in trust for, the Bishopric of London or the Bishop thereof, and for securing to

the said Bishop the reduced stipend deemed by us appropriate:

Whereas the Right Reverend and Right Honourable Geoffrey, Bishop of London, was in occupation of the See at the date of the passing of the aforesaid Measure and has requested us, the said Ecclesiastical Commissioners, to prepare a Scheme with respect to the See:

And whereas we have prepared this Scheme accordingly after consultation with the Diocesan Board of Finance of the Diocese of London, who have offered no objection thereto:

And whereas the said Geoffrey, Bishop of London, has approved the Scheme and in testimony of his approval has appended his signature thereto:

And whereas the Right Honourable Winston Spencer Churchill, First Lord of Your Majesty's Treasury, acting on behalf of Your Majesty, has signified to us his consent to the preparation and submission of the Scheme to Your Majesty in Council:

And whereas the endowments and property belonging to or held in trust for the See of London or for the Bishop thereof are described and referred to in the Schedule hereunder written:

And whereas there are in our hands under the Order of His late Majesty King George the Fifth in Council dated the 28th day of July, 1930, and published in the London Gazette of the day following certain sums of Stock and cash together representing the proceeds of sale of the former episcopal residence known as London House, together with the accumulations arising therefrom:

And whereas the income assigned for the Bishop is at present £10,000 per annum by virtue of the Ecclesiastical Commissioners Act, 1836, and certain Orders of Her late Majesty Queen Victoria in Council passed pursuant thereto and an Order of Her said Majesty in Council passed pursuant to the Ecclesiastical Commissioners Act, 1850, on the 25th day of August, 1851, and published in the London Gazette of the 19th day of September, 1851:

And whereas the said Bishop is required by the Episcopal Pensions Measure, 1926, to pay to us an annual contribution for the purposes of that Measure of £116 13s. 4d.:

Now, therefore, we, the said Ecclesiastical Commissioners, recommend and propose that all the endowments, securities and other property described and referred to in the said Schedule shall vest in us pursuant to the Episcopal Endowments and Stipends Measure, 1943, upon and from the 1st day of April, 1944, and that we shall be entitled absolutely to the benefit, rents and profits thereof upon and from that date:

And we further recommend and propose that upon and from the 1st day of April, 1944, the Bishop for the time being of the See shall be entitled to receive from us by equal quarterly instalments in respect of the quarters ended on the 1st day of January, the 1st day of April, the 1st day of July and the 1st

day of October in every year, the first such instalment to be the full quarter's payment due for the quarter ending on the 1st day of July, 1944, a reduced annual stipend comprising the sum of £5,000 and also such sum, not exceeding £700 in any one year, as we shall have been satisfied has become duly chargeable by him in connection with the travelling required in and for the carrying out of his official duties and obligations as Bishop:

And we further recommend and propose that the annual contribution payable to us by the Bishop for the time being of the said See under the Episcopal Pensions Measure, 1926, shall remain £116 13s. 4d., notwithstanding the reduction hereby effected in the stipend of the Bishop.

#### THE SCHEDULE

##### Part I

All that the episcopal residence known as Fulham Palace, together with the Chapel, outbuildings, cottages and other buildings and the yards, gardens, pleasure grounds and park and other the appurtenances thereunto belonging situate in the parish of All Saints, Fulham, in the county of London, as the same premises are delineated on the plan annexed hereto and thereon verged red.

And All that perpetual right of way in common with the London Diocesan Fund over the piece of land belonging to the said Fund shewn coloured blue on the said plan.

##### Part II

The annual payment amounting to £10,000 payable by the Ecclesiastical Commissioners under Section 3 of the Ecclesiastical Commissioners Act 1860.

##### Part III

The sums of stock and cash held by the Ecclesiastical Commissioners under an Order in Council dated the 26th day of July, 1930, and published in the London Gazette of the 29th day of July, 1930, authorising the sale of the former episcopal residence known as London House and the accumulation of the dividends and interest thereon.

##### Part IV

All those the fixtures, pictures, books, muniments, furniture and other goods and chattels belonging to the Bishop of London in right of his dignity and not in his private capacity, and described and set forth in an inventory to be deposited by us in the Diocesan Registry of the Diocese of London."

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately upon the publication of this Order in the London Gazette pursuant to the said Measure.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of London.

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, have prepared the following Scheme for effecting a transfer of the Ownership of the Advowson or perpetual right of patronage of and presentation to the Church and Cure (hereinafter called 'the said Benefice') of Lydiard Tregoz in the County of Wilts and in the Diocese of Bristol:

"Whereas we are satisfied that Charles Cyril Clarke of Gatcombe Court near Flax Bourton, in the County of Somerset, Esquire, is the Patron or person entitled to present or nominate to the said Benefice in case the same were now vacant:

"And whereas the said Charles Cyril Clarke desires to transfer the Advowson of the said Benefice to the Bishop of Bristol for the time being and is consenting to this Scheme (in testimony whereof he has executed the same):

"And whereas we are satisfied that the transfer will tend to make better provision for the cure of souls:

"Now, therefore, with the consent of the Right Reverend Clifford Salisbury, Bishop of Bristol (in testimony whereof he has executed this Scheme) we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the *London Gazette* of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole Advowson or perpetual right of patronage of and presentation to the said Benefice of Lydiard Tregoz shall be transferred to the said Clifford Salisbury, Bishop of Bristol and his successors in the same Bishopric and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the Bishop of Bristol for the time being."

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately upon the publication of this Order in the *London Gazette* pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Bristol.

River Great Ouse Catchment Board.

Sutton and Mepal Internal Drainage District.

Notice is hereby given that the Minister of Agriculture and Fisheries has made an Order under the Land Drainage Act, 1930, confirming a Scheme

submitted to him by the River Great Ouse Catchment Board, under Section 4 (1) (b) of that Act, making provision for the following matters:—

(1) The constitution of the Sutton and Mepal Drainage District as an Internal Drainage District and of the Drainage Board thereof.

(2) The abolition of the Sutton and Mepal Drainage Commissioners.

(3) The abrogation of the powers conferred on certain persons to carry out drainage works within the Commons in Chatteris and also in Sutton Meadlands, Pudding Holme, Feary's Fifty Acres, Keddington's Farm and Middlemoor in Sutton under the provisions of Section VI of the Act 46 George III, Cap. 96.

(4) The making of alteration in the provisions of the Local Acts and Statutory Orders under which the powers of the Sutton and Mepal Drainage Commissioners are derived.

(5) Matters supplemental thereto or consequential thereon.

The Order will become final and have effect as an Act of Parliament unless within thirty-one days from the date of this Notice a memorial is presented to the Minister by some person or body affected and having an interest sufficient for the presentation of a memorial, praying that the Order shall not become law without confirmation by Parliament.

Huddersfield Corporation (Trolley Vehicles) Act, 1936.

Huddersfield Corporation (Trolley Vehicles) Order, 1940.

THE Mayor Aldermen and Burgesses of the Borough of Huddersfield (hereinafter called "the Corporation") are applying to the Minister of War Transport for an Order under the Special Enactments (Extension of Time) Act, 1940, in respect of—

(1) the commencement of the running of trolley vehicles along the following trolley vehicle routes authorised by section 4 of the Huddersfield Corporation (Trolley Vehicles) Act, 1936, namely:—

(a) The route along the former tramway of the Corporation extending from Lockwood in the Borough of Huddersfield to Honley in the urban district of Holmfirth.

(b) Route No. 7 commencing at the junction of Queen Street South with East Parade passing along Queen Street South Ramsden Street High Street and Market Street to and terminating at the junction of that Street with Westgate.

(c) Route No. 8 commencing at the junction of Manchester Road with Outcote Bank passing along Outcote Bank and Manchester Street to and terminating at the junction of that street with High Street.

(2) the commencement of the use of trolley vehicles upon each of the two routes authorised by Article 3 of the Huddersfield Corporation (Trolley Vehicles) Order, 1940, namely:—

(a) Route No. 1 commencing at Ash Brow Road at a point 400 yards or thereabouts west of the junction of Ash Brow Road with Woodhouse Hill proceeding along Bradley Boulevard and Longhill Road to and terminating at the junction of the last-mentioned road with Bradford Road;

(b) Route No. 2 commencing at the junction of Woodhouse Hill with Ash Brow Road proceeding along Sheepbridge Road Chestnut Street and Riddings Road to and terminating at the junction of the last-mentioned road with Deighton Road.

## ELECTRICITY (SUPPLY) ACTS 1882 TO 1936.

NORTH DERBYSHIRE ELECTRICITY  
(EXTENSION) SPECIAL ORDER.

NOTICE is hereby given that application has been made by the Derbyshire and Nottinghamshire Electric Power Company (hereinafter called "the Company") whose principal office is at 66, Queen Street, in the City of London, to the Electricity Commissioners for a Special Order under the Electricity (Supply) Acts, 1882 to 1936, for the following amongst other purposes:—

1. To extend the area of supply of the Company for the purposes of the North Derbyshire Electricity Special Order, 1932 (hereinafter referred to as "the principal Order"), and to authorise the Company to supply and distribute electricity for all public and private purposes as defined by the said Acts within the area hereinafter described, viz.:—
