The KING has been pleased to grant unrestricted permission for the wearing of the insignia of Commander of the Order of St. Olav conferred by His Majesty the King of Norway upon Robert Neal Rudmose-Brown, Esquire, Professor of Geography at Sheffield University, and James Mann Wordie, Esquire, Honorary Secretary of the Royal Geographical Society, in recognition of services rendered by them during the war.

REGULATION FOR HIS MAJESTY'S FOREIGN SERVICE.

PROVISIONAL REGULATION No. 1.

Whereas Article 6 of the Foreign Service Order in Council, 1943, provides that

(1) The Foreign Secretary shall from time to time make "Regulations for H.M. Foreign Service," and that

(2) The said regulations may in particular provide (amongst other things) for the following matters:—

(i) The salaries for the different branches and grades of the Service; and

(ii) In conformity with any Act or Acts of Parliament which may be applicable, the conditions of retirement and pension for members of the Service, and that

(3) The said regulations in so far as they specify salaries, allowances, travelling allowances or conditions of retirement and pension, shall not be made without the concurrence of the Lords Commissioners of His Majesty's Treasury:

and Whereas the Lords Commissioners of His Majesty's Treasury have concurred in the present regulation:

Now, therefore, I, Robert Anthony Eden, His Majesty's Principal Secretary of State for Foreign Affairs, hereby make the following Regulation:—

1. Pending the making of further Regulations and subject to the provisions of the Foreign Service Act, 1943, and of paragraph 2 of this Regulation, the conditions relating to the salaries, allowances, travelling allowances and conditions of retirement and pension of members of His Majesty's Foreign Service shall be the same as those existing on the 19th May, 1943, in the respective Services to which these members belonged on that date.

2. Members of His Majesty's Foreign Service appointed to posts in the United Kingdom shall be entitled to war bonus as from 20th May, 1943, on the same scale as may from time to time be authorised for non-industrial civil servants.

3. This regulation shall operate retrospectively to the 20th May, 1943.

4. This regulation may be cited as "Provisional Regulation No. 1."

DANGEROUS DRUGS ACTS, 1920 TO 1932.

WITHDRAWAL OF AUTHORITIES.

(JOHN FORREST HINKSMAN.)

Whereas John Forrest Hinksman, M.B., Ch.B., U.Edin., whose registered address is 180, Sompting Road, Worthing, Sussex, has been convicted of an offence against the Dangerous Drugs Acts, 1920 to 1932:

Now therefore, in pursuance of the powers conferred on me by Regulation 7 of the Dangerous Drugs Regulations, 1937, and by Regulation 5 of the Raw Opium, etc., Regulations, 1937, I hereby withdraw from the said John Forrest Hinksman, the authorities conferred by the said Regulations upon him to be in possession of and to supply the drugs or preparations to which the Dangerous Drugs Regulations, 1937, and the drugs to which the Raw Opium, etc., Regulations, 1937, apply:

And I hereby direct that it shall not be lawful for the said John Forrest Hinksman to give prescriptions for the purposes of the Dangerous Drugs Regulations, 1937
