PUBLIC SCHOOLS ACT, 1868.

THE GOVERNING BODY OF ETON COLLEGE having, on the 17th day of March, 1945, in virtue of the powers conferred upon them by the above-named Act, made a Statute in the terms appended hereto amending Statutes III (2) V, VI, VIII, XVIII (3), XX (1) and (3) and XXII (1) of the existing Statutes of the said College, the said Statute is hereby published in the London Gazette in accord-ance with the provisions in that behalf contained in the said Act. the said Act.

And Notice is hereby given, that any person, body of persons, or body corporate, authorized in that behalf by the said Act, may, within two months after the publication of this notification. petition His Majesty in Council to withhold His approval from the whole or any part of the said Statute.

STATUTE made by the Governing Body of Eton College on the 17th day of March, 1945.

Whereas Statutes for the Government of Eton College were made by the Governing Body cf the said College under the Public Schools Act 1868 and approved by His Majesty The King in Council on the 24th October, 1904. And whereas the said Governing Body in exercise of the Powers for this purpose conferred upon them by Section 11 of the said Act have resolved to alter Statutes III (2) V, VI, VIII, XVIII (3) XX (1) and (3) and XXII (1) in the following manner:— Be it enacted as follows :—

Be it enacted as follows:-

From and after the date of His Majesty's Order in Council approving these Statutes they shall read as follows:

Statute III (2). The Provost shall attend to the good government The Provost shall attend to the good government of the College and shall exercise a general super-intendence over the property and affairs of the College; shall take care that all persons concerned in the administration or service of the College conform to the Statutes and Regulations of the College and School and perform the several duties assigned to them; and shall have power, in all cases not pro-vided for by the Statutes and Regulations of the College and School, or by any resolution of the Governing Body, to act as he shall think fit for the welfare of the College and shall forthwith report such action to the Fellows. such action to the Fellows.

### Statute V.

(1) Except as provided for in Section (2) of this Statute, the Provost, unless absent on College busi-ness or prevented by sickness, shall reside in the College for at least thirty weeks in every year, whereof nine weeks at least shall fall in each of the Summer and Michaelmas School-times and eight weeks at least in the Lent School-time.

(2) The Provost may at any time be granted by a majority of the Fellows special leave of absence for business of public importance or for other cause which they may deem sufficient.

which they may deem sufficient. Statute VI. (I) If at any time the Provost become per-manently incapable of performing the duties of his office, the Visitor may, on the petition of the Provost presented with the consent of a majority of the Fellows present at a meeting specially sum-moned, order that the Provost shall be permitted to retire from his office with such a pension not exceeding Eight Hundred Pounds a year as the Visitor may deem suitable to the circumstances of the case. the case.

the case. (2) If no such petition shall have been presented by the Provost, the Visitor may, if he think fit, on the petition of a majority of two-thirds of the Fellows present at a meeting specially summoned, and after inquiry held by him, declare that the Provost has become permanently incapable of per-forming the duties of his office and order that the Provostship shall be deemed vacant at a time to be forming the duties of his office and order that the Provostship shall be deemed vacant at a time to be fixed by the Order. The Visitor shall by the same order assign to the Provost, on his ceasing to hold office, such pension not exceeding Eight Hundred Pounds a year as the Visitor may deem suitable to the circumstances of the Case. (3) In the event of the Provost resigning his office with the consent of the Crown, the Fellows may assign him on his ceasing to hold office such pension not exceeding Eight Hundred Pounds a year as they may deem suitable to the circumstances of the

### Statute VIII.

Statute VIII. (1) The Provost shall be entitled to a stipend of One thousand Five hundred Pounds per annum or such larger sum as the majority of the Fellows may determine, together with such allowances in kind or in cash for heating, lighting, service, similar expenses and entertanment, as may be fixed from time to time by a majority of the Fellows. He shall reside at The Lodge or such other residence within the precincts of the College as shall be assigned to him by a majority of the Fellows. His residence shall be kept in tenantable repair at the expense of the College and all rates and taxes on it shall be paid by the College. (2) Except with the consent of the majority of the

(2) Except with the consent of the majority of the Fellows, the Provost shall not hold any other office, place or preferment to which an emolument is attached, or exercise any trade or profession.

Statute XVIII (3). (3) Except with the consent of the Provost and Fellows he shall be continuously resident during the whole of each School-time.

### Statute XX.

(1) Except as provided for in Section (3) of this Statute, there shall be seventy Scholars on the Foundation of the College.

(3) On the day of Election in every year the Electors shall arrange on a roll in order of merit the names of as many candidates as shall, in their judgment, be sufficient to supply vacancies. So soon as there shall be any vacancy or vacancies in the Foundation Scholarships, the Head Master shall forthwith notify the same in writing to the Provost, and the Provost shall proceed at once to fill up the said vacancy or vacancies, from and according to the order of the names on the said roll. No such Scholarship shall remain vacant more than twenty-one days during any School-time provided that there are sufficient names of boys on the roll to fill such vacancy. Every such roll shall be cancelled as the first business of the meeting at which the following Election is made, and no candidate shall, by reason of his name having appeared upon such cancelled roll, have any claim to preference at such following Election. Statute XXII (1).

Statute XXII (r). Statute XXII (r). (r) The Foundation Scholarships shall be open to any natural born British subject whose father is also a natural born British subject. Every candidate shall produce evidence satisfactory to the Electors of the date of his birth, and a Certificate of good character from the person or persons who have had charge of his education for the previous twelve months.
