Governing Body of Shrewsbury The Governing Body of Shrewsbury School having, in virtue of the powers conferred upon them by the Public Schools Act, 1868, and of every other power enabling them in that behalf, made a Scheme which was sealed on the 1st day of May, 1937, in the terms appended hereto for further amending and altering the original Scheme (approved by Order in Council of the 12th day of February, 1876), for the removal of the said School from its former site, the said Scheme is hereby published in the London Gazette in accordance with the provisions in that behalf contained in the said Act.

And notice is hereby given, that any person,

And notice is hereby given, that any person, body of persons, or body corporate, authorised in that behalf by the said Act, may, within two months after the publication of this notification, petition His Majesty in Council to withhold His approval from the whole or any part of the said Scheme.

Scheme for Further Amending and Altering the Scheme Approved by Order in Council of the 12th day of February, 1876, for the Removal of Shrewsbury School from its Actual

Whereas by the Public Schools Act, 1868, 31 and 32 Vict. Cap. 118, it is (among other things) enacted as follows:-

Section 25.—Any Scheme authorised to be made under this Act may contain all powers and provisions that may be thought expedient for carrying into effect its objects; and where any Scheme

visions that may be thought expedient for carrying into effect its objects; and where any Scheme authorises the purchase or acquisition of any lands, there shall be deemed to be incorporated with such Scheme "The Lands Clauses Consolidation Act, 1845" with the exception of the provisions relating to the purchase of lands otherwise than by agreement, and of the provisions relating to entry upon land, to intersected lands, and to the recovery of forfeitures, penalties, and costs, and of the provisions relating to access to the special Act.

By Section 26 it is provided (among other things) that the new Governing Body of Shrewsbury School may, if they deem it expedient, at any time after the passing of the Act lay a Scheme before Her Majesty in Council for the removal of the School from its actual site to some other place, and may provide in such Scheme for the sale or mortgage of any property belonging to or held in trust for such School and for its appropriation to building or other purposes, and for the purchase of other property, and for the erection of new buildings on the property so purchased, and generally for all matters required to effect such removal in a convenient manner, to the same extent as if such Governing Body were the absolute owners of any property they might be dealing with under this section as purchasers, vendors. absolute owners of any property they might be dealing with under this section as purchasers, vendors, or otherwise.

And whereas divers other Acts of Parliament have since been passed continuing and enlarging the powers conferred by the above mentioned Act, and in particular it was by the 2nd Section of the Public Schools Act, 1869, enacted that "Any Governing Body established for any of the Schools to which the said Act (meaning the said Public Schools Act, 1863) applies shall, as in the case of Westminster School, be a Body Corporate with perpetual succession and a Common Seal and with power to hold lands for the purposes of the School for which it is established without licence of mortmain." main.

And whereas in pursuance of a Scheme proposed by the Governing Body of Shrewsbury School (hereinafter called "the Governing Body") on the Twenty-first day of August One thousand eight hundred and seventy-five for the removal of Shrewsbury School (hereinafter called "the original Scheme"), which Scheme was duly approved and sanctioned by Her late Majesty Queen Victoria in Council on the twelfth day of February One thousand eight hundred and seventy-six, the Governing Body acquired by purchase the messuages buildings and land situate at Kingsland near Shrewsbury delineated upon the plan annexed hereto and

And whereas in the years 1890 and 1891 the Governing Body acquired by purchase divers others lands (which are adjacent to the said lands coloured pink on the said plan and are thereon coloured pale green) for the purposes of the School, and such purchase and the purchase of other land subsequently acquired which is coloured pale blue on the said plan, were sanctioned by an Amending Scheme proposed by the Governing Body on the Twenty-fifth day of May One thousand eight hundred and ninety-two, which Scheme was duly approved and sanctioned by an Order of Her late Majesty Queen Victoria in Council dated the twenty-eighth day of October One thousand eight hundred and ninety-two.

And whereas in the year One thousand nine
hundred and twelve the Governing Body acquired

And whereas in the year One thousand nine hundred and twenty the Governing Body acquired by purchase the freehold messuage land and hereditaments delineated on the said plan and thereon coloured orange for the purposes of the School, and in the year One thousand nine hundred and seventeen the Governing Body acquired the leasehold land delineated on the said plan and thereon coloured brown for the purposes of the School, and the said purchases were sanctioned by a further Amending Scheme proposed by the Governing Body on the twenty-first day of April One thousand nine bundred and twenty, which Amending Scheme was duly approved and sanctioned by an Order of His Majesty King George V in Council dated the twenty-second day of July One thousand nine hundred and twenty.

And whereas in the year One thousand nine hundred and twenty-one the Governing Body acquired by purchase the freehold messuages land and hereditaments delineated and coloured mauve on the said plan for the purposes of the School in consideration of an annual rentcharge of Three hundred pounds for twenty years, and at or about the same time the Governing Body acquired the leasehold hereditaments delineated on the said plan and thereon coloured magenta for the purposes of the School, And the said purchases were sanctioned by a further Amending Scheme proposed by the Governing Body on the eighth day of August One thousand nine hundred and twenty-one, which Amending Scheme was duly approved and sanctioned by an Order of His Majesty King George V in Council dated the thirty-first day of October One thousand nine hundred and twenty-one.

And whereas in the year One thousand nine hundred and twenty-four the Governing Body acquired by purchase the freehold messuages lands and hereditaments delineated on the said plan and therein coloured dark green for the purposes of the School and the said purchase was sanctioned by a further Amending Scheme proposed by the Governing

And whereas in the year One thousand nine hundred and thirty-seven the Governing Body acquired by purchase the freehold messuage and premises delineated on the said plan and therein coloured yellow hatched green for the purposes of the School and the said purchase was sanctioned by a further Amending Scheme proposed by the Governing Body on the first day of May One thousand nine hundred and thirty-seven which thousand nine hundred and thirty-seven which Scheme was duly approved and sanctioned by an Order of His Late Majesty King George and in Council dated the twenty-ninth day of July One thousand nine hundred and thirty seven.

And whereas all the said purchases were greatly for the benefit of the School and were rendered necessary chiefly by the increase in the number of boys attending the School.

And whereas the Governing Body have for some

time past observed with concern a growing tendency, for the land adjacent to the School premises to be employed for the purpose of building with a con-sequent diminution of access for the School to open

And whereas the practice of cross country running which is a prominent feature of the athletic life of the School would be seriously impaired if the School were to be entirely surrounded by urban development and direct access to open country

And whereas by a Conveyance dated the fifteenth day of October One thousand nine hundred and thirty-four Henry Harrison Hardy, M.B.E., M.A., the then Headmaster of the School and Cuthbert William Mitford, M.A., The Reverend John Osborn Whitfield, M.A., Arthur Everard Kitchin, M.A., Richard Sale, B.A., John Henry Tombling, B.A., James Martineau Street, B.A., and James Russell Hope-Simpson, M.A., being Assistant Masters of the School and Sydney Atterbury Tippetts, B.A., being the Bailiff and Bursar of the School purchased from Alexander Graham and Marion Wallace Cock for the sum of One thousand Pounds a freehold piece or parcel of land coloured red hatched red on the plan hereto annexed which land was conveyed to the said Henry Harrison Hardy Cuthbert William Mitford

John Osborn Whitfield and Arthur Everard Kitchin

John Osborn Whitfield and Arthur Everard Kitchin as Trustees and has since that time been used for the use and benefit of the School.

And whereas under the circumstances aforesaid by an Agreement dated the thirtieth day of September One thousand nine hundred and forty-four the Governing Body have agreed with the said Henry Harrison Hardy Cuthbert William Mitford John Osborn Whitfield and Arthur Everard Kitchin as such Trustees as aforesaid (conditionally on the sanction of His Majesty in Council being obtained to this Scheme) to purchase and the said Henry Harrison Hardy Cuthbert William Mitford John Osborn Whitfield and Arthur Everard Kitchin have agreed to sell the said piece or parcel of land (being the land described in the Schedule hereto) for the the land described in the Schedule hereto) for the sum of Nine hundred pounds the said purchase to be completed on or before the expiration of two months from the date when the purchase shall receive the sanction of His Majesty in Council.

And whereas the purchase of the said piece of land is very desirable in the interests of the School for the reasons hereinbefore appearing.

And whereas it is apprehended that the Governing Body have not power under the Original Scheme or the said Amending Schemes to acquire the land described in the Schedule hereto:

The Governing Body of Shrewsbury School do hereby propose by virtue of and in pursuance of the powers hereinbefore mentioned to alter the Original Scheme as follows (that is to say):

That the Original Scheme shall throughout be read and construed as though the land and hereditaments described in the said Schedule hereto and delineated on the plan hereto annexed and thereon coloured red hatched red had been described in the Schedule to the Original Scheme and delineated on sonedule to the Original Scheme and delineated on the plan thereto annexed and thereon coloured as last aforesaid. And that the said Agreement of the thirtieth day of September One thousand nine hundred and forty-four and the carrying into effect thereof may be deemed to have been authorised by the Original Scheme.

(2) Full and free right and liberty for the Trustees and their successors in title if and so often as they the Trustees or their successors in title shall erect and their successors in title in and so ditch as they the Trustees or their successors in title shall erect on the said property or any part thereof any building which or the land attached to which shall abut on or have access to any road or roadway to be made over and along the strip of land hereinbefore referred to and hereinafter described or any part thereof at all times prior to the time when the said road or roadway shall have been taken over by the Local Authority to use and make any desired connections with any drains sewers gas water and electric light pipes or wires laid thereunder by the Trustees predecessors in title or their successors in title the Trustees or their successors in title paying a fair proportion of the cost of laying down and maintaining such drains sewers gas water and electric light pipes or wires and of maintaining such road or roadway until the same shall be so taken over as aforesaid such proportion to be determined in

light pipes or wires and of maintaining such road or roadway until the same shall be so taken over as aforesaid such proportion to be determined in case of dispute by the Borough Surveyor for the time being of the Borough of Shrewsbury.

Except and reserved (1) a right of way for all purposes over and along a strip of land extending from the said Roman Road or By-pass Road (coloured Brown on the said plan) at or near the point marked "A" on the said plan to a position between the points marked "B" and "C" on the Easterly boundary of the field numbered 23 on the said plan which said field adjoins the property first hereinbefore described on the Westerly side thereof and is the property of the Trustees' pre-

decessors in title such strip of land to be 36 feet in width and the exact position thereof to be decided when necessary and marked out with pegs to the satisfaction of the respective Surveyors of the Trustees' predecessors in title and the Trustees.
