TENDERS FOR TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday, the 27th July, 1945, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills. Act, 1877, the National Debt Act, 1889, and the National Loans Acts, 1939 to 1945, to the amount of £130,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, or £100,000. They will be dated at the option of the tenderer on any business day from Monday, the 30th July, 1945, to Saturday, the 4th August, 1945, inclusive, and will be payable at three months after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates. different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday 12 noon) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office. Bank of England.

9. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.

### COUNTY BOROUGH OF SUNDERLAND.

TOWN AND COUNTRY PLANNING (GENERAL INTERIM DEVELOPMENT) ORDER, 1945.

THE Council has made, with the consent of the Minister of Town and Country Planning, a Direction under Article 5 of the above Order, the effect of which is to require the permission of the Council for development of the following classes:—

(a) The rebuilding, restoration or replacement of buildings and plant which have sustained war damage, except the restoration or replacement of plant, the carrying out of operations immediately necessary in consequence of war damage for avoiding danger to health or preventing the deteriora-tion of any building or otherwise required for temporarily meeting the circumstances created by the damage, and the carrying out of any opera-tions for the rebuilding, restoration or replacement of buildings which have sustained war damage, the cost of which does not exceed froo.

(b) The carrying out of alterations to existing buildings and of operations required for the main-

tenance of existing buildings, except where the cost of such work does not exceed £100 per building in

a period of 12 months,

in respect of the undermentioned areas in the County Borough:

- (i) An area bounded on the North by Coronation Street, on the East by North Durham Street and Hendon Road, on the South by West Lawrence Street and on the West by Sans Street and Upper Sans Street;
- (ii) An area bounded on the North by Borough Road, on the East by the centre line of Tatham Street, on the South by Murton Street and on the West by Laura Street;
- (iii) An area bounded on the North by Dundas Street, Lower Dundas Street, Dock Street and Dock Street East, on the East and South East by Millum Terrace, on the South by Millum Terrace, Nelson Square, Charles Street and Howick Street and on the West by North Bridge Street;
- (iv) An area bounded on the North by Middle Street, on the East by Union Street, on the South by Brougham Street (South Back) and on the West by Crowtree Road;

West Ham-South West No. 1 Area-COMPULSORY PURCHASE ORDER.

NOTICE is hereby given that the Council of the County Borough of West Ham in pursuance of their powers under Section 2 of the Town and Country

Planning Act, 1944, on the Twentieth day of June, 1945, made an Order, which has been submitted for confirmation by the Minister of Town and Counfor confirmation by the Minister of Town and Country Planning, authorising them to purchase compulsorily for the purposes of the redevelopment thereof as an area of extensive war damage the lands described in the Schedule hereto and directing that the provisions of the Act relating to expedited completion of purchase shall apply thereto.

A copy of the Order, and of the map referred to therein, have been deposited at the Offices of the Authority at the Town Hall, West Ham, E.15, and will be open for inspection without payment of fee at all reasonable hours.

Where the Minister confirms the Order, he may, if he is satisfied that it is requisite so to do, confirm the Order with a Direction that the provisions of the Act relating to expedited completion of purchase shall apply to the said lands.

Where the confirmed Order contains such a Direction the following provisions will operate:—

(a) The Lands Clauses Acts and the Acquisition of Land (Assessment of Compensation) Act, 1919, as amended and applied by the Town and Country Planning Act, 1944, will have effect as if a notice to treat such as is mentioned in Section 18 of the Lands Clauses Consolidation Act, 1845, had been served on every person on whom the Council could, under the terms of that Section, have served such a notice, namely, all persons interested in the said lands; all persons enabled by the Lands Clauses Acts to sell and convey or release any of the said lands; or such of the above persons as would after diligent enquiry be known to the Council, and the date on which such notice to treat will be deemed to have been served will be the date on which the Order is registered in the Register of Local Land Charges kept in respect of the area in which the lands are situated. Such notice to treat will not be deemed to have been served on any person in respect of an interest which is a tenancy for a year, or from year to year, or a less interest.

(b) The Council of the County Borough of West Ham may, at any time after the expiration of one month from the date of first publication of the notice of confirmation of the Order and subject to the said tenancies, execute a Declaration:

(i) of their intention to enter on the whole (i) of their intention to enter on the whole or part of the lands to which the Order relates and take possession thereof at the expiration of a period specified in such declaration, not being less than founteen days from the completion of the service of a notice to that effect on occupiers and on persons entitled to claim compensation, who have given information to the Council of the nature of the land in respect of which they are entitled to claim compensation and of their interest therein; and (ii) that the lands will vest in the Council

Any objection to the Order must be made in writing stating the grounds of the objection, and addressed to the Minister of Town and Country Planning, 32, St. James's Square, London, S.W.I, before the Twenty-second day of August, 1945.

The Act provides that if no objection is duly made, or if all objections so made are withdrawn, or if the Minister decides to make a modification agreed to by the person making the objection as meeting the objection, or where the Minister is satisfied, after considering the grounds of the objection and any further statement relating to the objection as the Minister may require an objector to furnish, that the objection relates to a matter which can be dealt with by an arbitrator by whom compensation is to be assessed, or in the case of an objection to an Order authorising a compulsory purchase of land to which an Order under Section 1 of the Act is in force, that the objection is made on the grounds that the purchase is not necessary or inexpedient, the Minister may, if he thinks fit, confirm the Order, with or without any modification except (unless all persons interested consent) a modification extending the Order to any land not designated by the Order as submitted; but in any other case he shall, before deciding to confirm the Order, afford the person making an objection an opportunity of appearing before and being heard by a person appointed for the purpose by the Minister.
