### BOOT AND FLOOR POLISH WAGES COUNCIL (GREAT BRITAIN).

The Boot and Floor Polish Wages Council (Great Britain) hereby gives notice of its intention to submit to the Minister of Labour and National Service proposals for (1) the revocation of the Order B.P.(23) dated 12th January, 1945, and for the fixing of specified statutory minimum remuneration in substitution for the minimum rates of wages at present in operation and (2) for the amendment of the Order B.P.(8) dated 14th June, 1939, which deals with holidays with pay.

(b) in an area comprising the said Orrell Ward on or in respect of any one hereditament £1,000, or ten times the net annual value (if any) which ever is the less of any such hereditament.

In the case of development of Class IV, the carrying out of alterations to, or operations required for the maintenance of any building, the cost of which does not exceed in any period of twelve months—

(a) in an area comprising the whole of the county borough with the exception of Orrell

Ward on or in respect of any one hereditament £100, or ten times the net annual value (if any) whichever is the less of any such hereditament; and
