"Now, therefore, we, the said Ecclesiastical Commissioners recommend and propose that upon and from the 1st day of April 1946, all the endowments payments and other property described and referred to in the said Schedule shall vest in us the said Ecclesiastical Commissioners pursuant to the said Measure and that we shall be entitled absolutely to the benefit rents and profit thereof upon and from that date:

"And we further recommend and propose that we shall pay to the Bishop for the time being of the See by equal quarterly instalments in respect of the quarters ended on the 31st day of March, the 30th day of June, the 30th day of September, and the

31st day of December in every year the first such instalment to be the full quarter's payment due for the quarter ended on the 30th day of June, 1946, an annual stipend comprising the sum of £2,400 and also such sum, not exceeding £600 in any one year, as we shall have been duly satisfied has been expended by him in connection with the travelling required in and for the carrying out of his official duties and obligations as Bishop:

# GEORGE R.I.

GEORGE THE SIXTH, by the Grace of God, of reat Britain, Ireland and the British Great Britain, Dominions beyond the Seas, King, Defender of the Faith, Emperor of India, to all to whom these Presents shall come,

WHEREAS We have taken into Our Royal consideration the many Acts of courage performed by foreign persons, both male and female, in furtherance of the interests of the British Commonwealth in the Allied cause, during the war,

And whereas We are desirous of honouring certain of those who perform or have performed

such deeds:

We do by these Presents for Us, Our Heirs and Successors institute and create a new Medal.

First: It is ordained that the Medal shall be designated and styled "The King's Medal for Courage in the Cause of Freedom

Secondly: It is ordained that the Medal shall be circular in form, but that the preparation of a design and the manufacture of the Medal

shall be postponed for the time being.

Thirdly: It is ordained that the Medal is intended to be worn by recipients on the left breast suspended from a ribbon one-and-a-quarter inches in width, of white, with broad red stripes at each edge and at the centre two narrow blue stripes separated by a narrow white stripe.

It is also ordained that when awards are made the ribbon shall be issued to recipients.

Fourthly: It is ordained that the persons eligible for the Medal shall be civilians of foreign nationality, male or female, upon whom We may think fit to confer the honour.

It is also ordained that foreign persons in military service, male or female, shall be eligible for the Medal provided that they are recommended for specal services outside the scope of normal military duties.

Fifthly: It is ordained that awards shall be made only on a recommendation to Us, for civilians by Our Secretary of State for Foreign

Affairs, and for Officers and members of foreign military forces by Our First Lord of the Admiralty, Our Secretary of State for War, or Our Secretary of State for Air, as the case may be, or, in the case of any of Our Dominions, the Government whereof shall so desire, by the appropriate Minister of State for the said Dominion.

Sixthly: It is ordained that the Medal shall be awarded only for acts of courage entailing risk to life or for service entailing dangerous work in hazardous circumstances, in furtherance of the Allied cause during the war, and shall be granted without distinction of status or rank.

Seventhly: It is ordained that the names of all those upon whom We may be pleased to confer or bestow the Medal, shall be recorded

in a Register in Our Treasury.

Eighthly: It is ordained that it shall be competent for Us, Our Heirs and Successors by an Order under Our Sign Manual and on a recommendation to that effect by or through Our Secretary of State for Foreign Affairs, Our First Lord of the Admiralty, Our Secretary of State for War, or Our Secretary of State for Air, as may be appropriate, or, in the case of any of Our Dominions, the Government where: of shall so desire, the appropriate Minister of State for the said Dominion, to cancel and annul the award to any person of the King's Medal for Courage in the Cause of Freedom and that thereupon the name of such person in the Register shall be erased: provided that it shall be competent for Us, Our Heirs and Successors to restore the award so forfeited when such recommendation has been withdrawn.
