TENDERS FOR TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday, the 21st September, 1945, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Acts, 1939 to 1945, to the amount of £130,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday, the 24th September, 1945, to Saturday, the 29th September, 1945, inclusive, and will be payable at three months after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday 12 noon) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

PETROLEUM (PRODUCTION) ACT, 1934.

In pursuance of Section 2 (3) of the Petroleum (Production) Act 1934, the Minister of Fuel and Power hereby gives notice that in accordance with the provisions of that Act and the Petroleum (Production) Regulations 1935, he has granted to the D'Arcy Exploration Company Limited of Britannic House, Finsbury Circus, London, E.C.2, four prospecting licences in respect of the areas referred to in the Schedule hereto, the boundaries of which are

described by reference to the one-inch Ordnance Survey map, supplemented where necessary by reference to the six-inch Ordnance Survey map.

SCHEDULE.

(1) An area of approximately 183 square miles in the Counties of Lancaster and York.

Northern boundary:

Commencing at the junction of Roman Road and Colne Road in the village of Thornton the boundary follows the main Skipton Road in a north-eastern and eastern direction for about 4 miles to a point where the road runs adjacent to the L.M. & S. Railway west of Gawber Hill. The railway is followed in a south-westerly direction to Skipton North Junction where the railway turns north-east past Skipton Station to the railway bridge at Keighley Road near the Leeds and Liverpool Canal.

Eastern boundary:

Continuing in a southerly and easterly direction along Keighley Road and over Kildwick Bridge the boundary follows Skipton Road, Keighley North Street, South Street, Halifax Road, Haworth Road, Hebden Bridge Road and Stone Posts, through the village of Pecket Well, along Akroyd Lane, through Chisley to the road junction at Dyke Lane. Thence along Height Road to the junction at Midgley Road turning in a west to southerly direction along Midgley Road, over Mytholmoyd Bridge, along New Road crossing the L.M. & S. Railway to Cragg, continuing along Blackstones Edge Road to the road junction at the south-east corner of Blackstones Edge Reservoir.

Southern boundary:

The boundary follows the Halifax Road through Littleborough to the cross roads at Henderson Street where it crosses the Weir and Buckley Road and continues along Bond Street and Greenbank Road to a point about 70 yards from the L.M. & S. Railway (Facit Branch). Thence in a north-westerly direction along the footpath to the junction of Binns Brook Road and Field House Road.

Western boundary:

The boundary continues generally northwards along the road to Burnley skirting the town to Point 429, turning west along Ormerod Road to Godley Bridge and following the Leeds and Liverpool Canal in a north-westerly direction as far as Colne Road. The boundary proceeds along Colne Road through Brierfield, along Manchester Road, Bradley Hall Road, and Leeds Road to the Viaduct Shed in Colne and following the L.M. & S. Railway as far as Primel Hill it turns in a north-easterly direction along the Albert Road to the junction of Market Street and Keighley Road, north along the Skipton Road, continuing along Skipton New Road and through Foulridge to a footpath leading to the L.M. & S. Railway (Skipton-Colne) about 200 yards north-east of Point 543. The railway is followed for about 2½ miles to Earby Crossing south of Point 445 and then along the road to the starting point in Thornton.

(2) An area of approximately 187 square miles in the county of York.

This area is triangular in shape and the northern apex is at Point 328, about one mile south-west of North Stainley at the junction of Musterfield Lane and Tripline Lane.

Eastern boundary:

The boundary proceeds along Tripline Lane through Sutton Grange to the junction of Green Lane, east of the village of Breckmore. Thence along Green Lane, Clotherholm Lane and Back Lane to Bishopton Grove, over Bishopton Bridge and the Old Mill Race at a point south of Bishopton Lodge. The footpath is followed to its junction with Hell Wash Lane; the direction is then generally south-westwards following the roads as far as Raventofts Hall, continuing southwards passing Bishop Thornton and Hampsthwaite to the junction of Grayston Plain Lane and Rowden Lane along Rowden Lane and Birley Bank Road to Penny Pot Lane. Thence in an easterly direction for about ¼ mile where the boundary turns south past Rough Bridge, through Candale Wood, Beckwithshaw to Point 585, continuing along Cinder Lane, Guys Bank to a point opposite Farnley Park Lodge.

Southern boundary:

This proceeds west and south-west along the road, through Otley to a point where the road crosses the L.N.E.R. (Otley & Ilkley Joint Branch).

The boundary then continues along the railway in a westerly direction for about 4½ miles when it branches off at the viaduct in Ilkley and follows the road to Addingham. From Addingham along the road through Silsden to the cross roads beyond Point 348 in Steeton and along Skipton Road to Eastburn.

Western boundary:

Thence through Kildwick to the L.M. & S. Railway Bridge at Skipton where the railway is followed in a north-easterly direction as far as Firth Street, the boundary continues along Brougham Street, The Bailey, Cross Bank, Shires Lane, Kirk Lane, through Eastby over Halton Moor, along the east side of Brill Coppy Wood, Grape Lane, Hazler Lane, New Road, Greenlow Hill to Pateley Bridge to Point 1072 following the road across Dallow Moor to Laverton, Kirksby Malzeard to the north-east corner of Azerley Park and finally to Point 328.

(3) An area of approximately 186 square miles in the county of York.

Northern boundary:

Commencing at Point 378 at the junction of How Hill Road the boundary proceeds in an easterly direction to Bishop Monkton, thence in a southerly direction past Point 120 to Copgrove, along Wath Lane to the L.N.E. Railway at a point about ¼ mile north-east of Copgrove Station, continuing along the railway to the south side of the River Ure at Boroughbridge.

Eastern boundary:

Turning east the boundary follows the river past the Weir to Borough Bridge, along the Horse Fair to Barr Lane, thence passing the junction of New Row and High Street to the Church it proceeds in a south-easterly direction past Point 62, along the Roman Road to the Cycle Hotel at Green Hamerton, and continues over Low Pricka Field to the cross-roads at the south-west corner of Providence Green. The Roman Road is followed south through Cattal to the cross-roads, ¼ mile south-east of Walton, then east to Church Lane, Wighill, and the junction of Wighill Lane and Oxtop Lane, Tadcaster.

Southern boundary:

Thence in a westerly direction along Hillside and the High Street the Roman Road is followed through Bramham to a lane leading to Wotherstone and the old Quarry turning east to Mangrill Lane which it follows in a southerly direction for about a mile to the fork road near Point 279. Passing Point 330 the boundary continues across the L.N.E. Railway (Leeds and Wetherby Branch) along Carr Lane, Holywell Lane, Alwoody Lane to its junction at Alwoody and in a north-westerly direction to Blackhall Road which is followed to Kings Road, Otley Road, through Bramhope to a point where the L.N.E. Railway (Otley Branch) is crossed by the Leeds Road, thence along the railway to Chevin Road.

Western boundary:

The boundary proceeds in a north to north-easterly direction along Piper Lane, Bridge Street, Fernley Lane, Cinder Lane, Bradford Road to Point 585 thence north-east to Point 468, and continuing along Penny Pot Lane to the Red House it follows Birley Bank Road through Hampsthwaite to Lane End Farm, Clint, Clint Bank, Pye Lane, Bishop Thornton, Watergate Road and finally to Point 378 at the junction of How Hill Road.

(4) An area of approximately 120 square miles in the counties of York, Nottingham and Derby.

Northern boundary:

Commencing at the point where the road from Ringinglow joins the main road from Glossop to Sheffield, near Rivelin Mill Bridge, situated in the county of York about four miles west of Sheffield Cathedral, thence by roads skirting the City to Newfield Green and to the road junction at White-lane End; along the road in a north-easterly direction to the cross-roads by Birley Moor Farm, in a general south-easterly direction along the road passing through Holbrook, over the L.M. & S. and L.N.E. Railways to the point where it is crossed by the railway connecting Beighton and Clowne about 1,500 feet south-west of the Sewage Works at Killamarsh.

Eastern boundary:

This boundary runs in a general south-easterly direction along the said railway to the point where it crosses the railway from Clowne to Staveley. Thence in a south-westerly direction by the road

to the point where it crosses the L.M. & S. Railway (Doe Lea Branch) about $\frac{1}{4}$ mile south-west of Nether Woodhouse, continuing along the railway in a southerly direction to where the road from Palterton to Heath is crossed and following the north side of the said road in a south-westerly direction past Stockley to the point where it crosses the River Doe Lea, in a northerly direction by the right bank of the river to the footbridge about 100 feet south of the point where the river is joined by Stockley Brook. The boundary continues westwards to the railway line at Temple Normanton, in a southerly direction towards Pilsley, eastwards for about one mile, north to the Heath-Palterton road and along the road as far as the L.M. & S. Railway line, then in a south-easterly direction by the line and road towards Mansfield.

Southern boundary:

This follows the road westwards from the Brick Works by Mansfield, through Skegby, Fackley, and Tibshelf to the L.M. & S. Railway line at Dopehill Station.

Western boundary:

The railway line is followed in a northerly direction to Hasland and from here the boundary continues along the road on the outskirts of Chesterfield, passing Brampton to Cutholme where the road turns westwards, proceeding as far as Curbar northward along the left bank of the River Derwent to Nether Padley, thence by road through Ringinglow to the point of departure.
