If not exceeding 10 lines of printed matter-15s.

For each additional 5 lines or under-7s. 6d.

Table or tabular matter will be charged at the rate of £1 ros. per quarter page or part thereof.

(g) In Notices of Dissolution of Partnership, the signatures of the partners will not be charged for.
