And whereas it is expedient to make other pro-

And whereas it is expedient to make other provision than in the said Orders is contained in regard to the constitution of the said Legislative Council.

Now, therefore, His Majesty, by virtue and in exercise of the powers by the Foreign Jurisdiction Act, 1890, or otherwise in His Majesty vested, is pleased, by and with the advice of His Privy Council,

I. This Order may be cited as the Tanganyika (Legislative Council) Amendment Order in Council, 1945, and shall be construed as one with the Principal Order, as amended by the Amending Order, and the Principal Order, the Amending Order and the Principal Order, the Amending Order and this Order may be cited together as the Tanganyika (Legislative Council) Orders in Council, 1926 to 1945.

II. Clause Five of the Principal Order is hereby revoked without prejudice to anything lawfully done thereunder and the following Clause substituted

VI. Clause XII of the said Order shall be construed as if the words "His Majesty for his confirmation or disallowance, signified through" were omitted therefrom.

VII. This Order shall come into operation on a date to be fixed by the Governor by proclamation in the Gazette and shall be published in the Gazette, and the Governor shall give directions for the publication of this Order at such places and in such manner and for such time or times as he thinks proper for giving due publicity thereto within the

Territory.

VIII. His Majesty, His Heirs and Successors, in Council may at any time revoke, alter, add to, or amend this Order.

Whereas the Colony of Kenya is a British Settlement within the meaning of the British Settlements Act, 1887:

And whereas by treaty, grant, usage, sufferance and other lawful means His Majesty the King has power and jurisdiction within the Uganda Probower and Infistiction within the Oganda Fro-tectorate, the Tanganyika Territory in respect of which His Majesty has accepted a mandate on behalf of the League of Nations, the Protectorate of Kenya and the Protectorate of Zanzibar:

Now, therefore, His Majesty, by virtue and in
exercise of the powers in this behalf by the British
Settlements Act, 1887, the Foreign Jurisdiction Act,
1890, or otherwise in His Majesty vested, is pleased,
by and with the advice of His Privy Council, to
order, and it is hereby ordered as follows:

1. This Order may be cited as "The East African
Territories (Air Transport) Order in Council, 1945".

PART I .- INTERPRETATION.

In this Order, unless the context otherwise

requires, the expression—
"British Resident, Zanzibar" includes the Officer for the time being exercising the powers and performing the duties of the British Resident

of the Protectorate of Zanzibar;

"East African territories" means collectively the Colony and Protectorate of Kenya, the Uganda Protectorate, the Tanganyika Territory and the Zanzibar Protectorate.

PART II.—ESTABLISHMENT OF THE EAST AFRICAN AIR TRANSPORT AUTHORITY.

(I) There shall be established an East African Air Transport Authority (hereinafter referred to as the Authority).

(2) The Authority shall consist of the following members

(a) the officer administering the Government of Kenya;

(b) the officer administering the Government of Uganda;

(c) the officer administering the Government of

(c) the omcer administering the Government of Tanganyika Territory; and
(d) the British Resident, Zanzibar, acting, save where specifically otherwise provided herein, jointly or in conference.

(3) At such times as the members of the Authority are not in conference and subject as beginning.

(3) At such times as the members of the Authority are not in conference and subject as hereinafter provided, the member administering the Government of Kenya shall have full power to do all or any of the acts, or to carry out all or any of the functions, which the Authority is empowered to do or which are vested in the Authority, as the case may be, under the provisions of this Order but shall report to the other members of the Authority not later than the next conference (as hereinafter in this Order provided) all acts done and decisions made by him when so acting; provided that the members may by agreement decide—

(a) what acts and decisions shall be deemed to be acts and decisions of a minor administrative

be acts and decisions of a minor administrative nature involving no important principle and which need not be so reported; and

- . (b) the matters which shall not be dealt with by the member administering the Government of Kenya without prior reference to the other members.
- 4.—(r) The members constituting the Authority shall meet in conference on matters relating to air transport as and when occasion arises: Provided that such meetings shall take place at least twice in each year.
- (2) In the event of the members of the Authority failing to reach agreement on any matter relating to air transport, such matter shall be referred to the Secretary of State for his decision.

PART III.—AUTHORITY'S POWER TO CONTROL AIRCRAFT PLYING FOR HIRE OR REWARD.

5.—(r) The Authority may, with the approval of the Secretary of State, by Regulation under the hand of a person authorised in that behalf by the

Authority, make provision:

(a) for securing that aircraft shall not be used in the East African Territories by any person;

(i) for plying, while carrying passengers or goods for hire or reward, on such journeys or classes of journeys (whether beginning and as may be specified in the Regulations, or

(ii) for such flying undertaken for the purpose of any trade or business as may be so specified except under the authority of, and in accordance with, a licence granted to the said person by the Authority;

(b) as to the manner in which, and the person to whom, application for such licences shall be

made;

(c) as to the circumstances in which such a licence may or shall be granted, refused, revoked or suspended, and in particular as to the matters to which the Authority is to have regard in deciding whether to grant or refuse such a licence;

(d) as to the conditions which may be attached

such a licence (including conditions as to the to such a licence (including conditions as to the fares, freight or other charges to be charged by the holder of the licence), and for securing compliance with any conditions so attached;

(s) as to the information to be furnished by an applicant for, or the holder of, such a licence;

(f) for prescribing the fees to be paid in respect of such a licence.

of such a licence

(2) A Regulation made under the provisions of this section may, for the purpose of securing compliance with the Regulation, provide for the imposition of penalties not exceeding, in the case of a first offence against the Regulation, a fine of fifty pounds or, in the case of a second or subsequent such offence, a fine not exceeding £1,000 or, in default of payment, to imprisonment for a term of two years.

term of two years.

(3) A Regulation made under the provisions of this section shall not have effect until it has been approved by the Secretary of State.

approved by the Secretary of State.

6.—(I) When any Regulations have been made under paragraph (a) of sub-section (I) of Section 5 of this Order, and an application for a licence is received, the Authority shall have full power in its discretion to grant or to refuse to grant the licence or to grant the licence subject to such terms and conditions as the Authority may think fit.

(2) In exercising such discretion the Authority shall have regard to the co-ordination and development of air services generally with the object of ensuring the most effective service to the public while avoiding uneconomical overlapping and generally to the interests of the public, including those of persons requiring or likely to require facilities for air transport, as well as those of persons providing such facilities. In particular the Authority shall have regard to the following matters:

(a) the existence of other air services in the area

(a) the existence of other air services in the area through which the proposed services are to be operated;

(b) the possibilities of air transport in that area;

(c) the degree of efficiency and regularity of the air services, if any, already provided in that area, whether by the applicant or by other operators;

whether by the applicant or by other operators;
(d) the period for which such services have been operated by the applicant or by other operators;
(e) the extent to which it is probable that the applicant will be able to provide a satisfactory service in respect of continuity, regularity of operation, frequency, punctuality, reasonableness of charges, and general efficiency;

(f) the financial resources of the applicant;(g) the type of aircraft proposed to be used on the service;

and the Authority shall take into consideration any objections or representations duly made in accordance with the provisions of any Regulations made under Section 5 of this Order.

PART IV.—CONSTITUTION OF CORPORATION TO BE KNOWN AS "EAST AFRICAN AIRWAYS".

- 7. So soon as may be after the making of this Order, there shall be established a Corporation to be known as the East African Airways with perpetual succession and a common seal which shall be capable of suing and of being sued and of purchasing or otherwise acquiring, holding and alienating property, movable and immovable, and of doing or performing all such acts and things as bodies corporate may by law do and perform.
- 8.—(1) The Corporation shall consist of a Chairman and five members (three of whom shall not be members of the public service) to be nominated by, and who shall hold office during the pleasure of, the Authority.
- (2) The Chairman shall be appointed by the Authority.
- (3) Four members of the Corporation shall form a quorum for any meeting of the Corporation.
- (4) The Chairman shall, in the case of an equality votes, have a casting vote in addition to a deliberative vote.
- (5) If any member of the Corporation shall be prevented by absence or other cause from acting as such, the Authority may appoint some other person to act and vote in his place until such time as such member shall return or be able to resume his duties.
- (6) The Chairman and members of the Corporation may be paid, in respect of their offices as such, such fees or remuneration from the funds of the Corporation as the Authority may determine.
- 9.—(1) The Corporation shall, with the approval of the Authority, appoint a General Manager who shall have such of the authority and powers of the Corporation as may be delegated to him by the Corporation or as may otherwise be conferred upon him by law.
- (2) The General Manager may, with the prior consent of the Corporation, delegate such of the powers delegated to him under sub-section (1) of this section or as may otherwise be conferred upon him by law, to such servants of the Corporation as the General Manager may consider necessary and desirable for the convenient and efficient working of the Corporation.
- (3) The General Manager shall be entitled to be present at all meetings of the Corporation and to take part in the discussions, but he shall not be entitled to vote.
- 10.—(1) It shall be the duty of the Corporation, subject as hereinafter provided, to secure the fullest development, consistent with economy, of efficient air transport services within the East African Territories and to secure that such services are operated at reasonable charges.
- (2) The Corporation shall have power, subject as hereinafter provided, either in connection with the discharge of their duty under the preceding sub-

ca) to acquire aicraft, parts of aircraft, aircraft equipment and accessories and stores;

(b) to acquire or construct, aerodromes, buildings and repair shops;

(c) to acquire lights, beacons, wireless installations and other plant and equipment;

(d) to call let or otherwise dispose of any

(d) to sell, let, or otherwise dispose of any property belonging to them and not in their opinion required for the proper discharge of their

(e) to establish or maintain air transport services

and, for that purpose, to enter into arrangements or agreements with any other person;

(f) to act as agents for any other undertaking engaged in the provision of air transport services, or in other activities of a kind which the

Corporation have power to carry on;
(g) to undertake flights on charter terms;
(h) to provide accommodation, in hotels or otherwise, for passengers, and facilities for the transport of passengers to or from aerodromes and for the collection, delivery and storage of baggage and freight;

(i) to make, with persons carrying on a business of providing any facilities for passengers or freight in connection with air transport services, arrangements for the provision of such facilities.

- (2) The Corporation may also, with the consent of, or in accordance with the terms of any general authority given by the Authority, borrow temporarily by way of over-draft or otherwise such sums as they may require for meeting their obligations and discharging their functions under this Order
- 12.—(1) The Corporation may create and issue stock (whether non-interest bearing or otherwise), for the purpose of enabling the Corporation to raise any money which they are empowered under this Order to borrow by the issue of stock.

 (2) Such stock and the interest thereof (if any) shall be charged on the undertaking and all property and revenues of the Corporation.

- 13. The Corporation shall establish an Airways Fund and all receipts of the Corporation shall be carried to that Fund and all payments by the Corporation shall be made out of that Fund.
- 14. The revenues of the Corporation (including any grant made to it from the public funds of any of the East African Territories) for any financial year shall be applied:
 - ear shall be applied:

 (a) in defraying the working and establishment expenses and expenditure on, or provision for, the maintenance and renewal of the undertaking and the discharge of the functions of the Corporation (including payments in respect of, and provision for, pensions and superannuation allowances), properly chargeable to revenue account;

 (b) in paying the interest on any Stock issued, or temporary loan raised, by the Corporation;

 (c) in transferring sums required by the Authority to be transferred to a Sinking Fund, or otherwise set aside, for the purpose of making provision for the redemption of stock.

 15.—(1) The Corporation shall keep proper

15.—(1) The Corporation shall keep proper accounts and other records in relation thereto and shall prepare in respect of each financial year a statement of accounts in such form as the Authority may direct.

may direct.

(2) Such accounts shall be audited by auditors to be appointed by the Authority.

(3) So soon as the accounts for the Corporation have been audited, the Corporation shall send a copy of the statement of accounts referred to in sub-section (1) of this section to the Authority together with a copy of any report made by the auditors on that statement or on the accounts of the Corporation.

(4) The Authority shall cause a copy of severy such statement and report to be laid before the respective Legislative Councils of each of the East

African Territories.

-(1) The Corporation shall, as soon as possible r6.—(1) The Corporation shall, as soon as possible after the end of each financial year, make to the Authority a report dealing generally with the operations of the Corporation during that year and containing such information with respect to the proceedings and policy of the Corporation as the Authority may determine.

(2) The Authority shall lay a copy of every such report before the respective Legislative Councils of each of the East African Territories.

(3) The Corporation shall furnish to the Authority—

 (a) such financial and statistical returns; and
 (b) such information with respect to the financial
 position of any subsidiary company,
 as the Authority may from time to time require.

 17.—(1) The Corporation shall, on or before the
 30th day of September in each year, submit to the
 Authority a full programme of the operations of
 the Corporation for the year next ensuing. Such
 programme shall show—

 (a) each air service proposed to be correted by
 - (a) each air service proposed to be operated by the Corporation that year;

(b) an estimate of the profit or loss on each

such service;
(c) the provision of any additional air services;

(c) the provision of any additional air services;
(d) the withdrawal of any services;
(e) the provision of any additional, or the withdrawal of any existing, aircraft or equipment;
(f) the tariff of charges of the Corporation:
(g) detailed estimates of expenditure and revenue of the Corporation.
(2) The Authority may either—
(a) approve the programme;
(b) after consultation with the Chairman and the General Manager of the Corporation, direct such deletions from, or modifications, or additions

- such deletions from, or modifications, or additions to, the programme; or

 (c) where the contemplated operation of the Corporation shows an estimated deficiency of revenue over expenditure, direct such reduction in such estimated deficiency as to the Authority may seem fit. Where such a direction has been given, the Corporation shall effect such reduction by such methods, and in such manner, approved by the Authority, as the Corporation may détermine.
- 18. The Corporation may appoint such servants of the Corporation as they may consider necessary for the proper working and operation of the Corporation. Such servants shall be employed upon such terms and conditions of service as the Corporation. such terms and conditions of service as the Corporation may, with the approval of the Authority, determine. The Corporation may also accept the services of any person seconded to the service of the Corporation as they may consider necessary or expedient: and any such person shall be deemed for all purposes to be a servant of the Corporation, except in so far as the Corporation may agree to the contrary with such seconded person or his employers. employers.
- 19. The Corporation shall, if and when required by the Postmaster-General, perform all such reasonable services in regard to the conveyance of mails (with or without officers of the Posts and Telegraphs Department in charge thereof) by the Corporation's aircraft or any of them as the Authority shall from time to time require time to time require.

The remuneration for any services performed in pursuance of this section shall be such as may be from time to time determined by agreement between the Postmaster-General and the Corporation.

- 20. The Corporation shall not be required by any of the respective Governments of the East African Territories to provide air transport facilities gratuitously, or subject to preferential conditions or at a rate of charge which is insufficient to meet the cost involved in the provision of such facilities, unless the Government concerned undertakes to pay the amount of loss incurred by reason of the provision of such grant of facilities.
- 21. The Corporation may make such Rules as it may consider necessary or desirable for the proper working, management and control of the Corporation so far as is not inconsistent with this Order or with any other law in force in any of the East African Territories.
- 22. Nothing in this Order shall be construed as exempting the Corporation from compliance with the provisions of this Order or of any Regulations made thereunder, relating to the licensing of air transport.

PART V.-GENERAL.

- 23. The Interpretation Act, 1889, shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 24. His Majesty, His Heirs and Successors in Council may from time to time revoke, alter, add to or amend this Order.

And whereas by an Order in Council of the 3rd August, 1945, notice of such Representation was given, and it was ordered that the same should be taken into consideration by a Committee of the Privy Council on the 15th day of September next,

Privy Council on the 15th day of September next, and such Order has been published in the London Gazette, and copies thereof have been affixed, as required by the said Act:

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to order, as it is hereby ordered, that no new burial ground shall be opened in the said Civil Parish of Burford save with the previous approval of the Minister of Health, and that burials shall be discontinued therein as follows, viz.:—

Burford.—Forthwith and entirely in the Parish Church of Saint John the Baptist, Burford, and in the Churchyard attached thereto.
