- Peter Noel Vesery NEWSOME, Apprentice, s.s. Tantalus '' (Öcean Steam Shipping Company Ltd.). The s.s. "Tantalus" was bombed and
 - sunk at anchor in Manila Bay, the crew being ashore at the time. Apprentice Newsome and two others attempted to get back to Bataan, but found that the bridges had already been blown outside Manila.

When Japanese troops entered Manila they were interned.

Apprentice Newsome escaped from the camp on 12th January, 1945, and joined some guerillas. He discovered these to be bandits and left them, but was caught and confined to a hut. Two days later he got away again and joined a large concentration

of guerillas at Pila. When the Ame the American forces arrived at Manila, Newsome, together with a party of guerillas and U.S. paratroops, attacked the camp and succeeded in liberating the prisoners, numbering about 2,100.

For the next two months until the Americans entered the area in force Newsome

commanded the Filipino guerillas. Apprentice Newsome displayed outstanding courage and coolness and did much useful work before being repatriated.

Captain Andrew Melville CAVAYE, Master, s.s. Iceland " (Currie Line Ltd.). The s.s. "Iceland" was

" Iceland " was sailing from Gibraltar in a convoy which was attacked by submarines, and two ships were lost. On the same day an attack by enemy bombers was made on the convoy, causing the loss of four ships. The "Iceland" turned back to the assistance of one of these vessels, which, sinking quickly, had overturned a lifeboat of survivors. The "Iceland" launched her starboard boat and succeeded in rescuing seven of the men who had been thrown in the water.

The following day a further attack was made on the convoy, and another ship was The steering gear of the " Iceland " sunk. parted and she was obliged to stop for repairs. Two shells were fired over s.s. "Ice-land" by the German cruiser "Admiral Hipper", and the Master had no alternative but to abandon ship. In spite of the bad weather all the crew got into the life-boats safely and were made prisoners by the raider. They have now been repatriated. Captain Cavaye was outstanding throughout and he displayed great courage in the face of overwhelming odds.

A tanker struck a mine and immediately caught fire. Although the sea was covered with blazing spirit over a large area, the s.s.

"Portia " which was following in the wake of the vessel at once lowered a boat. Five survivors were picked up in spite of the grave danger of the burning spirit which continued to spread rapidly.

The Second Officer, who was in charge of the boat, displayed coolness and courage in the rescue operations.
