TENDERS FOR TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday, the 8th February, 1946, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Acts, 1939 to 1945, to the amount of £130,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, or £100,000. They will be dated at the option of the tenderer on any business day from Monday, the 11th February, 1946, to Saturday, the 16th February, 1946, inclusive, and will be payable at three months after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which

the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. The persons whose Tenders are accepted will be informed of the same not later than the following day and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday 12 noon) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

Civil Service Commission, February 1, 1946.

The Civil Service Commissioners (hereinafter called "The Commissioners") with the approval of the Treasury have made the following Regulations, viz.:—

TEMPORARY (RECONSTRUCTION) REGULATIONS FOR FILLING VACANCIES IN THE GRADE OF ASSISTANT COMMISSIONER UNDER THE NATIONAL SAVINGS COMMITTEE.

1. Both men and women may compete under these Regulations.

2. In order to be eligible, a candidate must have been born on or after the 2nd August, 1904, and have attained the age of 21 by the 1st January of the year in which he or she competes.

3. Every candidate must be either

(a) a natural-born British subject

(i) having at least one parent who is or was at the time of death a British subject; or

(ii) of any other parentage, provided that he or she has resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of his or her appointment; or

(b) a naturalized British subject who has resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of his or her appointment; or

(c) A British subject who, although not fulfilling the requirements of sub-paragraph (a) or sub-paragraph (b), satisfies the Commissioners that he or she is so closely connected with His Majesty's dominions either by ancestry, upbringing or residence, or by reason of national service, that an exception may properly be made in his or her favour.

4. Candidates must satisfy the Commissioners that they have received such systematic education and possess such knowledge as to fit them for the post. University training and a knowledge of economic subjects are desirable. The Commissioners may submit all or any of the candidates to a qualifying examination to test their education or any part of it.

5. Candidates must satisfy the Commissioners as to their health and character.

The Commissioners reserve the right to give such preference to disabled persons or particular classes of disabled persons as may be necessary in order to give effect to any general policy regarding the employment of such persons which may be adopted by His Majesty's Government, provided that the disability is not of a nature to interfere with the discharge of the duties of the post.

6. Every woman candidate must be unmarried or a widow and if appointed will ordinarily be required to resign her appointment on marriage.

7. No person who is undergoing a course of study with the aid of a grant from public funds shall be eligible to compete under these Regulations before the completion of the course, unless he or she has previously obtained permission to do so from the authority which administers the grant.

8. Every candidate must apply on the appropriate form within the time and in the manner of which notice is given by the Commissioners.

9. Candidates who are recommended by the National Savings Committee and are accepted by the Civil Service Commissioners as possessing the requisite qualifications will be summoned to (a) a preliminary informal interview and (b) an interview before a Selection Board, who will recommend to the Commissioners for appointment (subject to the terms of Regulation 10) the candidates who appear to them to possess the highest qualifications. The Selection Board may also recommend that a certain number of candidates shall be classified as reserve

candidates and considered by the Commissioners for appointment in conjunction with the results of a later Board. The decision of the Commissioners will be final. The Selection Board will take into consideration a candidate's record of experience and education, any recommendations that they may receive from persons named by candidates as having direct knowledge of their work in the past, and the personal qualities of the candidates as shown at the interview; and on their estimation of the above evidence they will frame their decision.

10. It is the intention that of the total number of vacancies to be filled from the whole series of Selection Boards—

(a) men Service candidates shall receive not less than two-thirds; and

(b) of the remainder women Service candidates shall receive not less than the proportion yielded by the ratio of their applications to the total number of applications from all candidates except men Service candidates.

Provided that in either case a sufficient number of Service candidates reach the required standard.

11. For the purpose of these Regulations candidates shall be regarded as Service candidates if they have rendered whole-time service during any period after the 25th May, 1939, in

(a) the Armed Forces of the Crown;

(b) the Mercantile Marine or the Merchant Navy; or

(c) any of the Women's Services, that is to say, any of the capacities mentioned in the First Schedule to the Disabled Persons (Employment) Act, 1944.

12. Persons upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appropriate central education authority (that is, the Ministry of Education, the Scottish Education Department, or the Ministry of Education for Northern Ireland, as the case may be) has been notified to the Commissioners.

13. Candidates shall pay a fee of £1. on application. Every successful candidate will be required to pay a further fee of £3 before the issue of a certificate of qualification for appointment.

14. Any attempt on the part of candidates to enlist support for their applications through Members of Parliament or other influential persons, except as referees to be named by them in their application form, will disqualify them for appointment. The Selection Board will disregard recommendations from persons who are not personally acquainted with the candidate's work, whether at school, in the Forces or otherwise.

(3) to empower the Corporation to provide offices (including banks), shops (including catering establishments), stores, warehouses and other tenements or buildings in connection with their proposal to construct a new cattle market and also in connection with any of their markets and their markets undertaking;

(4) to enable the Corporation to grant leases of stalls, shops, lands or premises on any of the markets under their control for a longer period than three years, that is to say, for a period not exceeding seven years;

(5) to empower the Corporation with the consent of the Minister to lay out and develop any lands belonging to them which are not required for the purposes for which they were acquired;

(6) to authorise the Corporation to borrow with the consent of the Minister such sums as may be necessary for the purposes of the Order; and

(7) for the several purposes of the application, or for purposes connected with, incidental to or consequent on those purposes, to make any such alteration or amendment of the local Act, or of any other local Act, or of any Act confirming a Provisional Order made in pursuance of any of the Sanitary Acts or of the Public Health Act, 1875 and in force in the City, as may be necessary or desirable:
