CITY OF WINCHESTER.

ROAD TRAFFIC ACT, 1930—SECTION 46.

ROAD AND RAIL TRAFFIC ACT, 1933—SECTION 29.

NOTICE is hereby given that on the 25th January, 1946, the Minister of War Transport modified and confirmed the City of Winchester Roads (Restriction) Order, 1944, made by the Winchester City Council under Section 46 of the Road Traffic Act, 1930, and Section 29 of the Road and Rail Traffic Act, 1933.

The effect of the Order is to prohibit any person from driving or causing to be driven any heavy locomotive, light locomotive, motor tractor or heavy motor car (as respectively defined in Section 2 of the Road Traffic Act, 1930, or in any Regulations made or to be made thereunder) or any motor car (as defined as aforesaid) with seats for more than seven persons exclusive of the driver on that length of High Street (including the Westgate) from its junction with Southgate Street to its junction with Castle Avenue in the City of Winchester.

The order is available for inspection at the Guildhall, Winchester.

RURAL DISTRICT OF ISLE OF AXHOLME.

TOWN AND COUNTRY PLANNING (GENERAL INTERIM DEVELOPMENT) ORDER, 1945.

NOTICE is hereby given that the Council of the Rural District of the Isle of Axholme have, with the consent of the Minister of Town and Country Planning, given a Direction under Article 5 of the Town and Country Planning (General Interim Development) Order, 1945, with respect to the land comprising the Rural District of the Isle of Axholme.

The effect of the Direction is that as from the 5th day of February 1946, being the date of the publication of this Notice in the London Gazette, any development of the description set out in the Schedule hereto shall not be undertaken on the said land unless permission therefor is granted on application made under the said Order, but without prejudice to anything done before that date or to the making of an application under the said Order for permission for development of any description to which the Direction relates.

A copy of the Direction and a map defining the area to which it relates may be seen at The Gables, Epworth, at all reasonable hours.

SCHEDULE.

The carrying out by mining undertakers, on land comprised in their undertakings, of any development required for the purpose of their undertakings, being development comprised within Class V referred to in Article 4 of the said Order and not being development of any other Class, except:—

(a) the winning and working of minerals during a period of 12 months from the date hereof on land which adjoins land used at the date hereof for the same purpose, where, in relation to that use, such winning and working forms a continuous operation;

(b) the carrying out in case of emergency of any development of that Class;

(c) the extension, alteration and maintenance of plant or other structures or erections required for the winning, working, treatment or disposal of minerals;
