The KING's Most Excellent Majesty in Council. WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 26th day of February, 1946 (P.M. 1584/46) in the words following viz.:—

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, interalia, that all pay, pensions, or other allowances in the nature thereof, payable in respect of service in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman or Marine, therein, or to the widow or relative of a deceased Officer, Seaman or Marine, shall be paid in such manner, and subject to such restrictions, conditions and provisions, as are from time to time directed

manner, and subject to such restrictions, conditions and provisions, as are from time to time directed by Order in Council:

"And whereas by Your Majesty's Orders in Council dated 28th September 1944 and 24th January 1945, provision is made for the increase of certain Naval pensions and other awards, including awards administered by the Minister of Pensions, to continue in force until 31st December 1945:

"And whereas we deem it expedient, that the said provisions for the increase of the pensions and other awards should continue beyond the 31st December 1945:

"We beg humbly to recommend that Your Majesty may be graciously pleased by Your Order in Council to extend the provisions of the aforesaid Orders to 31st March 1947.

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal."

His Majesty, having taken the said Memorial into

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

WHEREAS by Section 670 of the Merchant Shipping Act, 1894, it is enacted that when any Lighthouse, Buoy, or Beacon has either before or after passing of that Act been erected or placed on or near the coast of any British Possession by or with the consent of the Legislature of that Possession, His Majesty may, by Order in Council, fix such dues (in that Act referred to as Colonial Light Dues) to be

paid in respect of that Lighthouse, Buoy, or Beacon by the Owner or Master of every Ship which passes the same and derives benefit therefrom as His Majesty the same and derives benefit therefrom as His Majesty may deem reasonable, and may by like Order increase, diminish or repeal such Dues, and those Dues shall from the time mentioned in the Order be leviable throughout His Majesty's Dominions, and further that Colonial Light Dues shall not be levied in any British Possession unless the Legislature of that Possession has, by address to the Crown or by Act or Ordinance duly passed, signified its opinion that the Dues ought to be levied:

And whereas by Orders in Council, dated respectively the 22nd day of May, 1883, the 9th day of May, 1892, the 29th day of June, 1896, the 10th day of August, 1903, the 21st day of October, 1912, the 6th day of February, 1917, the 14th day of July, 1922, the 6th day of February, 1925, the 5th day of November, 1926, and the 27th day of October, 1930, the Dues leviable in respect of the said Lighthouses for the Classes of Ships therein respectively mentioned were duly fixed:

And whereas by Order in Council, dated the 26th day of February, 1934, His Majesty directed that, as from the 1st day of April, 1934, or from the time of the receipt of notice of that Order, if that be later, by the Officers authorised to collect Light Dues, the Dues thenceforth to be levied should be as follows, that is to say, in respect of the Great Basses Lighthouse and the Little Basses Lighthouse, three hundredths of one penny per ton, and in respect of Lighthouse and tre Little Basses Lighthouse, three hundredths of one penny per ton, and in respect of the Minicoy Lighthouse one hundredth of one penny per ton, of the burden of every ship on every voyage in which she passes or derives benefit from the said Lights respectively:

Now, therefore, His Majesty, in exercise of the powers so vested in Him by the above recited provisions, and by and with the advice of His Privy Council, doth by this Order in Council order, and it is hereby ordered, as follows:

1. This Order may be cited as "The Colonial Light Dues (Great and Little Basses and Minicoy) Order 1946".

As from the 1st day of April, 1946, or from the time of the receipt of this Order, if that be later, by the Officers authorised to collect Light Dues, the Dues thenceforth to be levied shall be as follows, that is to say, in respect of the Great Basses Lighthouse and the Little Basses Lighthouse, three twentieths of one penny per ton, and in respect of the Minicoy Lighthouse, one twentieth of one penny per ton of the burden of every ship on every voyage in which she passes or derives benefit from the said Lights respectively.

WHEREAS the Ecclesiastical Commissioners for England have duly prepared and laid before His Majesty in Council a Scheme bearing date the 14th day of February, 1946, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, have prepared and now lay before Your Majesty in Council, the following scheme pursuant to the Episcopal Endowments and Stipends Measure, 1943, for vesting in us, the said Ecclesiastical Commissioners, all endowments and other property belonging to, or held in trust for, the Bishopric of Peterborough or the Bishop thereof and for securing to the said Bishop the reduced stipend deemed to us appropriate:

to the said Bishop the reduced stipend deemed to us appropriate:

"Whereas the Right Reverend Claude, Bishop of Peterborough, was in occupation of the See at the date of the passing of the aforesaid Measure and has requested us, the said Ecclesiastical Commissioners, to prepare a scheme with respect to the See:

"And whereas we have prepared this scheme accordingly after consultation with the Diocesan Board of Finance of the Diocese of Peterborough, who have offered no objection thereto:

who have offered no objection thereto:

"And whereas the said Claude, Bishop of Peterborough, has approved the scheme and in testimony of such approval has appended his signature to the scheme:

"And whereas the Right Honourable Clement Richard Attlee, First Lord of Your Majesty's Treasury, acting on behalf of Your Majesty, has signified to us his consent to the preparation and submission of the scheme to Your Majesty in

"And whereas the endowments and property belonging to the See of Peterborough held in trust therefor or for the Bishop thereof are described and referred to in the schedule hereunder written:

"And whereas income of the See to which the Bishop for the time being is entitled is £4,000 per annum and an annual contribution is required to be paid by him for the purpose of pension in accordance

annum and an annual contribution is required to be paid by him for the purpose of pension in accordance with the provisions of the Episcopal Pensions Measures, 1926 and 1945:

"Now therefore, we, the said Ecclesiastical Commissioners, recommend and propose that upon and from the 6th day of April, 1946, all the endowments securities and other property described and referred to in the said schedule shall vest in us, the said Ecclesiastical Commissioners, pursuant to the said Measure and that we shall be entitled absolutely to the benefit rents and profits thereof upon and from the benefit rents and profits thereof upon and from that date.

"And we further recommend and propose that we shall pay to the Bishop for the time being of the See by equal quarterly instalments in respect of the quarters ended on the 31st day of March, the 30th day of June, the 30th day of September, and the 31st day of December in every year, the first such instalment to be the full quarter's payment due for the quarter ended on the 30th June, 1946, an annual stipend comprising the sum of, so long as the Bishop remains in occupation of the whole of the Palace, Peterborough, as the legal house of residence of the See, £2,200 under a tenancy agreement made with us See,  $f_{2,200}$  under a tenancy agreement made with us and of  $f_{2,000}$  otherwise and in particular so soon as such part of the said Palace as shall in our opinion be redundant and unnecessary shall have been separated or let separately, together with, as an addition to the said sum of £2,200 or £2,000, as the case may be, such sum, not exceeding £500 in any one year, as we shall have been duly satisfied

any one year, as we shall have been duly satisfied has been expended by the Bishop in connection with the travelling required in and for the carrying out of his official duties and obligations as Bishop.

"And we further recommend and propose that the annual contribution payable to us by the Bishop, for purposes of pension shall notwithstanding the reduction hereby effected in the stipend of the Bishop be the amount which may be payable by the Bishop for the time being under the Episcopal Pensions Measures, 1926 and 1945.
