Privy Council Office, 25th October, 1946. THE PUBLIC SCHOOLS ACT, 1868

THE GOVERNING BODY OF CHARTERHOUSE SCHOOL having, on the 9th day of October, 1946, in virtue of the powers conferred upon them by the abovenamed Act, made a Statute in the terms appended hereto amending the existing Statutes of the said School, the said Statute is hereby published in the London Gazette in accordance with the provisions in that behalf contained in the said Act.

And Notice is hereby given that any person, body of persons, or body corporate, authorized in that behalf by the said Act, may, within two months after the publication of this notification, petition His Majesty in Council to withhold His approval from the whole or any part of the said Statute.

STATUTE made by the Governing Body of Charter-house School on the 9th day of October, 1946.

THAT STATUTES numbered 11 and 12 of the Statutes for the Government of Charterhouse School approved by His Majesty in Council on the sixteenth day of December One Thousand Nine Hundred and twelve (copies of which are set out in the Schedule hereto) be repealed and the following substituted:

"II. The Governing Body shall in each financial year commencing from the first day of April One Thousand Nine Hundred and forty-six set aside the sum of One Thousand Three Hundred Pounds to be applied as follows:

Firstly, in the provision of five prizes to be called 'Sutton's Prizes' which shall each be in the form of books to the value of Twenty

Pounds.

Secondly, in the payment of Exhibitions already awarded and tenable by virtue of the provisions of Clauses 11 and 12 of the Statutes dated the sixteenth day of December One Thousand Nine Hundred and twelve (prior to the repeal thereof by this and the succeeding Statutes) provided that in any year in which the balance of the said sum of One Thousand Three Hundred Pounds shall be insufficient to meet such payments the Governing Body shall meet such payments the Governing Body shall make good the deficiency and

Thirdly, in the provision of Grants in Aid of such amounts as the Governing Body shall determine which shall be available after quitting the School, subject to the conditions hereinafter prescribed to persons who may seem to the Governing Body to need and deserve such aid.

12. The Sutton's Prize shall be awarded as the result of an examination (to be conducted as the Governing Body shall direct) and shall be open to all boys in the School. In awarding the Grants in Aid available after quitting the School, the Governing Body may take into account the result of such examination. The Grants in Aid shall be payable (dependent upon satisfactory proof from term to term to the Governing Body of good conduct and diligence) at any University in the United

Kingdom, or in any other place of special educa-tion, or elsewhere, in preparation for any profession or occupation, subject to the approval of the Governing Body."

#### TENDERS FOR TREASURY BILLS.

- 2. In order to be eligible, a candidate must have been born on or after the 2nd August, 1905, and on or before the 1st August, 1916.
  - 3. Every candidate must be either (a) a natural-born British subject

(i) having at least one parent who is or was at the time of death a British subject; or

(ii) of any other parentage, provided that he or she has resided in His Majesty's dominion and/or been employed elsewhere in the service

and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of his or her appointment; or (b) a naturalized British subject who has resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of his or her appointment; or (c) A British subject who, although not fulfilling the meduirements of sub-paragraph (a) or sub-

the requirements of sub-paragraph (a) or sub-paragraph (b), satisfies the Commissioners that the or she is so closely connected with His Majesty's dominions either by ancestry, upbringing or residence, or by reason of national service, that an exception may properly be made in his or her favour favour.

4. Candidates must possess a wide experience of driving over the past ten years and have an unblemished motoring record. They should know the Highway Code in detail and have a general acquaintance with Road Transport law. Experience in driving ruition, conducting interviews, or writing concise and accurate reports, would be an additional advantage. advantage.

5. Successful candidates must satisfy the Commissioners as to their health and character.

The Commissioners reserve the right to give such The Commissioners reserve the right to give such preference to disabled persons or particular classes of disabled persons as may be necessary in order to give effect to any general policy regarding the employment of such persons which may be adopted by His Majesty's Government, provided that the disability is not of a nature to interfere with the discharge of the duties of a Driving and Traffic Examiner for which a high physical standard is normally required mally required.

Persons upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appropriate central education authority (that is, the Ministry of Education, the Scottish Education Department, or the Ministry of Education for Northern Ireland, as the case may be) has been notified to the Commissioners.

7. Every candidate must apply on the appropriate form within the time and in the manner of which notice is given by the Commissioners.

Candidates who appear to have the requisite qualifications and to be best fitted for appointment will be invited to appear before a Selection Board constituted by the Civil Service Commissioners in conjunction with the Ministry. Candidates recommended for appointment by the Selection Board will not be declared successful unless they give proof of driving competence by passing a driving test, which will be arranged as nearly as possible at the same time as the Selection Board. The Commissioners may also, at their discretion, require a candidate to take a written test so that they may be satisfied of his eductional standard.
