The KING has been graciously pleased to approve the award of the British Empire Medal (Military Division) to:-

968272 Flight Sergeant (now Warrant Officer) William George STATHAM, Royal Air Force Volunteer Reserve, No. 109 Squadron. Flight Sergeant Statham was captured near Becherel in November, 1941, after baling out of his aircraft and was imprisoned in Stalags VIIIB and VIIIA. On one occasion he changed identities with a soldier and was sent to a detachment at Rettbach, from whence he escaped on 2nd June, at Rettbach, from whence he escaped on 2nd June, r942, but was recaptured the following evening. In September, r942, he and a companion escaped from their work at Cleiwitz. When arrested at Kattowitz, however, they succeeded in convincing the police that they were Greek civilians and were allowed to proceed, only to be arrested near Cracow. During the next  $2\frac{1}{2}$  years Flight Sergeant Statham escaped on five occasions, his periods of liberty varying from a few hours to 6 days; twice he reached the Czech border. When the Germans were evacuating prisoners during the Allied adwere evacuating prisoners during the Allied ad-vance, Flight Sergeant Statham escaped from the marching column and met American forces 12 days later.
