TREASURY MINUTE PRESCRIBING THE TERMS UPON WHICH REPAYMENTS OF LOANS MADE FROM THE LOCAL LOANS FUND BEFORE IST AUGUST, 1945, MAY BE ALLOWED IN ADVANCE OF THE DUE DATE.

My Lords, having regard to the redemption of Local Loans Stock on 5th January, 1947, have had under consideration the terms on which repayment of loans made before 1st August, 1945, to Local Authorities and others from the Local Loans Fund can be accepted in advance of the date at which, in

can be accepted in advance of the date at which, in accordance with the terms agreed to by the borrower at the time when the loan was made, the principal of such loans falls due for repayment.

2. The conditions which at present govern the acceptance of such repayments are prescribed in Treasury Minute of 5th October, 1933, as amended by Treasury Minute of 4th August, 1937. It is evident, however, that these conditions will not be applicable to loans repaid on or after 13th January, 1947 (i.e. 7 days after the redemption of Local Loans Stock).

3. My Lords have also had under consideration

3. My Lords have also had under consideration Section 31 of the Finance Act, 1935, which provides

Section 31 of the Finance Act, 1935, which provides that:

"If at any time after Local Loans Stock has been . . redeemed . . . the Treasury are satisfied that the assets of the Local Loans Fund exceed in value its liabilities by an amount not less than ten million pounds, they may, if they think fit, by notice published in the London Gazette direct that such relief shall be given from such outstanding obligations to the Fund either in respect of interest or in respect of capital as may be specified in the notice. . . ."

A review of the Fund's assets and liabilities is being made but until this review is completed it will not be possible for Their Lordships to consider whether any relief can be given. Accordingly the terms of acceptance of premature repayments of loans made from the Local Loans Fund before 1st

loans made from the Local Loans Fund before 1st August, 1945, must be separately considered.

4. The intention of Parliament, as embodied in the Statutes governing the Fund, was that the Fund should be safeguarded against loss, and My Lords attach importance to the maintenance of the general principle that borrowers repaying before the due date should repay an amount sufficient to liquidate the liability incurred by the Local Loans Fund in respect of the advance which, as a result of the repayment of Local Loans Stock, is now a liability to the Exchequer.

the Exchequer. 5. The terms on which premature repayments of loans advanced from the Local Loans Fund before 1st August, 1945, have hitherto been accepted, are dependent on the rate of interest yielded by Local Loans Stock at the average market price of such Stock on the day seven days before the repayment is to be made. As an interim arrangement pending the results of the review of the assets and liabilities of the Local Loans Fund and without prejudice to the practice to be followed thereafter or to the principle stated in paragraph 4 above, My Lords have decided that after Local Loans Stock has been nave decided that after Local Loans Stock has been redeemed the terms of such repayments should continue for the present to be related to the rate of interest yielded by Local Loans Stock immediately prior to the announcement of the redemption of that

stock.

6. The Chancellor of the Exchequer therefore recommends and My Lords approve that as from 13th January, 1947, and until further notice, there shall be substituted for the conditions laid down in the Treasury Minute of the 5th October, 1933, the following conditions, viz.:

Applications for repaying, in advance of their due date, loans made before the 1st August, 1945, shall only be accepted provided:—

(1) That at least a month's notice of the intention to repay is given to the Public Works Loan Commissioners.

- 2(2) That the borrower repays a sum equal to the present value of the annuity payments (or payments of equal instalments of principal with diminishing interest) still remaining to be made to the Public Works Loan Commissioners under the mortgage with those Commissioners, such present value being calculated by discounting the annuity payments (or other annual or half-yearly payments) at a rate of two and seven-eighths per

My Lords authorise and require that, unless and until They shall otherwise direct, and subject to the exception provided for below, the cash sum to be lodged in respect of the repayment in advance of loans made from the Local Loans Fund before the 1st August, 1945, shall be calculated in accordance with the terms of this Minute.

8. Should any question arise in a particular case as to the correct amount of the discounted value of the annuity (or other) repayments which it is desired to anticipate under the terms of this Minute, the matter shall be referred to the Lords Commissioners of His Majesty's Treasury whose decision shall be

9. As an exception repayment in respect of un expended balances of loans already advanced will continue to be accepted (subject to due notice) on the basis of £100 for each £100 cash advanced in any case where the Public Works Loan Commissioners are satisfied that the balance is unexpended either because a scheme is less costly than was anticipated or because it has been definitely

reduced in extent.

10. This Minute does not affect the validity of the Treasury Minute of 1st August, 1945 (regarding Loans made on or after that date), which remains

### PROVISIONAL RULES AND ORDERS, 1946. POOR LAW, ENGLAND.

### BOARDING OUT OF CHILDREN.

The Public Assistance (Boarding Out) Order, 1946. Provisional Regulations, dated December 7, 1946, made by the Minister of Health under the Poor Law Act, 1930 (20 Geo. 5. c. 17) for the amendment of the provisions of the Public Assistance Order, 1930, relating to the Boarding Out of Children. 104565.

Whereas by the Public Assistance Order, 1930 (S.R & O. 1930 (No. 185) p. 1405), (in this order referred to as "the principal order") made by the Minister of Health under the Poor Law Act, 1930, provision is made in relation to the discharge of the poor law functions of councils of counties and county boroughs, and by Part VI of the principal order as amended by the Public Assistance (Amendment) Order, 1945 (S.R. & O. 1945 No. 113), regulations are prescribed in regard to the boarding out of children; 

And whereas it is expedient that further provision should be made in regard to the boarding out of children:

Now therefore the Minister of Health hereby certifies under Section 2 of the Rules Publication Act, 1893 (56 & 57 Vict. c. 66), that on account of urgency the following regulations should come into immediate operation, and in exercise of his powers under the Poor Law Act, 1930, and of all other powers enabling him in that behalf, hereby makes the following order to come into operation forthwith as provisional rules:—

1. This order may be cited as the Public Assistance (Boarding Out) Order, 1946, shall come into operation on the first day of January, 1947, and shall be read as one with the principal order.

2. The following provisions shall be substituted for the provisions contained in Part VI and Form 9 in the First Schedule of the principal order as amended by the Public Assistance (Amendment)

Order, 1945.
3. In any case in which, in the exercise of any powers other than the powers conferred by this order, relief other than institutional relief or medical assistance, is afforded by any Council to or on account of a child apart from its parents, the child shall be deemed to be boarded out and the provisions of this order shall apply accordingly:

shall be deemed to be boarded out and the provisions of this order shall apply accordingly:

Provided that the supply of clothing or pocket money to a child who is being accommodated in the area of the Council under an evacuation plan shall not be deemed to be relief for the purposes of this Article.

4.—(1) Relief by boarding out shall not be granted in any case for an initial period exceeding three months, and the case shall be reconsidered within the period for which relief is granted and thereafter

months, and the case shall be reconsidered within the period for which relief is granted and thereafter not less frequently than once in every three months.

(2) Any such relief may be given by way of loan to the parent of the child.

5.—(1) A Council, before boarding out any child within their area or undertaking the supervision of a child boarded out within their area by another Council, shall appoint a boarding out committee to act as a sub-committee of the Public Assistance Committee. Committee.

(2) The Council may, and if required by the Minister shall, appoint more than one such boarding out committee, and each committee shall act for a

defined part of the Council's area.

(3) If only one committee is appointed, they shall act for the whole of the Council's area.

(4) A committee may consist wholly or partly of persons whe are not members of the Council but shall include not less than three women.

(5) Every committee shall hold a meeting at least once in every period of three months.

6. A person deriving any pecuniary or other personal profit from the boarding out of a child shall thereby be disqualified from becoming or continuing

to be a member of a boarding out committee.

7. It shall be the function of a boarding out committee to find suitable homes for children whom any Council may desire to board out in the committee's area and to exercise supervision over all children boarded out under their care.

8. Every child boarded out by any Council shall be placed under the care of a boarding out committee, unless the child is boarded out outside the Council's area and the Council themselves exercise supervision

over the child.

9. Before the Council board out a child in a home outside the Council's area, the Council shall notify to the Council in whose area the house is situated—

(a) the address of the proposed home at which the child will be boarded out; and
(b) unless they have made administrative arrangements with that other Council, that they will exercise supervision over the child;

and any such administrative arrangements shall include arrangements for visiting the child, exercising supervision over the boarding out arrangements and over the welfare of the child, medical examination and medical care and the furnishing of all reports on the child.

ro.—(1) Every boarding out committee shall furnish to the Minister or to any of his officers or to the Council, when so required, all reasonable information respecting their proceedings and the children boarded out under their care, and shall keep a book containing a record of the proceedings at each of their meetings meetings

(2) All records or reports kept by or made to them shall be in the custody of their secretary and shall at all times be open to inspection by any officer of the Minister or of the Council.

- 11. The Clerk shall keep a Register of Boarded Out Children containing particulars of the relief granted in respect of children boarded out by the Council whether within or without their area and of children boarded out within their area by another Council under administrative arrangements made with the Council.
- 12.—(1) Every boarding out committee shall record in a separate case paper particulars of each child boarded out under their care containing all available information relating to the child and to the action taken by the committee from time to time in regard to it as also information relating to such matters as may be prescribed by the Council or the Public Assistance Committee.

(2) A copy of every report made under Article 21.
22 or 24 shall be placed in the case paper.
(3) A copy of any such report which relates to a child boarded out under the care of the committee by a Council other than the Council which appointed the committee shall be sent to the Clerk who shall forward it to the Council by whom the child was boarded out, and a record of the despatch of the

copy shall be made in the case paper.

(4) The case paper shall be laid before the committee on each occasion on which the case is considered by them, the information contained therein being first verified and if necessary brought up to

(5) The case paper shall be forwarded to the Clerk on each occasion on which in consequence of Article 4 of this order the case requires to be considered by the Council or a relief committee, to be laid by him before the Council or that committee together with the Register of Boarded Out Children, or in the case of a child boarded out by another Council under the care of the committee in order that he may report to that Council.

(6) The arrangements under which any child is

boarded out under the care of a committee shall be reviewed by them at the expiration of three months from the date on which the child was boarded out and thereafter at intervals of not more than six months, and a record of their consideration of the matter shall be made in the case paper.

13. In the event of a withdrawal from a committee of authority to act as a boarding out committee, all children boarded out within the area of that committee shall be removed with all reasonable expedition unless a new committee is constituted in their place.

14. Any Council under whose care a child is boarded out outside their area shall comply with such of the provisions of this order as would be applicable if the child were boarded out under the

care of a boarding out committee.

15.—(1) The Council may, and when required by the Minister shall, appoint an officer for the purpose of assisting the Council and boarding out committees in the performance of their functions under this order and in particular of visiting boarded out children within the area of the Council.

(2) Except in any case in which a child is boarded out by the Council outside their area but under their care, and subject to any regulation made by the Council or the Public Assistance Committee, the officer shall act under the direction of a boarding out committee or boarding out committees.

16.—(1) A child shall not be boarded out, or he allowed to remain boarded out—

(a) with a person who has at any time been

convicted of an offence which renders him unfit to be a foster parent; or

(b) in any environment which is likely to be

- (b) In any environment which is likely to be detrimental to the child.

  (2) The Council in selecting a person with whom a child is to be boarded out shall, if possible, select a person who is of the same religious persuasion as the child or who gives an undertaking that the child will be brought up in accordance with that religious persuasion. religious persuasion.
- 17. A child shall not be boarded out, or be allowed to remain boarded out in a home where more than four other children are resident unless all the children resident in the home are brothers or sisters of the child.
- 18. Before a child is boarded out, the Council shall arrange for him to be examined by a medical officer and shall obtain from that officer a certificate as to the physical health and mental condition of the child and his suitability for boarding out.
- 19.—(1) A foster parent shall, on receiving a child to be boarded out with him, be required by the Council to sign in duplicate an agreement in the

form set out in the Schedule to this order, or in a form to the like effect.

(2) One copy of the agreement shall be retained by the foster parent and the other shall be kept by the Council.

- 20. A child shall not be boarded out, or be allowed to remain boarded out, with a foster parent who is a party to any contract for the purpose of insuring the payment to him of a sum of money upon the illness or death of the child.
- 21. No child shall be boarded out unless the proposed foster parent and home have been visited by an officer appointed under Article 15 of this order, or by a woman member of the boarding out committee, who, having been given full information about the child, has made due inquiry and furnished a report in writing to the committee, stating in (a) the proposed foster parent is of good reputation; particular whether-

(b) he is in a position to take proper care of the child;

(c) the sleeping and living accommodation and other domestic conditions are satisfactory; and (d) the home is likely to suit the particular

needs of the child.

22.—(1) The Council shall arrange for an officer appointed under Article 15 of this order or a woman member of the boarding out committee to visit and see the child and the home where he is boarded out-

 (a) within one month of his being placed in the home and thereafter as often as may be necessary, not being less often than once in every six weeks;

(b) if a foster parent changes his address, within one month of the receipt by the Council of notice

of the new address:

Provided that where a child is over nine years of age and has been for not less than two years in the same home, which is proving suitable to his needs, the Council may decide to reduce the number of periodical visits to not less than one in every three months.

(2) The Council shall require the visitor to make them, after every visit to a child, a report in to them, after every visit to a child, a report in writing as to the health, welfare and conduct of the child, the condition of the home (including the sleeping and living accommodation), any complaint made by or concerning the child and whether the home appears suitable for the child.

23. If it is found that the conditions in the home

are seriously detrimental to the health or safety of the child or that the child is no longer suitably placed in the home, the Council or any boarding out committee concerned shall remove the child

from the foster parent.

24.—(1) The Council shall appoint a doctor to attend the child, and the name and address of the doctor shall be furnished to the foster parent.

(2) The Council shall arrange with the doctor to examine the child within a month of their boarding him out and to make a report to them, and thereafter to examine the child at least once a year.

(3) The Council shall arrange for the provision of

all medical treatment ordered by the doctor and all

necessary dental treatment.

- (4) The Council shall require the foster parent report to them all cases of serious illness or accident to the child and to summon a doctor at once in all such cases.
