PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS in the exercise of powers conferred on Him by Section 1 of the Diplomatic Privileges (Extension) Act, 1944 (7 & 8 Geo. 6. c. 44), His Majesty in Council was pleased to make the Diplomatic Privileges (U.N.R.R.A.) Order, 1945 (S.R. & O. 1945 (No. 79)), the Diplomatic Privileges (U.N.I.O., the Refugees Committee and E.A.C.) Order, 1945 (S.R. & O. 1945 (No. 84)), the Diplomatic Privileges (The Transport Organisation and War Crimes Commission) Order, 1945 (S.R. & O. 1945 (No. 1211)), the Diplomatic Privileges (United Nations Organisation and Preparatory Commission) Order, 1945 (S.R. & O. 1945 (No. 1539)), the Diplomatic Privileges (Preparatory Commission of the United Nations Educational, Scientific and Cultural Organisation) Order, 1945 (S.R. & O. 1945 (No. 1638)), the Diplomatic Privileges (the Transport Organisation Amendment) Order, 1945 (S.R. & O. 1945 (No. 1639)), the Diplomatic Privileges (the European Coal Organisation) Order, 1946 (S.R. & O. 1946 (No. 895)):

And whereas, The European Advisory Commission and the Preparatory Commission of the United Nations having ceased to exist, it is expedient to revoke the aforesaid Orders in so far as they apply to these organisations:

And whereas it is expedient further to amend the provisions of the said Orders.

Now, therefore, His Majesty, by virtue and in exercise of the powers on this behalf by the aforesaid Act or otherwise in His Majesty vested, is pleased by and with the advice of His Privy Council to order and it is hereby ordered as follows:—

*Article 1* (i) Each of the aforesaid Orders shall from the date when this Order enters into force have effect as if the words "and rates" were omitted from paragraph 3 of Part II and from paragraph 2 of Part III of the Schedule to the aforesaid Act.

(ii) The words "and rates" shall be omitted from each of the aforesaid Orders wherever they appear.

*Article 2.* The Diplomatic Privileges (U.N.I.O., the Refugees Committee and E.A.C.) Order, 1945, is hereby revoked in so far as it applies to the European Advisory Commission.

*Article 3.* The Diplomatic Privileges (United Nations Organisation and Preparatory Commission) Order, 1945, is hereby revoked in so far as it applies to the Preparatory Commission of the United Nations.

*Article 4* (i) This Order may be cited as the Diplomatic Privileges (General Amendment) Order in Council, 1946.

(ii) This Order shall be laid before Parliament. It shall enter into force on the 4th day of January, 1947.

And the Right Honourable Ernest Bevin, His Majesty's Principal Secretary of State for Foreign Affairs, is to give the necessary directions herein.

## EXPLANATORY NOTE.

(This Note is not part of the Order, but is intended to indicate its general purport.)

The purpose of this Order is:

(a) To revoke S.R.O's., 1945, Nos. 79, 84, 1211, 1539, 1638, 1639 and S.R.O., 1946, No. 895 in so far as they apply to the European Advisory Commission and the Preparatory Commission of the United Nations, as these bodies have ceased to exist.

(b) To revoke the exemption from rates accorded to individuals as the representatives of Governments to, or as officials of, any of the International Organisations which have been accorded immunities and privileges under the various Diplomatic Privileges Orders referred to. This change brings existing Orders in Council made under the Diplomatic Privileges (Extension) Act, 1944, into line with the provisions of the Diplomatic Privileges (Extension) Act, 1946, which does not give power to grant exemptions from rates to such persons.

The KING's Most Excellent Majesty in Council.

WHEREAS it is, among other things, enacted by the Merchant Shipping Act, 1894, that the Legislature of any British Possession may by any Act or Ordinance, confirmed by His Majesty in Council, repeal wholly or in part any provisions of the said Act (other than those of the third part thereof which relate to emigrant ships) relating to ships registered in that Possession, but that any such Act or Ordinance shall not take effect until the approval of His Majesty has been proclaimed in the Possession or until such time thereafter as may be fixed by the Act or Ordinance for the purpose:

And whereas by an Act passed in the Session held in the 15th and 16th years of Her Majesty Queen Victoria's reign, entitled "An Act to grant a Representative Constitution to the Colony of New Zealand," it is, amongst other things, declared that no Bill which shall be reserved for the signification of His Majesty's pleasure thereon shall have any force or authority within the Colony of New Zealand until the Governor of the said Colony shall signify, either by speech or message to the Legislative Council and House of Representatives of the said Colony, or by Proclamation, that such Bill has been laid before His Majesty in Council, and that His Majesty has been pleased to assent to the same:

And whereas by a Proclamation dated the 9th day of September, 1907, His Majesty King

Edward VII was graciously pleased to change the style and designation of "the Colony of New Zealand" to "the Dominion of New Zealand":

And whereas a certain Bill of 1936 (No. 59), passed by the Legislative Council and the House of Representatives of the said Dominion entitled "An Act to amend the Shipping and Seamen Act, 1908" was reserved by the Governor General of the said Dominion for the signification of His Majesty's pleasure thereon:

And whereas His Majesty was pleased, by an Order in Council, dated the 2nd day of February, 1937, to confirm, approve and declare His Majesty's Assent to the said Bill:

And whereas a certain Bill passed by the Legislative Council and House of Representatives of the said Dominion to amend the said Act entitled "An Act to amend the Shipping and Seamen Act, 1908" has been reserved by the said Governor General for the signification of His Majesty's pleasure thereon:

And whereas the said Bill so reserved as aforesaid has been laid before His Majesty in Council and it is expedient that the said Bill should be assented to by His Majesty:

Now, therefore, His Majesty, in pursuance of the said Act and in exercise of the powers thereby reserved to His Majesty as aforesaid doth by the present Order, by and with the advice of His Privy Council, confirm and declare His Assent to the said Bill.

WHEREAS the Ecclesiastical Commissioners for England have in pursuance of the Union of Benefices Measures, 1923 to 1936, duly prepared and laid before His Majesty in Council a Supplementary Scheme bearing date the 21st day of November, 1946, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, acting in pursuance of the Union of Benefices Measures, 1923 to 1936, have prepared and now humbly lay before Your Majesty in Council the following Supplementary Scheme for making an alteration in the Order of Your Majesty in Council (hereinafter called 'the original Order') dated the 5th day of May, 1939, and published in the *London Gazette* on the 9th day of the same month for effecting the union of the benefices (under the style of 'The Benefice of Birmingham, Saint Thomas') and of the parishes of the benefices of Birmingham, Saint Thomas; and Birmingham, Immanuel; both in the diocese of Birmingham.

#### " SUPPLEMENTARY SCHEME.

"Whereas by the original Order it was directed that upon the union of the said benefices and parishes the church of the parish of Saint Thomas, Birmingham, should be the parish church of the united parish and that the church of Immanuel, Birmingham, should be taken down and the materials and site thereof sold and disposed of by us at such time or times and in such manner in all respects as to us should seem expedient:

"And whereas the said union took effect on the 9th day of May, 1939, but the demolition of the church of Immanuel, Birmingham, and the sale of the materials and site thereof were deferred by us as inexpedient:

"And whereas the said parish church of Saint Thomas, Birmingham, was subsequently destroyed by enemy action and the church of Immanuel aforesaid is the sole remaining church in the parish and has been used as the parish church of the parish under directions issued by the Bishop of the diocese pursuant to the Clergy (National Emergency Precautions) Measure, 1939:

"And whereas it appears to us and to the said Ernest William, Bishop of Birmingham, necessary that the original Order shall be altered in manner hereinafter recommended and proposed:

"Now, therefore, we, the said Ecclesiastical Commissioners, with the consent of the said Ernest William, Bishop of Birmingham (in testimony of which consent he has signed this Scheme) do humbly recommend and propose to Your Majesty as follows, that is to say:—

"That upon and from the day when any Order of Your Majesty in Council ratifying this Scheme shall be published in the *London Gazette* the name of the united benefice shall be the benefice of Saint

Thomas and Immanuel, Birmingham, and the directions contained in the original Order for declaring the church of Saint Thomas, Birmingham, the parish church and for the demolition of the said church of Immanuel, Birmingham, and the sale of the materials and site thereof and disposal of the font, communion table, plate, bells, organ and other furniture and fittings shall cease to have effect, and the said church of Immanuel, Birmingham, shall be the parish church of the said united parish of Saint Thomas and Immanuel, Birmingham."

And whereas the provisions of the Union of Benefices Measures, 1923 to 1936, and the Union of Benefices Rules, 1926 to 1930, relating to the preparation and submission of this Supplementary Scheme have been duly complied with:

And whereas the said Supplementary Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty by and with the advice of His said Council is pleased hereby to affirm the said Supplementary Scheme and to order that it shall be and become effectual in law immediately upon the publication of this Order in the *London Gazette*.

WHEREAS the Ecclesiastical Commissioners for England have duly prepared and laid before His Majesty in Council a Scheme bearing date the 21st day of November 1946 in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, have prepared and now lay before Your Majesty in Council the following Scheme pursuant to the Episcopal Endowments and Stipends Measure 1943, for vesting in us, the said Ecclesiastical Commissioners, all endowments and other property belonging to, or held in trust for, the Bishopric of Guildford or the Bishop thereof and for securing to the said Bishop the reduced stipend deemed to us appropriate:

"Whereas the Right Reverend John, Bishop of Guildford, was in occupation of the See at the date of the passing of the aforesaid Measure and has requested us, the said Ecclesiastical Commissioners, to prepare a Scheme with respect to the See:

"And whereas we have prepared this Scheme accordingly after consultation with the Diocesan Board of Finance of the Diocese of Guildford who have offered no objection thereto:

"And whereas the said John, Bishop of Guildford, has approved the Scheme and in testimony of such approval has appended his signature to the Scheme:

"And whereas the Right Honourable Clement Richard Attlee, First Lord of Your Majesty's Treasury, acting on behalf of Your Majesty, has signified to us his consent to the preparation and submission of the Scheme to Your Majesty in Council:

"And whereas the endowments and property belonging to the See of Guildford or held in trust therefor or for the Bishop thereof are described and referred to in the Schedule hereunder written:

"Now therefore, we, the said Ecclesiastical Commissioners, recommend and propose that upon and from the 1st day of January 1947 all the endowments securities and other property described and referred to in the said Schedule shall vest in us the said Ecclesiastical Commissioners pursuant to the said Measure and that we shall be entitled absolutely to the benefits rents and profit thereof upon and from that date.

"And we further recommend and propose that we shall pay to the Bishop for the time being of the See by equal quarterly instalments in respect of the quarters ended on the 31st day of March, the 30th day of June, the 30th day of September and the 31st day of December in every year, the first such instalment to be the full quarter's payment due for the quarter ended on the 31st day of March 1947 an annual stipend comprising the sum of £2,000 and also such sum, not exceeding £400 in any one year, as we shall have been duly satisfied has been expended by him in connection with the travelling required in and for the carrying out of his official duties and obligations as Bishop.

#### " SCHEDULE.

##### " Part I.

"All that Episcopal Residence forming part of Farnham Castle in the County of Surrey and all those

gardens and pleasure grounds forming part of the grounds of Farnham Castle aforesaid as the same are delineated and more particularly described in the plan numbered 1 annexed hereto and are thereon shown coloured dark pink in the case of the site of the buildings and light pink in the case of the other premises (including the enclosure wall extending along the greater part of the external boundary of the land shown coloured light pink on the said plan). And also the following parts of the building standing on the site shown coloured dark blue on the said plan numbered 1 namely: (a) the heating chamber in the basement floor shown coloured dark pink on the plan numbered 2 hereto annexed and (b) the room on the top or attic floor shown coloured dark pink on the said plan numbered 2 together with the rights or easements set forth in Clause 2 of a conveyance dated the 20th day of February 1936 whereby the above mentioned premises were conveyed by the Guildford Diocesan Board of Finance to us as part of the endowment of the Bishopric of Guildford and to the intent that the building and other premises conveyed should become and be the official house of residence of the said Bishopric but subject to the exception and reservation set out in Clause 3 of the said conveyance and subject to or (as the case may be) with the benefit of the provisions of Clause 4 of the said conveyance so far as the same are capable of taking effect on the transmission of the before mentioned premises to us.

#### " Part II.

" The Annual Payment of £3,000 charged upon our Common Fund by an Order of Your Majesty in Council dated the 21st day of December 1937 and duly published in the London Gazette on the 24th day of the same month.

#### " Part III.

" All that sum of £159 7s. 2d. held by us for the improvement and repair of the Episcopal Residence of the Bishop of Guildford.

#### " Part IV.

" All that Crozier or pastoral staff and all those the silver ink stand furniture and other goods and chattels (if any) belonging to the Bishop of Guildford in right of his dignity and not in his private capacity and described and set forth in an inventory to be deposited by us in the Diocesan Registry of the Diocese of Guildford."

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately upon the publication of this Order in the London Gazette pursuant to the said Measure.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Guildford.

" We, the Ecclesiastical Commissioners for England, acting in pursuance of the New Parishes Measure, 1943, have prepared and now humbly lay before Your Majesty in Council the following Scheme for altering the boundaries of the parish of Wooburn and the parish of Beaconsfield both in the county of Buckingham and in the diocese of Oxford:

" Whereas we are satisfied that it is desirable that the boundaries of the said parishes should be altered in the manner hereinafter mentioned:

" And whereas the Bishop of the diocese consents to the proposed arrangements (in testimony whereof he has signed this Scheme):

" Now, therefore, we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that from and after the day of the date of publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme the boundaries of the said Parish of Wooburn and of

the said parish of Beaconsfield shall be altered in the manner described in the Schedule and delineated on the map annexed to this Scheme:

#### " THE SCHEDULE.

" The Schedule to which the foregoing Scheme has reference.

" The territory (shown by the pink colour on the map) to be annexed to the parish of Beaconsfield in the diocese of Oxford:—

" All that portion of the said parish of Wooburn which is bounded upon the east and part of the north east by the said parish of Beaconsfield, upon the remaining parts of the north east and upon part of the north west by the parish of Penn and upon the remaining sides, that is to say upon the remaining part of the north west, upon the south west, upon the west and upon the south by an imaginary line commencing on the boundary which divides the said parish of Penn from the said parish of Wooburn at a point in the middle of Riding Lane opposite to the middle of the footpath leading to White House Lane and extending thence south westwards to and along the middle of the last mentioned footpath for a distance of 23 chains or thereabouts and extending thence south eastwards in a straight line for a distance of 2½ chains or thereabouts to the north western end of the wall or fence which divides the close marked A from the closes marked B and C and extending thence generally in a south easterly direction along the last mentioned wall or fence to its junction with the north western wall or fence of Cut-throat Wood and continuing thence south eastwards in a straight line across the said wood for a distance of 6½ chains or thereabouts to the north eastern end of the eastern wall or fence of the said wood and extending thence southwards along the last mentioned wall or fence to its junction with London Road and continuing thence southwards to a point in the middle of the last mentioned road and extending thence eastwards along the middle of that road to its junction with the boundary which divides the said parish of Wooburn from the said parish of Beaconsfield."

And whereas the provisions of the New Parishes Measure, 1943, relating to the preparation and submission of this Scheme have been duly complied with.

And whereas the said Scheme has been approved by His Majesty in Council.

Now, therefore, His Majesty by and with the advice of His said Council is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately upon the publication of this Order in the London Gazette pursuant to the said Measure.

WHEREAS the Ecclesiastical Commissioners for England have duly prepared and laid before His Majesty in Council a Scheme bearing date the 21st day of November 1946 in the words and figures following, that is to say:—

" We, the Ecclesiastical Commissioners for England, have prepared and now lay before Your Majesty in Council the following Scheme pursuant to the Ecclesiastical Houses of Residence Act 1842 and the Episcopal Endowments and Stipends Measure, 1943, for authorising us, the said Ecclesiastical Commissioners, to sell and dispose of the episcopal residence belonging to the bishopric of Newcastle and for vesting in us all the endowments and other property belonging to, or held in trust for, the said bishopric or the bishop thereof and for securing to the bishop for the time being of the said bishopric an appropriate stipend:

" Whereas the Right Reverend Noel, Bishop of Newcastle, was in occupation of the See at the date of the passing of the aforesaid Measure and has requested us, the said Ecclesiastical Commissioners, to prepare a Scheme under the Measure with respect to the See:

" And whereas it has been represented to us by the said bishop and by the diocesan advisory committee constituted under the Faculty Jurisdiction Measure 1938 for the said diocese and we are of opinion that the house of residence known as Benwell Tower

belonging to the See is excessive in size and inconvenient for occupation by the bishop and the National Coal Board desires to acquire it for the purposes of a rescue service for the coal mines in the area:

"And whereas after consultation with the Diocesan Board of Finance of the Diocese of Newcastle we have prepared this Scheme and no objection has been offered thereto by the said Diocesan Board of Finance:

"And whereas the said Noel, Bishop of Newcastle, has approved the Scheme and in testimony of such approval has appended his signature hereto and sealed the same with his Episcopal Seal:

"And whereas the Right Honourable Clement Richard Attlee First Lord of Your Majesty's Treasury, acting on behalf of Your Majesty, has signified to us his consent to the preparation and submission of the Scheme to Your Majesty in Council:

"And whereas the endowments and property belonging to the See of Newcastle or held in trust therefor or for the Bishop thereof are described and referred to in the Schedule hereunder written:

"Now therefore, we, the said Ecclesiastical Commissioners, humbly recommend and propose that we be authorised to sell and convey the said residence known as Benwell Tower with the demesne thereto attached to the said National Coal Board or other the authority appropriate for the purposes recited at the price which we are advised represents the value thereof:

"And we further recommend and propose that upon and from the 1st day of January 1947 all the endowments securities and other property described and referred to in the said Schedule shall vest in us the said Ecclesiastical Commissioners pursuant to the said Measure and that we shall be entitled absolutely to the benefit rents and profit thereof upon and from that date.

"And we further recommend and propose that there shall be paid by us to the bishop for the time being of the said See until the date prescribed by such amending Scheme as is hereinafter mentioned a stipend calculated at the rate of £2,500 per annum, the said annual stipend to be payable by equal quarterly instalments in respect of the quarters ended on the 31st day of March, the 30th day of June, the 30th day of September and the 31st day of December in every year the first such instalment to be the full quarter's payment due for the quarter ended on the 31st day of March 1947 and to be supplemented by the addition of such sum, not exceeding £600 in any one year, as we shall have been duly satisfied has been expended by the bishop for the time being in connection with the travelling required in and for the carrying out of his official duties and obligations as bishop.

"Provided that so soon as we shall have provided a house of residence suitable in our opinion for occupation by the said bishop and his successors in the See as the permanent episcopal house of residence of the See as contemplated by the said Measure the said stipend may be reviewed in accordance with any amending scheme prepared by us and ratified by Your Majesty in Council pursuant to the said Measure.

#### " SCHEDULE.

##### " PART I.

"All that Episcopal residence known as Benwell Tower together with the Chapel Lodge buildings and outbuildings and the yards gardens pleasure grounds and other the appurtenances thereunto belonging situate in Benwell Lane Benwell in the City and County of Newcastle upon Tyne As the same premises are delineated on the plan annexed hereto and thereon verged red Together with a right of way for all purposes between the above-mentioned premises and the road known as Pendower Way over the strip of land shewn coloured blue on the said plan and together with the interest of the bishop in the piece of land and plantation shewn coloured green on the said plan under and by virtue of a lease thereof granted to us by the Lord Mayor Aldermen and Citizens of the City and County of Newcastle upon Tyne on the 24th day of December 1923 for a term of 99 years from the 11th day of November 1923 at the yearly rent of one peppercorn or if the said property shall have been sold prior to the said 1st day of January 1947 the interest of the said bishop in the net proceeds of the sale thereof.

##### " PART II.

"The annual payment of £3,856 charged upon our Common Fund by an Order of Your Majesty in

Council dated the 22nd day of March 1943 and duly published in the London Gazette on the 26th day of the same month.

#### " PART III.

"All those the pastoral staff, cope and mitre, communion plate, altar linen, altar and chapel furnishings, portraits, furniture and other goods and chattels belonging to the bishop in right of his dignity and not in his private capacity and described and set forth in an inventory to be deposited by us in the Diocesan Registry of the Diocese of Newcastle."

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately upon the publication of this Order in the London Gazette pursuant to the said Measure.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Newcastle.

This day, the Lords being met, a message was sent to the Honourable House of Commons, by the Gentleman Usher of the Black Rod, acquainting them that *The Lords, authorised by virtue of a Commission under the Great Seal, signed by His Majesty, for declaring His Royal Assent to the Acts agreed upon by both Houses, do desire the immediate attendance of the Honourable House in the House of Peers to hear the Commission read; and the Commons being come thither, the said Commission, empowering the Lord Archbishop of Canterbury, and several other Lords therein named, to declare and notify the Royal Assent to the said Acts, was read accordingly, and the Royal Assent given to:—*

Expiring Laws Continuance Act, 1946.

TEMPORARY (RECONSTRUCTION) REGULATIONS FOR FILLING VACANCIES IN THE GRADE OF INSPECTOR OF FACTORIES IN THE MINISTRY OF LABOUR AND NATIONAL SERVICE.

1. Both men and women may compete under these Regulations.

2. In order to be eligible, a candidate must have been born on or after the 2nd August, 1910, and have attained the age of 23 by the 1st January of the year in which he or she competes.

3. Every candidate must be either

(a) a natural-born British subject

(i) having at least one parent who is or was at the time of death a British subject; or

(ii) of any other parentage, provided that he or she has resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of his or her appointment; or

(b) a naturalized British subject who has resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of his or her appointment; or

(c) a British subject who, although not fulfilling the requirements of sub-paragraph (a) or sub-paragraph (b), satisfies the Commissioners that he or she is so closely connected with His Majesty's dominions either by ancestry, upbringing or residence, or by reason of national service, that an exception may properly be made in his or her favour.

4. (i) Candidates must satisfy the Civil Service Commissioners that they have such experience and have received such systematic education, general or technical, or general and technical together, as in the opinion of the Commissioners fits them for the post. In general, candidates should either have passed an examination qualifying for a University degree, or should possess an equivalent qualification in engineering, industry or science.

Provided that the Commissioners may at their discretion dispense with this requirement in the case



of a candidate who appears to them to be exceptionally well fitted by reason of suitable works or other special practical experience.

(2) (a) A person other than a candidate accepted under the proviso to Regulation 4 (1) who has not spent at an institution of University rank at least the necessary period for a war-time degree but is prepared to do so as soon as practicable, may submit a provisional application (thereby becoming a "provisional applicant") and may be accepted by the Commissioners as such if they are satisfied that his or her education has been such as to justify the expectation that he or she will obtain a degree on completion of the course.

(b) A provisional applicant will not become eligible to compete, and will not be required to pay an applicant's fee until he or she is able to fulfil the requirements of Regulation 4 (1).

5. Candidates must satisfy the Commissioners as to their health and character.

6. No person who is undergoing a course of study with the aid of a grant from public funds shall be eligible to compete under these Regulations before the completion of the course, unless he or she has previously obtained permission to do so from the authority which administers the grant.

7. Every candidate must apply on the appropriate form within the time and in the manner of which notice is given by the Commissioners.

8. Candidates who are recommended by the Ministry of Labour and National Service and are accepted by the Civil Service Commissioners as possessing the requisite qualifications will be summoned to an interview before a Selection Board, who will recommend to the Commissioners for appointment the candidates who appear to them to possess the highest qualifications. The Selection Board may also recommend that a certain number of candidates shall be classified as reserve candidates and considered by the Commissioners for appointment in conjunction with the results of a later Board. The decision of the Commissioners will be final. The Selection Board will take into consideration a candidate's record of experience and education, any recommendations they may receive from persons named by candidates as having direct knowledge of their work in the past, and the personal qualities of the candidates as shown at the interview; and on their estimation of the above evidence they will frame their decision.

9. Persons upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appropriate central education authority (e.g., the Ministry of Education, the Scottish Education Department, the Ministry of Education for Northern Ireland) has been notified to the Commissioners.

10. Candidates shall pay a fee of 10s. on application.

11.
