The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of His Majesty's Treasury, viz.:—

Temporary (Reconstruction) Regulations for filling Vacancies in the Grade of District Officer (Male) under the Forestry Com-MISSIONERS.

I. In order to be eligible, a candidate must have been born on or after the 2nd August, 1906, and have attained the age of 21 by the 1st January, 1946, provided that candidates born before 2nd August, 1906, may be admitted if they have specially suitable qualifications.

2. Every candidate must be either (a) a natural-born British subject

(i) having at least one parent who is or was at the time of death a British subject; or

(ii) of any other parentage, provided that he has resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least 5 years out of the last 8 years preceding the date of his appointment;

(b) a naturalized British subject who has resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least 5 years out of the last 8 years preceding the date of his appointment; or

(c) a British subject who, although not fulfilling the requirements of sub-paragraph (a) or sub-paragraph (b), satisfies the Commissioners that he is so closely connected with His Majesty's dominions either by ancestry, upbringing or residence, or by reason of national service, that an exception may properly be made in his favour.

3. Candidates for appointment as District Officers

(a) In the case of District (Forest) Officers—an examination qualifying for either a University degree in Forestry, a University Diploma in Forestry or a post-graduate degree in a Forestry subject: subject;

(b) In the case of District (Estate) Officers—
(i) the qualifying examination for the fellowship of the Royal Institute of Chartered Surveyors, or of the Royal Institute of Chartered Surveyors, or (ii) the qualifying examination for the fellowship of the Auctioneers and Estate Agents' Institute, or (iii) the qualifying examination for the fellowship of the Land Agents' Society, or (iv) one of the degree examinations, for example those in Estate Management of Cambridge and London, which secure exemption from the qualifying examinations in (i), (ii) and (iii) above: provided that these requirements may be waived in the case that these requirements may be waived in the case of a candidate who has attained a satisfactory standard of general education and has had suit-able practical experience in the office of a Sur-veyor, Estate Agent or Land Agent.

4. Candidates must satisfy the Commissioners as their health and character.

The Commissioners reserve the right to give such preference to disabled persons or particular classes of disabled persons as may be necessary in order to give effect to any general policy regarding the employment of such persons which may be adopted by His Majesty's Government, provided that the disability is not of a nature to interfere with the discharge of the duties of the post.

No person who is undergoing a course of study

- 5. No person who is undergoing a course of study with the aid of a grant from public funds shall be eligible to compete under these Regulations before the completion of the course, unless he has previously obtained permission to do so from the authority which administers the grant.
- Every candidate must apply on the appro-priate form within the time and in the manner of which notice is given by the Commissioners.
- 7. Those candidates who appear to have the most suitable qualifications may be summoned to a pre-liminary informal interview and will be summoned to an Interview before a Selection Board, who will recommend to the Civil Service Commissioners for appointment (subject to the terms of Regulation 8) the candidates who appear to them to possess the highest qualifications. The Selection Board may also recommend that a certain number of candidates shall be classified as reserve candidates and considered by the Commissioners for appointment in conjunction with the results of a later Board. The decision of the Commissioners will be final. The Selection Board will take into consideration a candidate's record of experience and education, any recommendations that they may receive from persons named by candidates as having direct knowledge of their work in the past, and the personal qualities of the candidates as shown at the interview; and on their estimation of the above evidence they will frame their decision.
- 8. It is the intention that of the total number of vacancies to be filled from the whole series of Selection Boards Service candidates shall receive not less than two-thirds; provided that a sufficient number of Service candidates reach the required standard.
- 9. For the purposes of these Regulations candidates shall be regarded as Service candidates if they have rendered whole-time service during any period after the 25th May, 1939, in

 (a) the Armed Forces of the Crown; or

(b) the Mercantile Marine or the Merchant Navy.

- ro. Persons upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appropriate central education authority (e.g. the Ministry of Education, the Scottish Education Department, the Ministry of Education for Northern Ireland) has been notified to the Commissioners.
- 11. Every successful candidate will be required to pay a fee of it before the issue of a certificate of qualification for appointment.
- 12. Any attempt on the part of candidates to enlist support for their applications through Members of Parliament or other influential persons, except as referees to be named by them in their application form, will disqualify them for appointment. The Selection Board will disregard recommendations from persons who are not personally acquainted with the candidate's work, whether at school in the Forces or otherwise. school, in the Forces or otherwise.

 - (b) If naturalized British subjects, they must have resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.
 - (c) If not qualified under (a) or (b) of this paragraph they must satisfy the Commissioners that they are so closely connected with His Majesty's dominions either by ancestry, upbringing or resi-dence, or by reason of national service, that an exception may properly be made in their favour.

CAUTION · WHEN APPROACHING BRITISH PORTS.

PART I.

Closing of Ports.

Former Notice.—No. 1 of 1946; hereby cancelled.

- (1) My Lords Commissioners of the Admiralty, having taken into consideration the fact that it may having taken into consideration the fact that it may be necessary to forbid all entrance to certain ports of the Empire, this is to give Notice that on approaching the shores of the British Isles, or any of the ports or localities of the British Empire, a sharp look-out should be kept for the signals described in the following paragraph and for the vessels menthe following paragraph, and for the vessels mentioned in paragraph (5), Part II, of this Notice, and the distinguishing and other signals made by them. In the event of such signals being displayed, the port or locality should be approached with great caution, as it may be apprehended that obstructions may exist.
- (2) if entrance to a port is prohibited, three red lights vertically disposed by night, or three red balls vertically disposed by day, will be exhibited in some conspicuous position, in or near to its approach, which signals will also be shown by the vessels indicated in paragraph (5), Part II, of this Notice.
- If these signals are displayed, vessels must approach the port with the greatest caution and implicitly obey all orders or signals given them by the Examination Vessel; Traffic Control Vessel, or signal station.
- (3) At some ports or localities at home or abroad, search-lights are occasionally exhibited for exercise.

Instructions have been given to avoid directing movable search-lights during practice on to vessels under way, but mariners are warned that great care should be taken to keep a sharp look-out for the signals indicated in paragraph (2) above, when search-lights are observed to be working.

Vessels are particularly warned not to enter a dclared "Dangerous Area" or approach boom defences without permission, nor to anchor or remain stopped in a dangerous area or prohibited anchorage unless specially instructed so to do.

PART II.

Examination Service.

- (4) In certain circumstances it is also necessary to take special measures to examine individual vessels desiring to enter ports and localities at home and abroad and to control entry generally. This is the function of the Examination Service. Where Traffic Control Vessels take the place of Examination Vessels their authority is the same.
- (5) In such case, vessels carrying the distinguishing (5) In such case, vesses carrying the distinguishing flags or lights mentioned in paragraph (7) will be changed with the duty of examining ships which desire to enter the port and of allotting positions in which they shall anchor. If Government vessels, or vessels belonging to the local port authority, are found patrolling in the offing, merchant vessels are advised to communicate with such vessels with a view to obtaining information as to the course a view to obtaining information as to the course on which they should approach the port. Such communication will not be necessary in cases where the pilot on board has already received this information from the local authorities.
- (6) As the institution of the Examination Service (6) As the institution of the Examination Service will probably be unknown to vessels desiring to enter the port, especial care should be taken in approaching the ports, by day or night, to keep a sharp look-out for any vessel carrying the flags or lights mentioned in paragraph (7), and to be ready to "bring to" at once when hailed by her or warned by the firing of a grup as sound replace.



In approaching by night any port in the British Empire, serious delay and risk will be avoided if four efficient all round lanterns, two red and two

white, are kept available for use.

(7) By day the distinguishing flag of the Examination Vessel or Traffic Control Vessel will be a special flag (white and red horizontal surrounded by a blue border).

 Also, three red balls vertically disposed if entrance is prohibited.



Usually the Examination Vessels or Traffic Control Vessels will fly the Blue Ensign, but in certain circumstances they may fly the White Ensign.

By night the steamer will carry:-

(a) Three red lights vertically disposed if

entrance is prohibited.

(b) Three white lights vertically disposed if entrance is permitted.

The above lights will be carried in addition to the ordinary navigation lights, and will show an unbroken light around the horizon.

- (8) Merchant vessels approaching a British Port at which the Examination Service is in force, must hoist their signal letters on arriving within visual signal distance of the port, and are not to wait for the signal "What is the name of your vessel?" to be made from the Examination Vessel.
- (9) Masters are warned that, before attempting to enter any port when the Examination Service is

enter any port when the Examination Service is in force, they must in their own interests strictly obey all instructions given to them by the Examination Vessel or Traffic Control Vessel.

Whilst at anchor in the Examination Anchorage, Masters are warned that it is forbidden, except for the purpose of avoiding accident, to do any of the following things, without permission from the Examining Officer:—

To lower any boat

To lower any boat.

To communicate with the shore or with other ships.
To move the ship.

To work cables. To allow any person or thing to leave the ship.

- (10) In case of fog, Masters are enjoined to use the utmost care, and the port should be approached with caution.
- (11) When the Examination Service is in force merchant vessels when approaching ports are especially cautioned against making use of private signals of any description, either by day or night; the use of them will render a vessel liable to be fired
- (12) The pilots attached to the ports will be acquainted with the regulations to be followed.

PART III.

Mine-Sweeping Operations.

(r) H.M. Vessels, operating singly or in formation, engaged in mine-sweeping operations or exercises are hampered to a considerable extent in their manœuvring powers.

Such vessels will show the signals hereinafter men-

Such vessels will show the signals hereinarter mentioned to indicate the nature of the work on which they are employed at the time:—

By day.—A black ball at the foremast head and a black ball at the yardarm on the side, or sides, on which it is dangerous for vessels to pass.

By night.—All round green lights instead of the black balls, and in a similar manner.

CAUTION.—When circumstances permit, vessels or formations showing these signals should not be approached nearer than 500 yards on either beam, and ships should in no case cross astern at a less distance than 1,000 yards.

In no circumstances should a ship pass through a formation of mine-sweepers.

(2) Conduct of Vessels in the vicinity of Mine-sweepers engaged in sweeping.

(i) It is the duty of any vessel—whether steam or sailing—to take early action to keep out of the way of vessels employed in mine-sweeping.

(ii) Mine-sweepers should warn merchant vessels who persist in approaching too close by means of the International Code of Signals.

PART IV.

Other Regulations in force.

Nothing in this Notice is to be taken as over-ruling such general or local regulations as may be issued by the Public Traffic Regulations at each port, through routeing authorities, by Notices to Mariners or other means to meet new dangers or situations which may arise, or to cover local conditions.

- No. 7. Caution with regard to Single Ships Approaching Squadrons or Aircraft Carriers. Former Notice.—No. 7 of 1946; hereby cancelled.
- (1) The attention of shipowners and mariners is called to the danger to all concerned which is caused by single vessels approaching a squadron of warships or merchant vessels in convoy so closely as to involve risk of collision or attempting to pass ahead of or through such a squadron or convoy.
- (2) Mariners are therefore warned that single vessels should adopt early measures to keep out of the way of a squadron or convoy.
- (3) The fact that it is the duty of a single vessel to keep out of the way of a squadron or convoy does not entitle vessels so sailing in company to proceed without regard to the movements of the single vessel. Vessels sailing in a squadron or convoy should accordingly keep a careful watch on the movements of any

single vessel approaching the squadron or convoy and should be ready, in case the single vessel does not keep out of the way, to take such action as will best aid to avert collision.

(4) Attention is also drawn to the uncertainty of the movements of aircraft carriers, which must usually turn into the wind when aircraft are taking off or landing.

1. Attention is drawn to the following warning signal which is in use to denote the presence of Submarines:

British vessels fly a rectangular red flag to denote that Submarines, which may be submerged, are in the vicinity. Vessels are cautioned to steer so as to give a wide berth to any vessel flying such a flag. If from any cause it is necessary to approach her, vessels should proceed at slow speed until warning is given of the danger zone by flags, semaphore or megaphone, etc., a good look-out being kept meanwhile for Submarines whose presence may be only indicated by their periscopes

showing above water.

A Submarine submerged at a depth too great to show her periscope may sometimes indicate her position by releasing a "smoke candle" which gives off a considerable volume of smoke on first

reaching the surface.

- 2. Under certain circumstances warnings that Submarines are exercising in specified areas may be broadcast by a General Post Office W/T station.
- 3. It must not be inferred from the above that Submarines exercise only when in company with escorting vessels.

BYELAWS WITH REGARD TO HOUSEBOATS MADE UNDER THE PORT OF LONDON ACT, 1935, AND THE CITY OF LONDON (VARIOUS POWERS) ACT, 1933, BY THE PORT OF LONDON AUTHORITY AND BY THE MAYOR AND COMMONALTY AND CITIZENS OF THE CITY OF LONDON.

1. These byelaws may be cited as "The Port of London Houseboat Byelaws 1946" and shall come into operation on the day after the same are confirmed by the Minister of Health.

2. In these byelaws the words and expressions hereinafter mentioned shall have the meanings hereby assigned to them respectively unless there be something in the subject or context repugnant to such construction, viz:-

The expression "Port Health Authority" means the Mayor and Commonalty and Citizens of the

City of London.

The expression "district of the Port Health Authority" means the Customs Port of London as described in the Treasury Minute dated August

The expression "Port Authority" means the Port of London Authority.

The expression "the Port of London" means the Port of London within the limits described in the First Schedule to the Port of London (Consolidation) Act, 1920, as amended by Section 22 of the Port of London (Various Powers) Act, 1932.

The expression "Registration Authority" means

in respect of Houseboats the Port Authority

moored within the Port of London, and the Port Health Authority in respect of Houseboats moored in such parts of the district of the Port Health Authority as are beyond the limits of the Port of London.

The expression "infectious disease" includes smallpox, chickenpox, measles, scarlet fever, diphtheria, membranous croup, erysipelas, typhus fever, typhoid fever, para-typhoid fever, enteric fever, continued fever, relapsing fever, purperail fever, cerebro-spinal fever, acute poliomyelitis, acute polioencephalitis encephalitis letherain polioencephalitis, encephalitis lethargica, acute influenzal and acute primary pneumonia, tuberculosis (all forms), ophthalmia neonatorum, malaria, plague, cholera, dysentery and yellow

The expression "Medical Officer of Health" means the Medical Officer for the district of the Port Health Authority or any legally qualified medical practitioner authorised to act on behalf of such Officer.

The word "owner" in relation to any house-best means the parson for the time being receiving

the word owner in relation to any house-boat means the person for the time being receiving the rent of the houseboat or who would so receive the same if such houseboat were let. The word "occupier" in relation to any house-boat means the person who for the time being has

the charge, management or control of such house-

For Requiring the Registration of Houseboats.

The Owner of a houseboat which is lying within the Port of London or within the District of the Port Health Authority at the date of the confirmation of these byelaws shall, within a period of three calendar

months therefrom, make application to three calendar months therefrom, make application to the Registration Authority for the registration of the same in the manner prescribed in byelaw No. 4.

The owner of a houseboat which is lying within the Port of London or within the District of the Port Health Authority at the date of the confirmation of these byelaws shall not, after the

expiration of fourteen days from the termination of such period of three calendar months, use or permit to be used such houseboat within the Port of London or within the District of the Port Health Authority, unless and until such houseboat has been registered by the Registration Authority.

The owner of a houseboat which is brought into the Port of London or the District of the Port Health Authority from elsewhere after the confirmation of these byelaws shall forthwith make application to the Registration Authority for the registration of the same, in the manner prescribed by byelaw No. 4, and shall not after the expiration of one calendar month from the date when such houseboat is brought into the Port of London or the District of the Port Health Authority as aforesaid use or permit to be used such houseboat within said use or permit to be used such houseboat within the Port of London or within the District of the Port Health Authority unless and until such houseboat has been registered by the Registration Authority.

The owner of any vessel or boat (other than a houseboat) which is within the Port of London or the District of the Port Health Authority and who intends to convert the same into a houseboat and the owner of any newly constructed houseboat within the said Port or District after the confirmation of these byelaws shall make application to the Registration Authority for the registration of the same in the manner prescribed by byelaw No. 4 and shall not use or permit to be used such vessel, boat or houseboat as a houseboat within the Port of London or within the District of the Port Health Authority unless and until such vessel or boat has been registered as a houseboat by the Registration Authority.

For Regulating the Making of Applications for Registration.

- 4. The owner of a houseboat shall make application for registration of the same on a form to be obtained from the Registration Authority, and shall enter upon such form:—

 - (i) The name and address of the owner.(ii) The name and description of the houseboat. the material of its construction and its principal dimensions.
 - (iii) The name and address of the occupier. (iv) The situation in which the houseboat is to be moored.
 - (v) Whether the houseboat will be afloat at all
 - (v) whether the houseboat will be affoat at all or any states of the tide.

 (vi) The means of communication with the shore.

 (vii) The number of occupants.

 (viii) The number of living and sleeping rooms respectively with the cubic capacity of each.

 (ix) The number and nature of other compartments
 - ments.
 - (x) The type of sanitary convenience.
 (xi) The nature of the provision for light
 (natural and artificial).
 - (xii) The means of ventilation of each compart-
 - (xiii) The arrangements for cooking.
 (xiv) The arrangements for the supply of fresh water.
 - (xv) The method of disposal of sewage and other refuse.
- and shall sign a declaration thereon that the particulars contained therein are correct to the best of his knowledge and belief.
- 5. On receipt of the form of application signed by the owner and on being satisfied by means of a certi-ficate signed by the Medical Officer of Health that the houseboat in respect of which the application is made complies with byelaws Nos. 11, 12, 13 and 14 hereunder, and that the name of the houseboat is not the same as or similar to that of any other houseboat already registered, the Registration Authority shall register the houseboat and issue a certificate of registration to the owner, which the owner shall cause to be retained in legible condition on board the houseboat and to be available at any resconable the houseboat and to be available at any reasonable time for inspection by an authorised officer of the Port Authority or the Port Health Authority and the name and the registered number of the houseboat shall be painted white on a black ground, in capital letters, not less than 3 inches long and proportionately broad, and figures not less than 6 inches long and proportionately broad, on each side of the houseboat.
- 6. The owner of a registered houseboat shall give notice in writing to the Registration Authority of

every transfer, sale or change of tenancy of such

houseboat within fourteen days thereof.

7. The certificate of registration of a houseboat shall remain in force until the 31st day of December of the year in which it is issued. The owner of a houseboat shall apply to the Registration Authority for renewal of the certificate of Registration of the same on or before the 1st day of November in each

8. The owner of a houseboat shall pay to the Registration Authority a sum of ten shillings for a certificate of Registration or renewal of Registration and an additional sum of one shilling for each

duplicate thereof.

Provided that in the case of a certificate of Registration issued after the 1st day of June in any year a sum of five shillings only shall be payable.

For Prohibiting the Mooring of Houseboats except at Places Specified.

g. The owner or occupier of a houseboat shall not

Provided also that vessels used as club premises may use such moorings or facilities as shall be from time to time licensed for that purpose by the Port Authority, and that any vessel of the Port Health Authority used as a boarding station may use such place in the River Thames off Gravesend as is from time to time occupied by it as a meeting also time to time occupied by it as a mooring place.

For prescribing the maximum number of occupants of any Houseboat.

ro. The occupier of a houseboat shall not knowingly permit any room wholly or partly used as a sleeping apartment to be occupied at any one time by steeping apartment to be occupied at any one time by a greater number of persons than will allow 300 cubic feet of free air space for each person over 10 years of age and 240 cubic feet of free air space for each person under 10 years of age, provided that if in any room any part is less than 5 feet 6 inches in height, such part shall not be included in the cubic space specified above.

For requiring adequate means for the admission of Daylight.

rr. The owner of a houseboat shall provide in every living and sleeping room thereof adequate means for the admission of daylight by a window or windows opening directly into the external air and having a total area exclusive of frames equal at least to one-tenth of the floor area in such room, provided that a properly constructed skylight or deck-light opening directly into the external air and having the minimum dimensions required in the case of a window or windows may be provided in lieu of a window or windows when these are impracticable. Provided also that where there are windows situated

on opposite sides of a room the total area exclusive of frames shall be at least one-fifteenth of the floor area.

For requiring the provision of adequate means of Permanent Ventilation.

12. The owner of a houseboat shall, for the ventilation of each living-room and sleeping-room in which there is not a chimney opening provide adequate means of permanent ventilation by means of an opening for the outlet and inlet of air of an area not less than 36 square inches.

Conveniences and Appliances.

13. The owner of a houseboat shall provide for use therein a sanitary convenience of impervious and durable material and of such size and shape as to permit of its being easily removed and cleansed, and a separate compartment in or on the houseboat, ventilated directly into the open air and not communicating directly with any other compartment, in which to keep the said sanitary convenience. - 16. The occupier of a houseboat shall empty and clean the bilges thereof and shall cause the internal surfaces and the floor thereof to be thoroughly cleansed as often as may be necessary for keeping the same in a cleanly condition.
- 17. The owner of a houseboat shall cause the same to be maintained so that it shall be reasonably weather-proof at all times.

For preventing the spread of infectious disease by persons inhabiting Houseboats.

20. The occupier of a houseboat who has been informed or has otherwise ascertained or has reason to suspect that any inmate thereof is suffering from an infectious disease, shall forthwith notify the Medical Officer of Health of the name and address of the person so suffering and the nature of the illness

of the person so suffering and the nature of the illness and shall adopt all such reasonable precautions for the preventing of the spread of the disease as the Medical Officer of Health may order.

21. The occupier of a houseboat in which there is any person suffering from an infectious disease or which has not been properly disinfected subsequent to the removal or recovery of any person who has been suffering from an infectious disease on board shall:

(d) when moving such houseboat, comply with such reasonable conditions as the Medical Officer of Health may impose for the purpose of preventing the spread of infection.

(e) not move such houseboat out of the District of the Port Health Authority until the same has been properly disinfected.

- 22. In every case where, in pursuance of any statutory provision in that behalf, an order of a Justice has been obtained for the removal from a houseboat to a hospital or other place for the reception of the sick of a person who is suffering from any dangerous infectious disorder, the occupier of such houseboat, on being informed of such order shall, in and about such removal, adopt all such precautions as the Medical Officer of Health may prescribe.

The occupier of a houseboat shall immediately after a person suffering from an infectious disease has been removed thereform, or has died therein, or has recovered from such disease whilst being therein, give notice of such removal, death or recovery to the Medical Officer of Health. The occupier shall cause all bedding, clothing or other articles therein which may be liable to retain infection, other than such as shall have been ordered to be destroyed or shall have been required to be removed for the purpose of disinfection, to be in like manner cleansed and disinfected, and shall comply with all reasonable instructions of tion, to be in like manner cleansed and disinfected, and shall comply with all reasonable instructions of the Medical Officer of Health as to such cleansing and disinfection. When the houseboat and every such article as aforesaid shall have been thoroughly cleansed and disinfected, the occupier shall give notice thereof to the Medical Officer of Health. Provided that if for any reason beyond his control the occupier has been unable to comply with any of the provisions of this byelaw it shall be the duty of the owner, on becoming aware of the fact, to comply with such provisions. ing aware of the fact, to comply with such provisions.
- 24. Neither the owner nor the occupier of a houseboat in which any person has to his knowledge been suffering from an infectious disease shall cause or suffer any person newly to occupy or to become an inmate of such houseboat, unless the provisions of the last preceding byelaw have been complied with.

Generally for the prevention of nuisances in connection with Houseboats.

- 25. The occupier of a houseboat shall not deposit or cause to be deposited any faecal matter or any urine or any solid or liquid refuse of any sort whatever on the foreshore and shall not deposit or cause to be deposited such matter, urine or refuse in any other place so as to cause a nuisance.
- 26. The occupier of a houseboat shall not keep any animal on board in such a manner as to render the houseboat filthy or unwholesome.

For authorising the inspection of registered House-boats by or on behalf of the Port Health Authority.

- 27. A person residing in a houseboat shall at all reasonable times when required by the Medical Officer of Health or a Sanitary Inspector of the Port Health Authority afford such officer free access to the interior of such houseboat and any room or compartment
- 28. A duly authorised officer of the Port Authority or the Port Health Authority shall at all reasonable or the Port Health Authority shall at all reasonable times have the right to enter and inspect a registered houseboat, for the purpose of ascertaining whether the provisions of these byelaws are being complied with, and the owner and occupier thereof shall afford all reasonable facilities and assistance to such officer to carry out such inspection.

Penalties.

29. Every person who shall offend against any of the foregoing byelaws shall be liable for every such offence to a penalty of £5 and in the case of a continuing offence to a further penalty of 40/- for each day after written notice of the offence from the Port Authority or the Port Health Authority as the case

may be; Provided nevertheless that the Justices or Court before whom any complaint may be made or any proceedings may be taken in respect of any such offence may, if they think fit, adjudge the payment, as a penalty, of any sum less than the full amount of the penalty imposed by this byelaw.

30. These byelaws shall not apply to a training ship lying within the Port of London or within the District of the Port Health Authority at the date of the confirmation of these byelaws.
