Warsaw, March 4. N. S. The Cardinal Primate of Poland, and the Crown General, took their Leaves of the King this evening, in order to go to their Country Houses, and most of the Senators that are in Town are preparing to do the like. The Princes of the House of *Sapieha* have complained to the King, That notwithstanding the Agreement lately concluded with the Confederated Nobility of *Lithuania*, the said Nobility do still keep in Arms, and destroy the Houses and Estates of those who are in the Interests of Prince *Sapieha*; And according to the last Accounts from *Lithuania*, Prince *Wisnowsky* had got together near *Grodno* a considerable Body of the Confederated Nobility, and expected a Reinforcement of *Muscovites* under the Command of the *Sieur Oginsky*, who upon the Defeat he received some time ago from the *Swedes*, retired to *Muscovy* to desire the *Czar's* Assistance. The King of *Sweden* continues to march this way with his Army; but 'tis said he intends to stop upon the Frontiers, to receive the Ambassadors who are sent to him on the part of the Republick, to see if Matters can be brought to an Accommodation.

Vienne, March 8. The Emperor declared yesterday the King of the *Romans* Generalissimo of his Forces on the *Rhine*, and that Prince *Lewis* of *Baden* should command under him. Several Regiments of Horse and Foot, which are to be employed in that Service, are marching thither from the Emperor's Hereditary Countries, and the other necessary Preparations are made with all possible diligence for an early Campaign. Divers *German* Officers are come hither from *Italy* to raise Recruits for their Regiments; The Forces lately ordered from *Hungary* to reinforce the Imperial Army in *Italy* have left their Quarters, and are marching thither with all expedition. The 6. Regiments of *Hussars* lately ordered to be raised are very near completed, and 'tis said 5 of them will march to the *Rhine*, and the other to *Italy*. It is reported, that Orders will shortly be given for demolishing the Fortifications of *Alia Regalis, Agria, Caislaw*, and some other Places in *Hungary*, that the Forces which are in Garrison there may be more usefully employed. They write from *Italy*, that our Forces there have received considerable Supplies of Provisions from the Countries of *Friuli* and *Croatia*, and that a great quantity of Corn and Hay is bought up for their use in the Pope's Territories.

Frankfort, March 15. The Deputies of the Circles of *Frankonia, Swabia*, and the *Upper Rhine*, are met at *Norlingen* to consult together about making Provision for their Common Safety and Defence. Prince *Lewis* of *Baden* has lately been to view the new Lines near *Spire*, and the Fortifications of *Germersheim*, near which last place 'tis said a considerable number of the Emperor's Forces will shortly be drawn together. The Imperial Troops which lay in the *Brisgau* are marching towards *Philipsburgh*; and the Forces of the Circles of *Swabia* and *Frankonia* have Orders to be in a readiness to march. Guards are posted all along the *Rhine*, and all possible care is taken to prevent the carrying of any Horses over to the *French*, who stand in great need thereof. The Marquis *d'Uxelles* is come from the *French* Court to *Strasbourg*, and has given Directions for making a Draught out of the several Garrisons in *Alsace*, in order to form a Camp near *Landau*.

Cologne, March 17. The 3 *Dutch* Regiments of Foot in Garrison here have Orders to be in a readiness to march; and 'tis said, the *Dutch* Regiment of Horse which is quartered at *Mulheim* is to come hither. A Party of the *Dutch* Troops have seized several Wagons laden with Sword-Blades which were going to *Antwerp*. The *French* Forces in the Bishopricks of *Cologne* and *Liege* make frequent Marches and Countermarches; they have lately reinforced the Garrisons of *Niuy, Keyserwaert*, and *Rhinberg*. The Bishop of *Raab* is still at *Dusseldorp*; the *French* have had a Design for some time to seize him as he passed between *Dusseldorp* and this City, but not being able to effect it, they found Means to corrupt several Persons here, who were to lay in wait for him near one of the City Gates, and having seized his Coach, designed to carry him out of Town, where the *Sieur la Croix*, a *French* Officer, was to be ready with a Body of *French* Horse to receive and carry him off; but this Design was timely discovered, and most of the Persons concerned therein are secured.

Hague, March 21. N. S. Yesterday the Forces of this State began their march from their respective Quarters according to the Orders they had received; The Foot and Horse-Guards that were quartered here, are marched to *Nimeguen*, where is to be the principal Camp; and the Design is thought to be to besiege *Keyserwaert*. The Lord *Cutts* intends to go from hence to morrow to the Camp at *Rosendaal*, where all the *English* Forces are to be the 23d Instant. Engineer General *Cockburn* is gone from hence to *Nimeguen*. The Allies are going to form a Camp likewise in the Duchy of *Cleves*. Marshal *Boufflers* has given Orders for drawing together the *French* Forces in the *Spanish Netherlands*, to observe the Movements of the Allies. Monsieur *Norf*, who resided here as Mi-

nister from the Elector of *Cologne* and from the Bishop of *Munster*, having received a Mandate from the Emperor, requiring him to quit the Elector's Service, has complied therewith, and notified the same to the States, declaring that for the future he desires to be looked upon no otherwise than as the Bishop of *Munster's* Resident. An Express arrived here with Advice, that the Emperor has declared the King of the *Romans* Generalissimo of all the Imperial Armies which are to act on the *Upper Rhine*.

St. James's, March 13. This evening was held by a Chapter of the Most Noble Order of the *Garter*, filling up the two vacant Stalls, where Her Majesty the Sovereign of the Order and 11 Knights Companion being present, his Grace *Wriothesley* Duke of *Beaufort*, and the Rt. Hon. *John* Earl of *Marlborough*, were admitted into the said Order, after having been successively introduced into the Chapter, and Knighted by the Sovereign with the Sword of State, and thereupon were severally Invested with the *Garter* and *George*, the two Principal Ensigns of the said Order, with the usual Ceremonies.

St. James's, March 14. The Queen has been pleased to appoint the Rt. Hon. the Earl of *Marlborough* to be Captain-General of all Her Majesty's Forces in *England*, or which are employed abroad in conjunction with the Troops of Her Majesty's Allies. And Her Majesty has thought fit to dispatch his Lordship to *Holland* with the Character of Her Ambassador Extraordinary and Plenipotentiary to the States General of the United Provinces.
