WATER ACT, 1945.

Notice is hereby given that the Minister of Health is about to make an order under section 9 (2) of the Water Act, 1945, providing for the compulsory transfer to the North Lindsey Water Board and to

the Urban District Council of Barton-upon-Humber of the Barton undertaking of the North East Lincolnshire Water Company.

LAND DRAINAGE ACT, 1930.

Rivers Birket and Fender Catchment Area.

Notice is hereby given that the Minister of Agriculture and Fisheries has made an Order under the Land Drainage Act, 1930, confirming the Order made on the 20th day of March, 1947, adding to Part I of the First Schedule to the Act the area the drainage of which is directed to the Rivers Birket and Fender which Order has now come into force.

Copies of the Order may be seen at all reasonable hours at the Offices of the Ministry of Agriculture and Fisheries, 23-25, Soho Square, London, W.1, and at the Offices of the Engineer to the Chester Town Council, 54, Hough Green, Chester, the Town Hall, Wallasey and the Town Hall, Birkenhead.

By part III of the Second Schedule to the said Act, it is provided that if any person aggrieved by an Order desires to question its validity on the ground that it is not within the powers of the Act or that any requirement of the Act has not been complied with, he may, within six weeks after the publication of this notice, make an application for the purpose to the High Court, and if any such application is duly made the Court, if satisfied that the Order is not within the powers of the Act, or that the interests of the applicant have been substantially prejudiced by any requirements of the Act not having been complied with, may quash the Order either generally or in so far as it affects the applicant.

LAND DRAINAGE ACT, 1930.

*River Great Ouse Catchment Board.**Hundred Foot Washes Internal Drainage District.*

Notice is hereby given that the Minister of Agriculture and Fisheries has made an Order under the Land Drainage Act, 1930, confirming a Scheme submitted to him by the River Great Ouse Catchment Board, under Section 4 (1) (b) of that Act, making provision for the following matters:—
