Objections made to the Draft Order.

That workers employed in the assembly, installation, maintenance, alteration or repair of electrical appliances and apparatus of all kinds and in the supply of such appliances when sold in pursuance of contracts of work, labour and materials, should be excluded from the scope of the Wages Council.

That workers employed by local authorities, and by non-municipal gas and electricity undertakings, in the retail sale of gas and electrical appliances and apparatus should be excluded from the scope of the Wages Council.

That workers employed by gas and electricity undertakings should be excluded from the scope of the Wages Council.

That technical staff employed by authorised and are the council.

That technical staff employed by authorised undertakers in the electricity supply industry should be excluded from the scope of the Wages Council.

That workers employed in Scotland in the retail sale of radio and television apparatus should be excluded from the scope of the Wages Council, and that a separate Wages Council should be established for such workers.

That workers employed on the repair or renovation of furniture (including mattresses), the making up, planning or laying of carpets, linoleum and similar floor coverings, or the measuring, cutting, sewing, making up and fixing of blinds, curtains, pelmets and loose covers should be excluded from the scope of the Wages Council.

That workers engaged in the retail sale of um-

That workers engaged in the retail sale of umbrellas, sunshades, walking sticks, canes and similar articles, and ladies' handbags, should be brought within scope of the Wages Council.
