PRESENT.

The KING's Most Excellent Majesty in Council.

HIS MAJESTY, in pursuance of section one of the Aliens Restriction Act, 1914, as amended by any subsequent enactment, and of all other powers enabling Him in that behalf, is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered as follows:—

1. The following amendments shall be made in the Aliens Order, 1920 (S.R. & O. 1920 (No. 448) I, p. 138), as amended by any subsequent Order (hereinafter referred to as "the principal Order"):

(a) Article 6 (see S.R. & O. 1939 (No. 994) I, p. 121) (which relates to the registration of aliens, not being enemy aliens) shall have effect as if in paragraphs (1) and (2) thereof the words "not being an enemy alien" were omitted;

(b) Article 6A (see S.R. & O. 1939 (No. 994) I, p. 121 and 1944 (No. 1315) I, p. 11) (which relates to the registration of enemy aliens) shall cease to have effect;

(c) Article 6B (see S.R. & O. 1939 (No. 994) I, p. 121) (which exempts seamen from the provisions of Articles 6 and 6A) shall have effect as if for the words "the last two preceding Articles" there were substituted the words "Article 6 of this Order";

(d) Article 9A (see S.R. & O. 1939 (No. 994) I, p. 121 and 1940 (No. 890) I, p. 33) (which restricts the possession of certain articles by enemy aliens) shall cease to have effect;

(e) paragraph (5A) of Article 18 (see S.R. & O. 1940 (No. 890) I, p. 33) (which provides for the forfeiture of articles in the unlawful possession of enemy aliens) shall cease to have effect;

(f) Article 19A (see S.R. & O. 1940 (No. 890) I, p. 33) (which relates to the entry and search of premises for the purpose of seizing certain articles) shall cease to have effect;

(g) in paragraph (2) of Article 20 (see S.R. & O. 1939 (No. 994) I, p. 121) (which relates to interpretation) the definition of the expression "enemy alien" shall cease to have effect;

2.—(1) This Order may be cited as the Aliens Order, 1947, and shall come into operation forthwith.

(2) The Interpretation Act, 1889, shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

(3) Anything done for the purposes of paragraph (1) or (4) of Article 6A of the principal Order before the coming into operation of this Order shall have effect after the coming into operation of this Order as if done for the purposes of paragraph (1) or (2), as the case may be, of Article 6 of the principal Order.

EXPLANATORY NOTE.

(This Note is not part of the Order, but is intended to indicate its general purport.)

This Order removes from the Aliens Order the distinction, established for the purposes of the war,

between enemy aliens and other aliens. Article 6A of the Aliens Order, which imposed requirements as to the registration of enemy aliens, and Article 9A, which restricted enemy aliens from possessing certain articles, are revoked, and some consequential changes are also made.

Registration of aliens will, after the amending Order comes into operation, be effected under Article 6 of the Aliens Order, while enemy aliens registered under Article 6A will be treated as registered under Article 6 and will not automatically have to re-register.

A limited number of tickets will be available for relatives and friends of Members of both Houses of Parliament who desire to witness the procession in the Royal Gallery. Applications by Peers for these tickets should reach this Office by October 4th. Members of the House of Commons should, however, submit their applications to the Secretary to the Speaker by October 4th.

Parking facilities will be provided for the Opening of Parliament. All those who desire to take advantage of this arrangement are requested to submit an application for a car ticket with their request for seats to enable them to park their cars at the respective entrances shown thereon. Peers attending by car, unaccompanied by Peers or guests, should also obtain a car ticket from this Office.

The doors will be opened at 9.30 a.m. and close at 10.30 a.m.

The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of His Majesty's Treasury viz.:—

REGULATIONS RESPECTING OPEN COMPETITIVE EXAMINATIONS FOR THE SITUATION OF PLANS ASSISTANT IN H.M. LAND REGISTRY.

1. Age.

Candidates must be at least 16 and under 17 years of age on the governing date, but candidates who have served in any established post to which they were admitted with the Certificate of the Civil Service Commissioners may deduct from their actual age any time not exceeding two years which they may have spent on such service before the governing date.

2. Sex.

Both boys and girls are eligible.

3. Nationality.

Candidates must be British subjects. They must also satisfy one of the following conditions:—

(a) If natural-born British subjects, they must either

- (i) have at least one parent who is or was at death a British subject; or
- (ii) have resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.

(b) If naturalised British subjects, they must have resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.

(c) If not qualified under (a) or (b) of this paragraph they must satisfy the Commissioners that they are so closely connected with His Majesty's dominions either by ancestry, upbringing or residence, or by reason of national service, that an exception may be properly made in their favour.

4. Health and Character.

Successful candidates must satisfy the Civil Service Commissioners as to their health and character.

5. Examination.

The subjects of examination and marks they will carry are as follows:—

(1) English	200
(2) Arithmetic	100
(3) Mathematics	200
(4) Drawing	200

Candidates will be arranged in order of merit on their aggregate of marks in the examination as a whole. Even if there are unfilled vacancies, no candidate will be appointed who does not obtain such an aggregate as to satisfy the Civil Service Commissioners.

6. Fee.

A fee of 5s. is payable by all candidates. This must be sent with the application form, and is not returnable in any circumstances.

These Regulations apply to the examination of January, 1948. For subsequent examinations the regulations will be similar, except for governing date for age in Regulation 1. For an examination held in the first six months of any year the governing

date will be the 1st March in that year; for an examination held in the last six months of any year it will be the 1st September in that year.

The Civil Service Commissioners further give notice that an open competitive examination under the above regulations will be held on 20th January, 1948, and following days. The governing date for age will be 1st March, 1948. ROAD TRAFFIC ACT, 1930, SECTION 46 (3).

COUNTY OF DEVON.
