## EXPLANATORY NOTE.

These Regulations deal with four main subjects, namely, (1) the condition as to residence in Great Britain which must ordinarily be complied with before a person can become insured under the National Insurance Act, 1946 (regulation 2); (2) payment of contributions in present of contributions. ment of contributions in respect of persons abroad
