PRESENT.

The KING's Most Excellent Majesty in Council.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 21st day of April, 1948 (N.2/N.L.2588/48) in the words following, viz.:

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted inter alia that all pay, pensions or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an officer, seaman or marine therein shall be paid in such manner and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council:
"And whereas the system for the execution of sentences of detention in military detention barracks provides that men under sentence who are considered capable of rehabilitation as soldiers serve their sen-

capable of rehabilitation as soldiers serve their sentences in a series of progressive stages in a Military Detention Barrack known as a Military Corrective Establishment; and that soldiers under sentence in Stage 3 of a Type B Military Corrective Establishment may be issued a special rate of pay:

'And whereas Naval ratings and Royal Marines

other ranks are from time to time sentenced to undergo periods of detention in such Military Corrective Establishments and we consider it desirable that they should be issued with the aforesaid special pay at the rates and under the same conditions as soldiers:

"We beg leave to recommend that Your Majesty may be pleased by Your Order in Council to authorise the issue to a Naval Rating or Royal Marine who may be serving sentence in Stage 2 of a Type B Military.

be serving sentence in Stage 3 of a Type B Military Corrective Establishment of such special rate of pay as may for the time being be authorised by the Royal Warrant for pay for soldiers undergoing sentence in Stage 3 of such Establishment, in part remission of the stoppage of pay applied during periods of

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is

The KING's Most Excellent Majesty in Council. WHEREAS the Church Commissioners, have duly prepared and laid before His Majesty in Council a

Scheme bearing date the 20th day of April, 1948, in the words and figures following, that is to say:—

"Whereas we are satisfied that the right of patronage of and presentation to the said benefice is at present exercisable alternately by Alice Anne Nevile of 'The Towers,' 185, Carholme Road, Lincoln, Widow; William Thomas Frow of 40, Saint John Street, Mansfield, Nottinghamshire, Gentleman; and Thomas Ernest Inman of Field House, Wickenby, Lincoln, Farmer; and by the Right Reverend Maurice, Bishop of Lincoln, in the right of his See:

"And whereas the said Alice Anne Nevile, William Thomas Frow and Thomas Ernest Inman desire to transfer the alternate right of patronage exercisable by them as aforesaid to the Bishop of Lincoln for the time being and are consenting to this Scheme (in testimony whereof they have executed the same):

"Now, therefore, with the consent of the said Maurice, Bishop of Lincoln (in testimony whereof he has executed this Scheme), we, the said Church Commissioners, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty. in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order, the share exercisable by the said Alice Anne Nevile, William Thomas Frow and Thomas Ernest Inman of and in the advowsor or perpetual right of patronage of and presentation to the said benefice shall be transferred to the said Maurice, Bishop of Lincoln, and his successors in the same Bishopric and shall thereupon and thencethe same bisnopric and snail thereupon and thence-forth become and be absolutely vested in and shall and may from time to time be exercised by the Bishop of Lincoln for the time being."

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately upon the publication of this Order in the London Gazette pursuant to the said Acts.
