CESSER OF POWERS.

THE CORSHAM TRAMWAYS (CESSER OF POWERS) ORDER, 1948.

Made 12th June, 1948.

WHEREAS by the Corsham Tramways Order, 1876, (hereinafter referred to as "the Order of 1876") confirmed by the Tramways Orders Confirmation (Bristol etc.) Act, 1876, powers were granted for the construction of certain tramways in the County of Wilts and of those tramways the tramways described in the Schedule to this Order (hereinafter referred to as "the abandoned tramways") were constructed: were constructed;

And whereas the provisions of the Tramways Act, 1870, are incorporated with the Order of 1876 and in Part III of that Act it is enacted by section 41 (inter alia) as follows:—

"If at any time after the opening of any tram-

way in any district for traffic the promoters dis-continue the working of such tramway, or of any part thereof, for the space of three calendar months part thereof, for the space of three calendar months (such discontinuance not being occasioned by circumstances beyond the control of such promoters, for which purpose the want of sufficient funds shall not be considered a circumstance beyond their control), and such discontinuance is proved to the satisfaction of the Board of Trade, the said Board if they think fit, may by order declare that the powers of the promoters in respect of such tramway or the part thereof so discontinued shall, from the date of such order, be at an end, and thereupon the said powers of the promoters shall cease and determine, unless the promoters shall cease and determine, unless the same are purchased by the local authority in manner by this Act provided ";

And whereas by virtue of the Ministry of Transport Act, 1919, and the Ministry of Transport (Board of Trade Exception of Powers) Order, 1919 (S.R. & O. 1919 No. 1440), the powers and duties of the Board of Trade under the said section 41 have been transferred to the Minister of Transport (hereinafter referred to as "the Minister");

And whereas the powers of the promoters under the Order of 1876 and otherwise in respect of the abandoned tramways are now vested in the Trustees of the Neston Estate (hereinafter referred to as "the Trustees '');

And whereas the Trustees have applied to the Minister for an order under the said section 47 declaring that the powers of the Trustees in respect of the abandoned tramways shall be at an end and it has been proved to the satisfaction of the Minister has been proved to the satisfaction of the Minister that the working of the abandoned tramways has been discontinued for the space of three calendar

Now therefore the Minister in exercise of his powers under section 4r of the Tramways Act, 1870,

and of all other powers him enabling hereby makes the following Order:—

1. The powers of the Trustees in respect of the abandoned tramways shall from the date of this

Order be at an end.

2. The Interpretation Act, 1889, shall apply to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.

3. This Order may be cited as "The Corsham Tramways (Cesser of Powers) Order, 1948".
