TRUNK ROADS ACT, 1946.

The Minister of Transport hereby gives notice that he proposes to make an Order under section 4 of the Trunk Roads Act, 1946, the effect of which will be.

(a) to provide for the construction by the Minister of a new road from a point on the road leading to Riding Mill at Corbridge in the County of Northumberland approximately 150 yards from its junction with the Carlisle—Sunderland Trunk Road in a north-westerly direction to points on the said Trunk Road approximately 60 yards and 105 yards respectively south-west of the said junction,

(b) to provide for the stopping up entirely of the existing junction between the said Trunk Road and the road leading to Riding Mill aforesaid when the new road has been completed;

(c) that section 4 of the Trunk Roads Act, 1936 (which modifies the Restriction of Ribbon Development Act, 1935, in its application to trunk roads), will apply to the new road on the date when the Order comes into operation;

(d) that the Northumberland County Council will become the highway authority for the new road on the 1st day of April next after the date on which notice is given by the Minister to the Council that the new road is opened for through traffic

Copies of the draft Order and the plan showing the line of the new road may be inspected by any person free of charge at all reasonable hours during a period of three months from 9th July, 1948, at the offices of the Ministry of Transport, Berkeley Square House, London, W 1, or at the offices of the Northumberland County Council, County Hall, Newcastle-upon-Tyne, or at the County Council Divisional Surveyor's Office, Beaumont Street, Hexham, or at the offices of the Divisional Road Engineer, 21, Park Square South, Leeds 1.
