The following Address was presented to The KING on the occasion of the opening of the Power Station at Kingston-upon-Thames on Wednesday, 27th October:

To the King's Most Excellent Majesty.

May it Please Your Majesty.

The Mayor, Aldermen and Burgesses of the Royal Borough of Kingston-upon-Thames, with feelings of great loyalty and devotion to Your Majesty, and to Her Majesty The Queen, tender a most warm and heartfelt welcome to the Royal Borough on this the occasion of Your Majesties' visit to open the new Power Station, and also to visit the Guildhall, the centre of our Civic Administration.

Kingston was one of the earliest Authorities to make provision for the supply of electricity for its inhabitants. Construction of their original Power Station was begun in 1891. After many years of successful operation, the Corporation accepted with

Station was begun in 1891. After many years of successful operation, the Corporation accepted with gratification the suggestion from the Central Electricity Board in 1939, that the Council should construct a new and modern Power Station. Work on this new Station commenced in January, 1945. The Royal Borough is proud to have taken its part in meeting the vital national needs for more generating attained.

Kingston is the business, shopping and entertainment centre of many of your peoples, residing in a very large area and the inhabitants take great pride in its many important industries and commerce. Particularly are they proud of the part which the workpeople of this Royal Borough have taken since 1912 in the production of aircraft—especially the 1912, in the production of aircraft—especially the Hurricane Fighter, which, with the gallant pilots and splendid ground personnel of Your Majesty's Royal Air Force, played such a vital and important part in the Battle of Britain.

The Royal Borough of Kingston-upon-Thames claims a unique link with the Royal Household in that a thousand years ago the Saxon Kings of England were crowned here. Athelstan—crowned in Kingston in 924, was the first King of all England. The Coronation Stone which certain Saxon Kings are said to have used during the ceremony of Coronation, is set up adjoining the Guildhall. The Stone, together with the Royal Charters granted to Kingston-upon-Thames and kept at the Guildhall, is amongst our most prized possessions.

These historic associations with the Throne have been strengthened by the confirmation to the Borough, of the designation as a Royal Borough, by Your Majesty's illustrious father, His Late Majesty King George V.

We are grateful for Your Majesties' visit to-day, and rejoice to have the opportunity of expressing in this personal manner the deep loyalty of the citizens of this Royal Borough, and the love and affection which they bear to Your Majesties.

The Queen and I thank you Mr. Mayor for the warm and affectionate welcome with which you and the people of the Royal Borough of Kingston-upon-Thames have received us to-day. Soon after our marriage we lived at White Lodge as your near neighbours, and we are glad to be here again in your borough, which we know so well, and whose history, symbolized by the Coronation Stone, links it with the earliest days of the Monarchy in England.
