- SUPPLEMENTARY RECONSTRUCTION REGULATIONS FOR FILLING VACANCIES FOR VETERINARY INSPECTORS, RESEARCH OFFICERS, AND ASSISTANT VETERINARY INVESTIGATION OFFICERS UNDER THE MINISTRY OF AGRICULTURE AND FISHERIES.
- 1. Both men and women may compete under these Regulations.
