The Foot-and-Mouth Disease (Infected Areas) Special Order No. 19, 1948.

I. Contracts, as from 5th January, 1949, the Foot-and-Mouth Disease Infected Area around Walberton, West Sussex, declared by Special Order No. 18, 1948, to an area comprising the districts situate within approximately 5 miles of Walberton, West Sussex.
