During an evening raid by enemy aircraft on Malta, in 1940, several motor launches were observed to be in difficulties, and personnel were seen to be swimming for the shore about a quarter of a mile out. Lance Corporal Read and Privates Munday and Bagge immediately entered the water and swam out, each bringing back a survivor. Privates Bagge and Munday swam out again each bringing in another survivor, and were followed by Lance Corporal Read who had observed that Private Bagge was in difficulties. Together they brought back a third survivor; Private Munday was by this time practically exhausted. By reason of this prompt and gallant action, five persons were saved.
