## MINISTRY OF TRANSPORT.

## TRUNK ROADS ACT, 1946.

The Minister of Transport hereby gives notice that he proposes to make an Order under Section 4 of the Trunk Roads Act, 1946, the effect of which will be:—

(a) to re-align the carriageway of the road leading to Terrington Station from a point approximately 35 yards from its junction with the King's Lynn-Sleaford-Newark Trunk Road at Terrington St. Clement in the County of Norfolk to the said junction;

(b) to provide for the construction by the Minister of a new road from a point on Churchgate Way at Terrington St. Clement aforesaid approximately 115 yards from its junction with the said Trunk Road in a southerly direction for a distance of approximately 105 yards to a point on the said Trunk Road approximately 30 yards east of the said junction.

(c) to provide for the stopping up entirely of the existing junction between the said Trunk Road and Churchgate Way aforesaid when the new road has been completed;

(d) that on the date on which notice is given by the Minister to the Norfolk County Council that the improvements in relation to the road leading to Terrington Station are completed the land acquired by the Minister for the purpose of the improvements will vest in the Council as highway authority for the road leading to Terrington Station aforesaid;

(e) that on the first day of April next after the date on which notice is given by the Minister to the Council that the new road is opened for the purposes of through traffic the Council will become the highway authority for the new road.

Copies of the draft Order and the plan showing the site of the improvements and the line of the new road may be inspected by any person free of charge at all reasonable hours during a period from 1st February, 1949, to 7th May, 1949, at the offices of the Ministry of Transport, Berkeley Square House, London, W.1, or at the offices of the Norfolk County Council, Thorpe Road, Norwich, or at the County Council Divisional Surveyor's Office, St. James' House, King's Lynn, or at the offices of the Divisional Road Engineer, Palace Chambers, Silver Street, Bedford.

Any person may within a period of three months from 8th February, 1949, object to the making of the Order by notice to the Minister addressed to Berkeley Square House, London, W.1.

## STAMP DUTIES.
