EXTINGUISHMENT OF PUBLIC RIGHTS OF WAY.

City of Plymouth.

Notice is hereby given that the Minister of Town and Country Planning, in exercise of the powers conferred upon him by Section 23 of the Town and Country Planning Act, 1944, as amended by the Town and Country Planning Act, 1947, has prepared in draft and proposes to make an Order extinguishing the public rights of way over the following highways:—

Union Street (part), Athenaeum Lane (part), and the lane running eastwards from Athenaeum Lane on the northern side of numbers 36 to 41 inclusive George Street.

A copy of the draft, Order and of a map showing the lands over which the rights of way are proposed to be extinguished may be inspected at the Town Clerk's Office, Pounds House, Plymouth, without payment of fee, during the usual office hours.

Any objection to this proposal must be made in writing, and addressed to the Minister of Town and Country Planning, 32, St. James's Square, London, S.W.1, before the 27th day of May, 1949.

The Minister is not, in all cases, required to cause a local inquiry to be held. It is important, therefore, that an objection should include a full statement in writing of the grounds on which the objection is made, as the objector may have no further opportunity to make such a statement.
