ROAD HAULAGE WAGES COUNCIL.

The Road Wages Council hereby gives notice of its intention to submit to the Minister of Labour and National Service proposals for the fixing of statutory minimum remuneration in substitution for the statutory minimum remuneration fixed by the Road Haulage Wages Order, 1948 (Order R.H. (24)), as amended by the Road Haulage (No. 2) Wages Order, 1948 (Order R.H. (26)) and by the Road Haulage Wages Council Wages Regulation Order, 1949 (Order R.H. (28)).
