## COLONIAL STOCK ACTS 1877 TO 1948.

ADDITION TO LIST OF STOCKS UNDER SECTION 2 OF THE COLONIAL STOCK ACT, 1900 (63 & 64 Vic. CAP 62).

Pursuant to Section 2 of the Colonial Stock Act, 1900, the Lords Commissioners of H.M. Treasury hereby give notice that the provisions of the Act have been complied with in respect of the under-mentioned Stock registered in the United Kingdom—New Zealand Government 3% Stock, 1973-1977.

The restrictions mentioned in Section 2, Subsection (1) of the Trustee Act, 1925, apply to the above Stock (see Colonial Stock Act, 1900, Section 2).
