#### TENDERS FOR TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Thursday, the 14th April, 1949, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939, to the amount of £170,000,000.

amount of £170,000,000. 2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Tuesday, the 19th April, 1949, to Saturday, the 23rd April, 1949, inclusive, and will be payable at three months after date. 3. The Bills will be issued and paid at the Bank

3. The Bills will be issued and paid at the Bank of England. 4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates. 5 Tenders must be made through a London

#### Whitehall, April 6, 1949.

Under authority of a Royal Warrant, the Governor-General of New Zealand at Government House, Wellington, on the 3rd March, 1949, con-ferred the honour of Knighthood upon the Honour-able David Stanley Smith, Judge of the Supreme Court and Chancellor of the New Zealand University.
