#### CERTIFICATE OF THE BOARD OF TRADE.

(4) that the said Commission do not desire to give any further such directions.

Now therefore the Board of Trade pursuant to section 24 (1) of the Transport Act, 1947, hereby certify that there is no reason for the continued existence of each or any of the said bodies.
