

## WAGES COUNCILS ACTS, 1945 TO 1948.

## SUGAR CONFECTIONERY AND FOOD PRESERVING WAGES COUNCIL (GREAT BRITAIN).

The Sugar Confectionery and Food Preserving Wages Council (Great Britain) hereby gives notice of its intention to submit to the Minister of Labour and National Service proposals (1) for the fixing of statutory minimum remuneration in substitution for the statutory minimum remuneration fixed by the Sugar Confectionery and Food Preserving Wages Council (Great Britain) Wages Regulation Order, 1948 (Order F. (45)), and (2) for the revocation of the Sugar Confectionery and Food Preserving Wages Council (Great Britain) Wages Regulation (Holidays) Order, 1948 (Order F. (47)) and for the making of a Wages Regulation Order to give effect to proposals for holidays and holiday remuneration in substitution of the provisions at present in operation.

Particulars of the proposals may be obtained on application to the Secretary of the Wages Council at the address given below.

The Wages Council will consider any written representations with respect to the above mentioned proposals which may be sent to it within fourteen days from 21st June, 1949. Any such representation should be signed by the person making the same (adding his or her address) and sent to the Secretary, Sugar Confectionery and Food Preserving Wages Council (Great Britain), Queen Anne's Chambers, 28, Broadway, London, S.W.1. It is desirable that persons making objections should state the precise grounds of their objections.

## MINISTRY OF FOOD

## PUBLIC HEALTH (IMPORTED FOOD) REGULATIONS, 1937 and 1948

The Minister of Food gives notice, in pursuance of the above-named Regulations, that he hereby recognises the Official Certificate, of which particulars are given in the Schedule hereto, as showing (a) that the meat from which the meat product to which it relates was prepared, was derived from animals inspected ante and post-mortem and passed in accordance with criteria satisfactory to the Minister; and (b) that all necessary precautions for the prevention of danger to public health were taken in the dressing or preparing and packing of the meat product.

The certificate being in the form of a stamp, the recognition will apply only if the stamp is clearly impressed on the package containing the meat product and if the stamp has not in any other circumstances or on any other occasion been used as an Official Certificate.

## RIVER BOARDS ACT, 1948.

*Isle of Wight River Board Area.*

Notice is hereby given that the Minister of Agriculture and Fisheries and the Minister of Health, in exercise of the powers conferred upon them under Section 1 (1) (a) of the River Boards Act, 1948, intend to make an Order defining the area of the administrative County of the Isle of Wight as a river board area to be known as the Isle of Wight River Board Area.
