At the Court at *Buckingham Palace*, the 30th day of June, 1949.

PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 24th day of June, 1949 (C.W. 2828/49), in the words following, viz.:—

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, *inter alia*, that all pay, pensions or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman or Marine therein, shall be paid in such manner and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council:

"And whereas by Order in Council dated the 26th June, 1946, new rates of pay were sanctioned for Petty Officers and Seamen of Your Majesty's Navy and for Non-Commissioned Officers and Men of the Royal Marines:

"And whereas under Section I (B) of the Schedule of the afore-mentioned Order in Council pay for a Marine 2nd Class (recruit) was sanctioned at the rate of 4s. 0d. a day:

"And whereas we are of opinion that Marines 2nd Class (recruits) selected for training with an Army Officer Cadet Training Unit should receive pay at the rate of 5s. 0d. a day while training with the Unit:

"We beg leave humbly to recommend that Your Majesty by Your Order in Council may be graciously pleased to sanction the rate of 5s. 0d. a day to Marines 2nd Class (recruits) while under training with an Army Officer Cadet Training Unit, with effect from 18th May, 1949.

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

RECRUITMENT FROM CANDIDATES WITH REGULAR SERVICE IN H.M. FORCES TO THE CLERICAL CLASSES (GENERAL AND DEPARTMENTAL) OF THE HOME CIVIL SERVICE.

1. *Age.* Except as provided in Regulation 5, candidates must be under 50 years of age on the 1st November, 1949.

2. *Sex.* Both men and women are eligible.

3. *Nationality.* Candidates must be British subjects. They must also satisfy one of the following conditions:—

(a) If natural-born British subjects, they must either

(i) have at least one parent who is or was at death a British subject; or

(ii) have resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.

(b) If naturalised British subjects, they must have resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.

(c) If not qualified under (a) or (b) of this paragraph they must satisfy the Commissioners that they are so closely connected with His Majesty's dominions either by ancestry, upbringing, or residence, or by reason of national service,

that an exception may properly be made in their favour.

4. *Service.*

(i) All candidates must be serving or have served on a regular engagement (including a regular short service engagement) in the Royal Navy, Army, or Royal Air Force, or the corresponding women's Services (W.R.N.S., W.R.A.C., and W.R.A.F.).

(ii) A candidate who is still serving must on the 1st November, 1949, be in the last year of an engagement involving, in the case of men, at least five years' whole-time service, including any previous service under the National Service Acts, or, in the case of women, at least four years' whole-time service, including any service otherwise than on a regular engagement.

(iii) A candidate who is not still serving must on the 1st November, 1949, either (a) have rendered, in the case of men, at least five years' whole-time service including any previous service under the National Service Acts, or, in the case of women, at least four years' whole-time service, including any service otherwise than on a regular engagement, or (b) have entered upon a regular engagement for a period of, in the case of men, at least five years, or in the case of women, at least four years, and have been invalided out before completing that term.

(iv) Except as provided in Regulation 5, no candidate will be eligible whose whole-time service ceased more than two years before the 1st November, 1949.

5. In 1949 only, certain candidates born on or after 2nd November, 1898, will be admitted exceptionally to the competition. These candidates must have completed a regular engagement (including a regular short service engagement) in the Royal Navy, Army, or Royal Air Force before 1st November, 1946, and must either (a) have rendered at least five years' service, including any service under the National Service Acts, or (b) have entered upon a regular engagement involving at least five years' whole-time service and have been invalided out before completing that term.

6. *Health and Character.* Successful candidates must satisfy the Civil Service Commissioners as to their health and character.

7. *Examination.* The candidates will undergo a written examination consisting of papers in English and Arithmetic, a General Paper, and a test of General Intelligence.

RECRUITMENT FROM CANDIDATES WITH REGULAR SERVICE IN H.M. FORCES TO GRADE 6 POSTS IN BRANCH B OF THE FOREIGN SERVICE.

1. *Age.* Except as provided in Regulation 5, candidates must be under 50 years of age on the 1st November, 1949.

2. *Sex.* Both men and women are eligible.

3. *Nationality.* (1) Every candidate must
(a) be a natural-born British subject; and
(b) have been born within the United Kingdom or within one of the self-governing Dominions of parents both of whom were also born within the United Kingdom or within one of the self-governing Dominions.

(2) No departure from this rule will be made without the special permission of the Secretary of State for Foreign Affairs, and then only in exceptional cases and in favour of candidates who are British subjects and who also satisfy one of the following conditions:—

(a) If natural-born British subjects, they must either

(i) have at least one parent who is or was at death a British subject; or

(ii) have resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.

(b) If naturalised British subjects, they must have resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.

TEMPORARY (RECONSTRUCTION) REGULATIONS FOR THE COMPETITIVE SELECTION OF DRAUGHTSMEN IN THE SCIENCE MUSEUM UNDER THE MINISTRY OF EDUCATION.

Qualifications.

1. The competition will be open to men and women.

2. Candidates must have attained the age of 21 and must not have attained the age of 35 on the 1st January, 1949.

3. Candidates must be British subjects. They must also satisfy one of the following conditions:—

(a) If natural born British subjects, they must either

(i) have at least one parent who is or was at death a British subject; or

(ii) have resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.

(b) If naturalised British subjects, they must have resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.

(c) If not qualified under (a) or (b) of this paragraph, they must satisfy the Civil Service Commissioners that they are so closely connected with His Majesty's dominions either by ancestry, upbringing or residence, or by reason of national service, that an exception may properly be made in their favour.

4. (a) Persons upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appropriate central education authority (e.g. the Ministry of Education, the Scottish Education Department, the Ministry of Education for Northern Ireland) has been notified to the Civil Service Commissioners.

(b) No person who is undergoing a course of study with the aid of a grant from public funds shall be eligible to compete under these Regulations before the completion of the course, unless he or she has previously obtained permission to do so from the authority which administers the grant.

The Selection Board will recommend for the vacancies existing those candidates who appear to them to possess the highest qualifications, having regard to the requirements of paragraph 5 of the Regulations and to the number and ability of the competitors. The decision will be final.
