PUBLIC INQUIRY. On 18th March, 1949, the Minister of Labour and National Service published draft Regulations, entitled the Blasting (Castings and other Articles) Special Regulations, 1949, and gave notice, in accord-ance with Section 129 of the Factories Act, 1937, and the Second Schedule to that Act, of his intention to make Special Regulations as in that draft.
