Treasury, the following amendment has been made to the Temporary (Reconstruction) Regulations for the Competitive Selection of Radio Operator, Class I (Male), formerly styled Wireless Telegraphist, in the Post Office Wireless Service, dated the 26th November, 1946, and published in the London Gazette of the same date, viz.:—

Regulation 6. To read "Candidates must possess the Postmaster-General's First Class Certificate of Proficiency in Radiotelegraphy and have had practical experience as a Wireless Operator in the Post Office or elsewhere."

The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of H.M. Treasury and the Secretary of State for Foreign Affairs, viz.:—

RECRUITMENT UNDER NORMAL REGULATIONS TO THE GOVERNMENT COMMUNICATIONS HEADQUARTERS. (DEPARTMENT OF THE FOREIGN OFFICE.)

1. No candidate may compete more than twice under Normal Regulations.

2. *Age.* Candidates must be at least 20½ years and under 26 years of age on the 1st day of August, 1950. But the Commissioners may at their discretion admit a candidate who was born on or after 2nd August, 1923, if he rendered civilian service otherwise than under the National Service Acts and so was debarred from competing in 1949 by the terms of the proviso to paragraph 1 of the Regulations governing the Normal Open Competition of 1949 for recruitment to the Government Communications Headquarters, but in other respects complies with the requirements of these Regulations.

3. *Marriage.* (i) Both men and women are eligible.

(ii) Married women who have formerly been established civil servants and have drawn marriage gratuity (other than those who are widows or divorced, or who are separated from their husbands, or whose husbands suffer without hope of recovery from total physical or mental incapacity) will not be eligible unless they undertake to refund on appointment the marriage gratuity paid.

4. *Nationality.* (1) Every candidate must

(a) be a natural-born British subject; and

(b) have been born within the United Kingdom or within one of the self-governing Dominions of parents both of whom were also born within the United Kingdom or within one of the self-governing Dominions.

(2) No departure from this rule will be made without the special permission of the Secretary of State for Foreign Affairs, and then only in exceptional cases and in favour of candidates who are British subjects and who also satisfy one of the following conditions:—

(a) If natural-born British subjects, they must either

(i) have at least one parent who is, or was at death, a British subject; or

(ii) have resided in His Majesty's dominions and/or been employed elsewhere in the service
