(a) As from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council confirming this Scheme, the area defined in the subjoined Schedule and delineated on the map hereto annexed shall be a new parist.

(b) The Church of Saint John the Evangelist aforesaid shall be the parish church of the parish.

(c) The name of the parish shall be 'The Parish of Saint John the Evangelist, Dudley Wood.'

prepared and humbly lay before Your Majesty in Council the following Scheme for constituting a new parish to be taken out of the parishes of Saint John, Newland, and Cottingham in the diocese of York.

## "SCHEME

"Whereas we, the Church Commissioners, are satisfied that the spiritual interests of the area defined in the subjoined Schedule and delineated on the map hereto annexed would be best served by constituting it a new parish:

"And whereas we are satisfied that a suitable

endowment therefor will be provided:

'And whereas we have not approved any consecrated church within the area as suitable to be the

parish church of the new parish:

"Now, therefore, with the consent of the Right
Honourable and Most Reverend Cyril, Archbishop
of York (in testimony whereof he has set his hand
and affixed his archiepiscopal seal to this Scheme)
we, the said Church Commissioners, do humbly recommend and propose as follows, that is to say:

"1. Constitution:

(a) As from the licence thereto of a Minister the area defined in the subjoined Schedule and delineated on the map hereto annexed shall be a separate district for spiritual purposes.

(b) As from the date of consecration of a church

within the area approved by us as suitable to be a parish church, or if the church is consecrated before such approval, the date of the approval, the said area shall become a new parish.

(c) The name of the district (or parish as the case may be) shall be 'The District (or Parish) of Saint Michael and All Angels, North Hull'.

"2. Archdeaconry and Rural Deanery:
The parish shall be in the Archdeaconry of East
Riding and in the rural deanery of Kingston-upon-Hull.

"The area comprising:

All those contiguous portions of the parishes of Saint John, Newland, and Cottingham (shown by the pink and blue colours respectively on the map) which taken together are bounded by an imaginary which taken together are bounded by an imaginary line commencing at the point in the middle of Moor Dike on the boundary which divides the said parish of Saint John, Newland, from the said parish of Cottingham opposite to the middle of the southern end of Panbottom Drain and continuing thence westwards along the middle of Moor Dike to a point opposite to its western end in the middle of Cottingham Drain and continuing thence southwards along the middle of Cottingham thence southwards along the middle of Cottingham Drain to the point at which Cottingham Drain turns to follow the northern side of Endike Lane and continuing thence in a straight line in the same southward direction to a point in the middle of Endike Lane and continuing thence eastwards along southward direction to a point in the middle of Endike Lane and continuing thence eastwards along the middle of Endike Lane, thereby following in part the boundary which divides the parish of Cottingham from the parish of Saint Alban, Hull, to a point in the middle of Beverley Road opposite to the middle of the eastern end of Endike Lane and continuing thence northwards along the middle of Beverley Road to a point in the middle of the bridge or culvert which carries Beverley Road over Moor Dike and continuing thence westwards along the middle of Moor Dike to the hereinbefore mentioned point on the boundary which divides the parish of Saint John, Newland, from the parish of Cottingham."
