"Now, therefore, with the consent of the Right Honourable and Most Reverend Cyril, Archbishop of York, (in testimony whereof he has set his hand and affixed his archiepiscopal seal to this Scheme), we, the said Church Commissioners, do humbly recommend and propose as follows, that is to say:—

Constitution:

(a) As from the licence thereto of a minister the area defined in the subjoined Schedule and delineated

area defined in the subjoined Schedule and delineated on the map hereto annexed shall be a separate district for spiritual purposes.

(b) As from the date of the consecration of a church within the area approved by us as suitable to be a parish church, or if the church is consecrated before such approval, the date of the approval, the said area shall become a new parish.

(c) The name of the district (or parish as the case may be) shall be 'The District (or Parish) of Saint Chad, Middlesbrough.'

"2. Archdeaconry and Rural Deanery:
The said district and parish shall be in the archdeaconry of Cleveland and in the rural deanery of Middlesbrough.

"THE SCHEDULE

"The area comprising:

All those contiguous pontions of the parishes of All those contiguous pontions of the parishes of Saint Oswald, Middlesbrough and West Acklam (shown by the pink and blue colours respectively on the map) which taken together are bounded upon the south-east by the parish of Marton in Cleveland and upon the remaining sides by an imaginary line commencing at a point on the boundary which divides the said parish of Saint Oswald, Middlesbrough from the said parish of West Acklam in the middle of Marton West Beck, 6 chains, or thereabouts, north-west of Newham West Acklam in the middle of Marton West Beck, 6 chains, or thereabouts, north-west of Newham Bridge at the junction of an unnamed brook or stream with Manton West Beck and continuing thence first north-westwards and then south-westwards along the middle of the said unnamed brook or stream for a distance of 9 chains or thereabouts to a point (south of Newham Bridge Farm) at which the said brook or stream meets the track or footpath leading to Newham Bridge Farm and continuing thence first northwards and then north-westwards along the middle of the said track or footpath (thereby passing the western side of Newham Bridge Farm) to the middle of Tollesby Road and continuing thence northwards along the middle of Tollesby Road to a point opposite to the middle of its northern end in the middle of Emerson Avenue and continuing thence middle of Emerson Avenue and continuing thence eastwards along the middle of Emerson Avenue to a point opposite to the middle of the southern end of The Avenue and continuing thence northwards along the middle of The Avenue to a point opposite to the middle of the western end of Eastbourne Road and continuing thence eastwards along the middle of Eastbourne Road to a point in the middle of the bridge or culvert which carries Eastbourne Road over Marton West Beck (thereby following in part the boundary which divides the said parish of West Acklam and the parish of Saint Barnabas Linthorpe from the said parish of Saint Oswald, Middlesbrough), and continuing middle of Emerson Avenue and continuing thence

thence south-eastwards to and then along the middle of Manton Burn Road to a point opposite to the middle of the north-western end of Ashfield Avenue and continuing thence south-eastwards along the middle of Ashfield Avenue to a point opposite to the middle of its south-eastern end in the middle of Deepdale Avenue and continuing thence first southwards and then south-eastwards along the middle of Deepdale Avenue to the southeastern end of Deepdale Avenue and continuing thence in the same straight line for a distance of 31 chains or thereabouts to the boundary which divides the said parish of Saint Oswald, Middlesbrough from the said parish of Marton in Cleveland."

And whereas the provisions of the New Parishes Measure, 1943, relating to the preparation and submission of this Scheme, have been duly complied with:

"1. The territory, shown by the green colour on the map, to be annexed to the parish of Saint Nicholas, Bishopwearmouth:—

All that portion of the parish of Saint Matthew, Silksworth, which is bounded upon the north by the said parish of Saint Nicholas, Bishopwearmouth, and upon the remaining sides by an imaginary line commencing at a point on the boundary which divides the said parish of Saint Nicholas, Bishopwearmouth, from the said parish of Saint Ma*thew, Silksworth, in the middle of Tunstall Road and continuing thence southwards along the middle of Tunstall Road to the point where Tunstall Road is crossed by the boundary of the County Borough of Sunderland and continuing thence generally westwards, along the said county borough boundary to the point in the middle of the railway line of the Hetton Colliery Railway where the said railway line is crossed by All that portion of the parish of Saint Matthew,
