*LONDON TRAFFIC ACT, 1924.*

*LONDON PASSENGER TRANSPORT ACT, 1933.*

#### MINISTRY OF TRANSPORT.

*TRUNK ROADS ACT, 1946.*

The Minister of Transport hereby gives notice that he proposes to make an Order under section 1 of the Trunk Roads Act, 1946, as amended by the Special Roads Act, 1949, the effect of which will be that a new road which he proposes to construct at Southampton from West End to North of Bassett will become a trunk road on the date when the Order comes into operation and that approximately 330 yards of the Folkestone—Brighton—Southampton—Dorchester—Honiton Trunk Road will cease to be a trunk road on the date on which notice is given by the Minister to the Southampton County Council (who will thereafter become the highway authority responsible for that road) that the new road is opened for through traffic.

Copies of the draft Order and the plan showing the line of the new road and the length of the Folkestone—Brighton—Southampton—Dorchester—Honiton Trunk Road to be superseded may be inspected by any person free of charge at all reasonable hours during a period from 26th April, 1950, to 25th July, 1950, at the Ministry of Transport, Berkeley Square House, London, W.1, or at the offices of the Southampton County Council, The Castle, Winchester, or at the offices of the Southampton County Borough Council, Municipal
