equal width, the central stripe being black and the other two white; and further, that in the case of those to whom the Medal is awarded for service during the Great War 1914-1918 a bar or clasp shall be attached to the riband, bearing the words "The Great War. 1914-1918."

VI. It is ordained that an additional bar or clasp which shall be attached to the riband and shall bear upon it the words "Long Service" may be awarded to those to whom the Medal has been awarded upon the same recommendation by the Chief Officer of Police as is required for the award of the Medal upon the completion of each ten years of service after the completion of qualifying service for the Medal, or, where such award was made under Rule III (1), after 19th July, 1919. Provided that each period of service without pay during the period beginning with the 3rd September, 1939 and ending with the 31st December, 1945 amounting to one year or upwards in the course of which the Special Constable completed not less than 50 police duties shall be reckoned as equivalent to three years service for the purpose of this Rule and other periods in the same proportion.

VII. It is ordained that on a recommendation to that effect by or through one of Our said Secretaries of State it shall be competent for Us, Our Heirs, and Successors to direct the cancellation and annulment of the award to any person of the Medal or Bars, and thereupon the name of such person shall be erased from the record of those to whom the Medal shall have been awarded, and every person whose Medal shall be so forfeited shall on being required so to do by either of Our said Secretaries of State deliver up his Medal to such person as either of Our said Secretaries of State may direct. Provided that it shall be competent for Us, Our Heirs and Successors to direct the restoration of any Medal or Bars which may have been so forfeited when such recommendation has been withdrawn

III. All previous Warrants issued in this behalf are hereby revoked except in so far as they are already revoked.
