The Lords Commissioners of His Majesty's Treasury hereby give notice that They have made an Order under Section 19 of the Import Duties Act, 1932, Section 10 of the Finance Act, 1934, and Section 1 of the Import Duties (Emergency Provisions) Act, 1939, viz.:-

The Import Duties (Exemptions) (No. 5) Order, 1950, which exempts from duty unwrought copper imported in the form of billets.

The Lords Commissioners of His Majesty's Treasury announce that They are considering making an Order under Section 21 of the Finance Act, 1948, to exempt from Purchase Tax those "labels, tags, gummed seals and other marking tickets" which are at present chargeable with tax.

Any representations which interested parties desire to make in regard to this matter should be addressed to The Commissioner of Customs and Excise, City Gate House, Finsbury Square, London, E.C.2, not later than the 19th August, 1950.

TENDERS FOR TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday, the 11th August, 1950, at 1 p.m., for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939, to the amount of £240,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday the 14th August, 1950, to Saturday, the 19th August, 1950, inclusive, and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent by post, on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part, and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday 12 noon) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.
