TRUNK ROADS ACT, 1946.

SPECIAL ROADS ACT, 1949.

The Minister of Transport hereby gives notice that he proposes to make an Order under section 14 of the Special Roads Akt, 1949, the effect of which will be:

(a) to provide for realigning the carriageway of Thackeray's Lane at Arnold in the County of Nottingham at its junction with the Widmerpool-Nottingham-Bawtry-Goole-Howden Trunk Road by substituting a standard type refuge for the existing triangular island;
