Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows:

1. No new burial ground shall be opened in the said Civil Parish of Lydd save with the previous approval of the Minister of Health, and burials shall be discontinued therein as follows, viz.:—

Lydd.—Forthwith and entirely in the extension to the Churchyard of the Parish Church in the said Parish of Lydd.
Provided that—

(a) In any vault or walled grave now existing in the said Churchyard Extension, burial may be allowed subject to the condition that every coffin buried in such vault or grave be separately enclosed by stonework or brickwork properly cemented.

(b) In any earthen grave now existing in the said Churchyard Extension, the burial may be allowed of the body of any member of the family of the person or persons heretofore buried in such grave, subject to the condition that no part of the coffin containing the body shall be at a depth less than three feet below the level of the surface of the ground adjoining the grave.

2. This Order may be cited as the Burial Grounds (Lydd) Order, 1950.

WHEREAS the Minister of Health, after giving 10 days' previous notice of his intention in that behalf, has, under the provisions of the Burial Act, 1853 (16 & 17 Vict. c. 134), as amended by subsequent enactments, made a Representation to His Majesty in Council that for the protection of the Public Health, the opening of any new burial ground in the Civil Parish of Pelsall, in the County of Stafford, save with the previous approval of the Minister of Health, should be prohibited, and that burials should be discontinued therein as hereinafter directed:
