WHEREAS by the Osborne Estate Act, 1914, 4 & 5 Geo. 5. c. 36, it is enacted that His Majesty may, by Order in Council, add to the persons for whose benefit the part of Osborne House mentioned in paragraph (b) of subsection (4) of section one of the Osborne Estate Act, 1902, 2 Edw. 7. c. 37, is to be used, such other classes of persons as, subject to such conditions and restrictions as may be imposed by the Order, He may determine to be qualified on account of their public services to participate in such benefit, and may from time to time by Order in Council revoke or vary any such Order: Order:

And Whereas His Majesty, in pursuance of the said Act, was pleased by Orders in Council dated the 28th November, 1923, 7th February, 1927, 5th October, 1934, 22nd October, 1937, 15th March, 1938, and 25th October, 1948 (in this Order together referred to as "the Principal Orders"), to order that the several classes of persons specified in the Principal Orders should, subject to the conditions and restrictions therein specified, be eligible to participate in such benefit:

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows:—

1.—(1) This Order may be cited as the Osborne Estate Order, 1951.

(2) The Interpretation Act, 1889, 52 & 53 Vict. c. 63, applies to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.

2.—(1) In addition to the persons mentioned in the Principal Orders as eligible to participate in the benefit aforesaid, the following persons (in so far as any of them are not so eligible by virtue of the Osborne Estate Acts, 1902 and 1914, or the Principal Orders for the time being in force), that is to say, all established and permanent unestablished members of the Civil Service of Great Britain, the Civil Service of Northern Ireland and His Majesty's Foreign Service, shall be eligible to participate in the benefit aforesaid subject to the conditions and restrictions specified in the said Order in Council dated the 28th November, 1923.

(2) For the purposes of this Order references in the Principal Orders to the First Commissioner of His Majesty's Works and Public Buildings shall be read as references to the Minister of Works.

3.—(1) The said Order in Council dated the 15th March, 1938, (being one of the Principal Orders) is hereby revoked.

(2) The said Order in Council dated the 25th October, 1948, shall be varied by the deletion of paragraph (e) of Article 1 thereof.
